KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of ONE HUNDRED SEVENTEEN THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$117,900.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantors, JOHN WEBB HUNTER and LAUREN HUNTER, husband and wife (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, ROBERT E. FREEMAN and TENINA M. FREEMAN (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot B, Block 1, according to the Survey of Riverwood, 1st Addition, as recorded in Map Book 8, page 49, in the Probate Office of Shelby County, Alabama.

Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, reservations, mineral/mining rights, and declarations of record, if any.

\$88,425.00 of the above-recited purchase price was paid with a purchase money mortgage being recorded simultaneously herewith.
