WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this July 24, 2014, That for and in consideration of **TWO HUNDRED FORTY THOUSAND AND NO/100 (\$240,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **WILLIAM E. DILL, a married man**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **AARON C. PEARSON and AMY PEARSON**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

The Eastern 65.82 feet of Lot 1, Wooley Subdivision, as recorded in Map Book 4, Page 15, Probate Office of Shelby County, Alabama, also, Lot 8 of Wooley Addition to Columbiana, as recorded in Map Book 3, Page 58, Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2014 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 3, Page 58.
7. Protective Covenants as shown on subdivision map in Map Book 4, Page 15.
8. 30-foot building setback line from Parker Street.

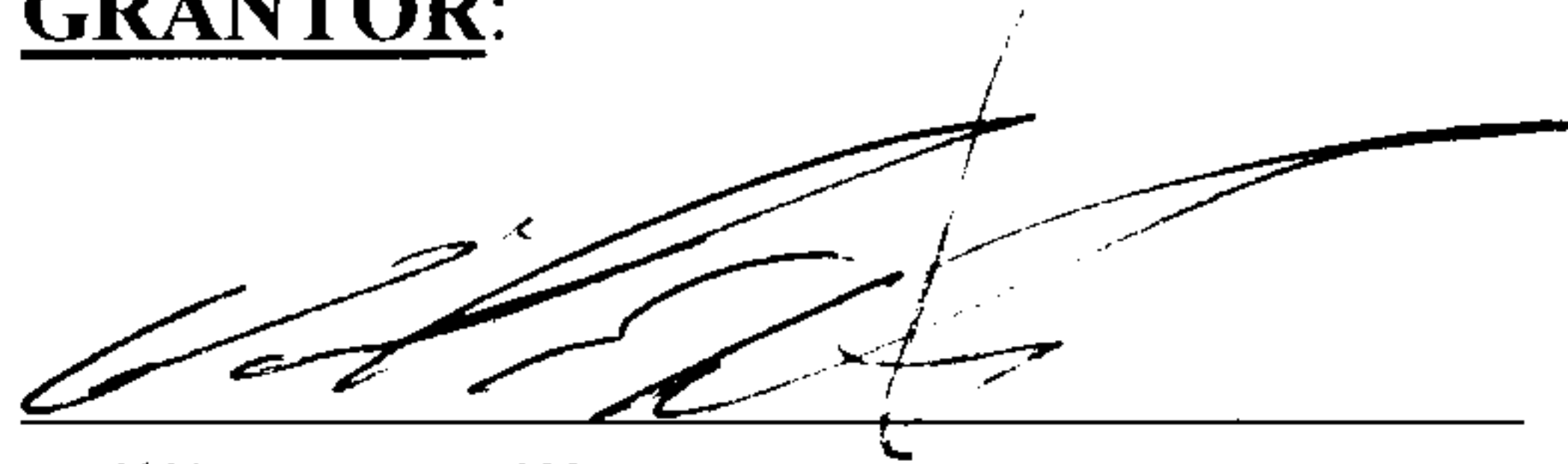

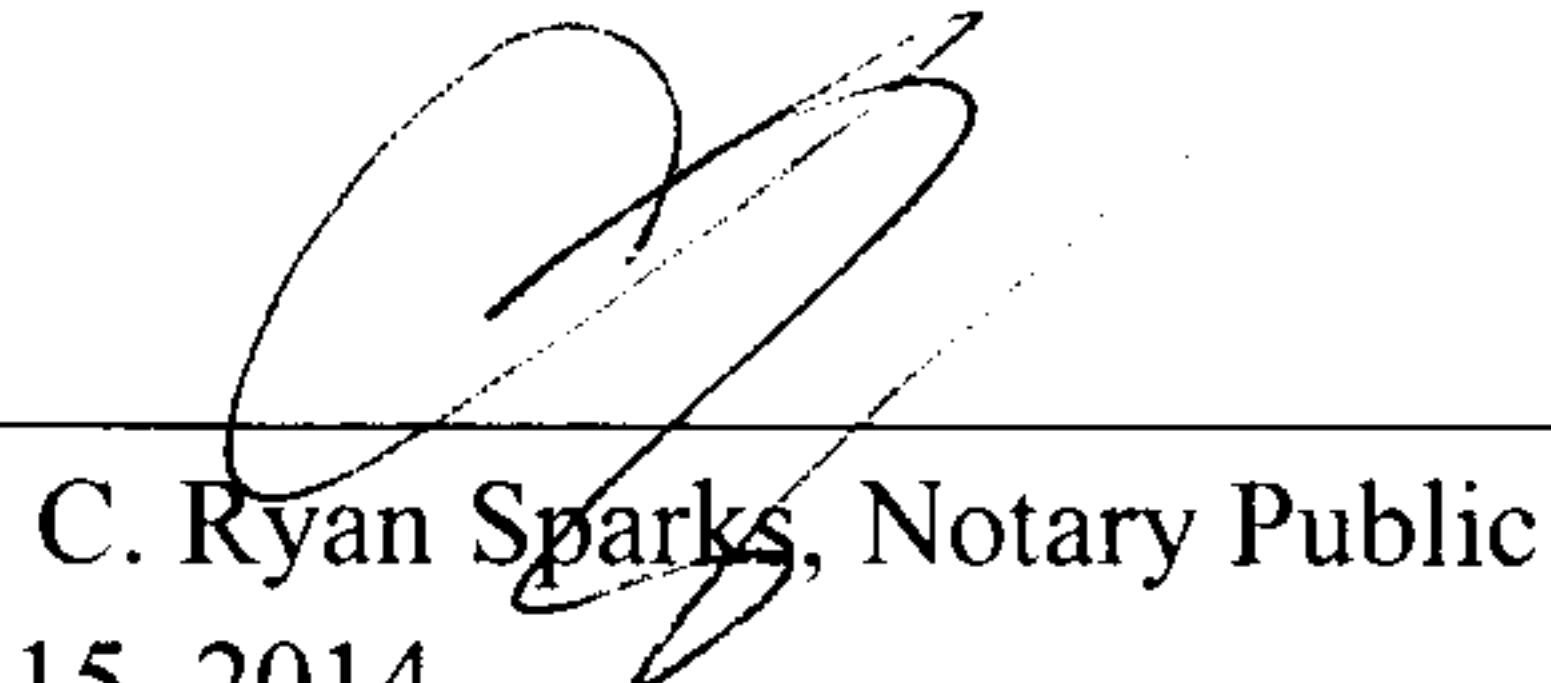
