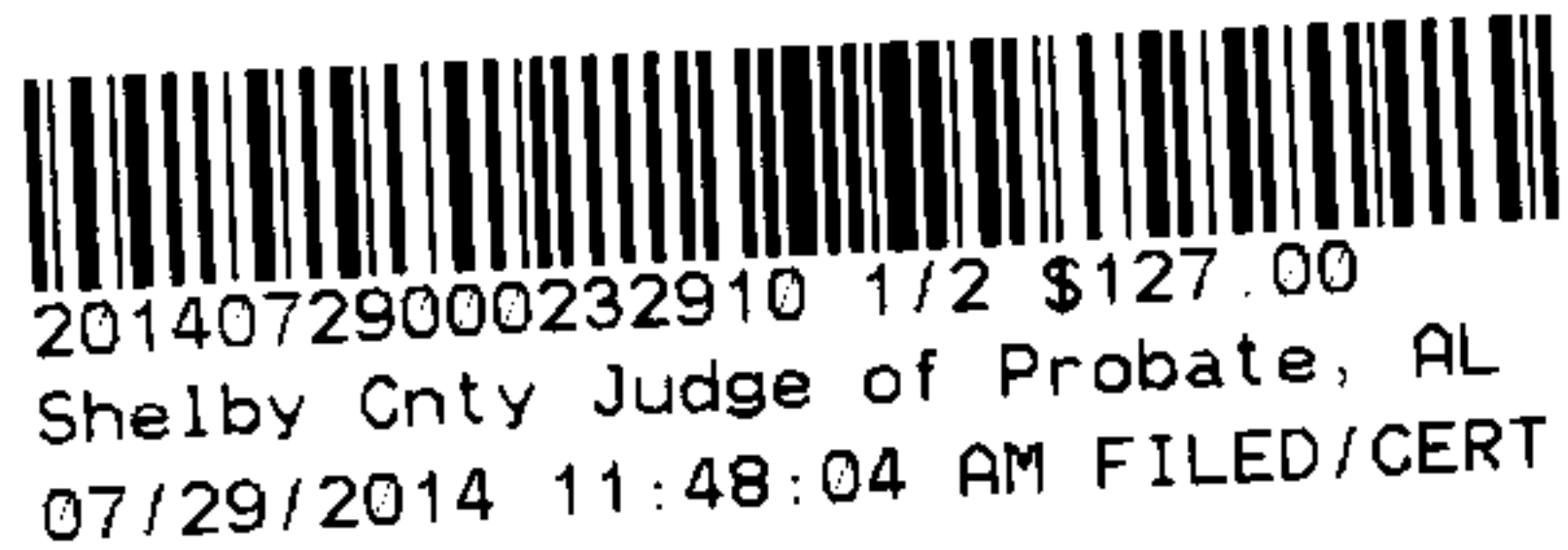

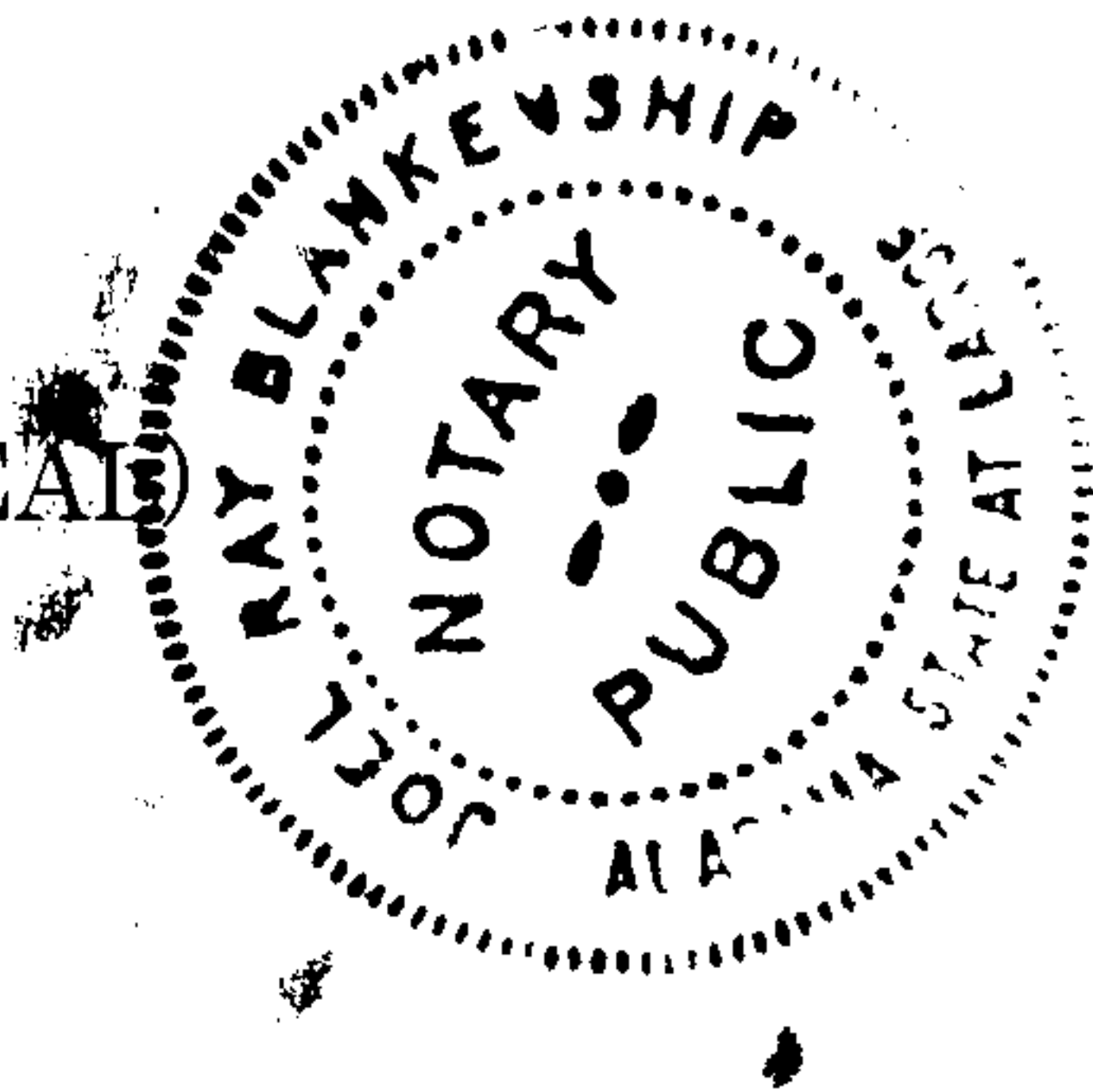
- 1) Subject to ad valorem taxes for the current tax year and all subsequent years.
