FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of November, 2005, Marvin L. Harrell, Jr. and Yolanda Danette Harrell, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for M&T Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20051115000596880, said mortgage having subsequently been transferred and assigned to M&T Bank, by instrument recorded in Instrument Number 20140218000044110, in the aforesaid Probate Office ("Transferee"); and

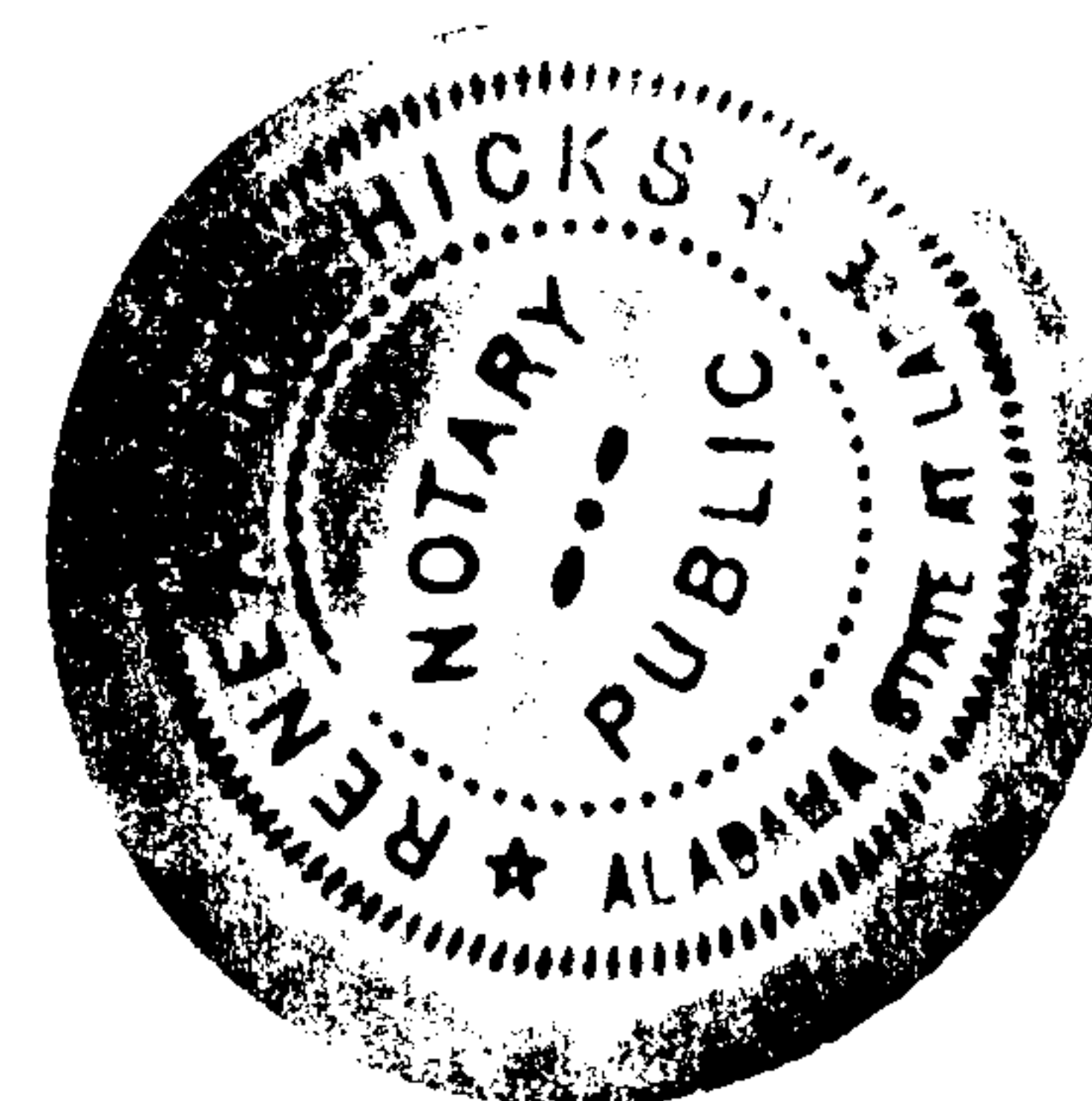
