KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of May, 2008, Chris L. Holcombe and Cassie L. Stagner, both unmarried individuals, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080512000193640; having been re-recorded in Instrument Number 20080616000244630, said mortgage having subsequently been transferred and assigned to MidFirst Bank, by instrument recorded in Instrument Number 20140501000129470, in the aforesaid Probate Office ("Transferee"); and

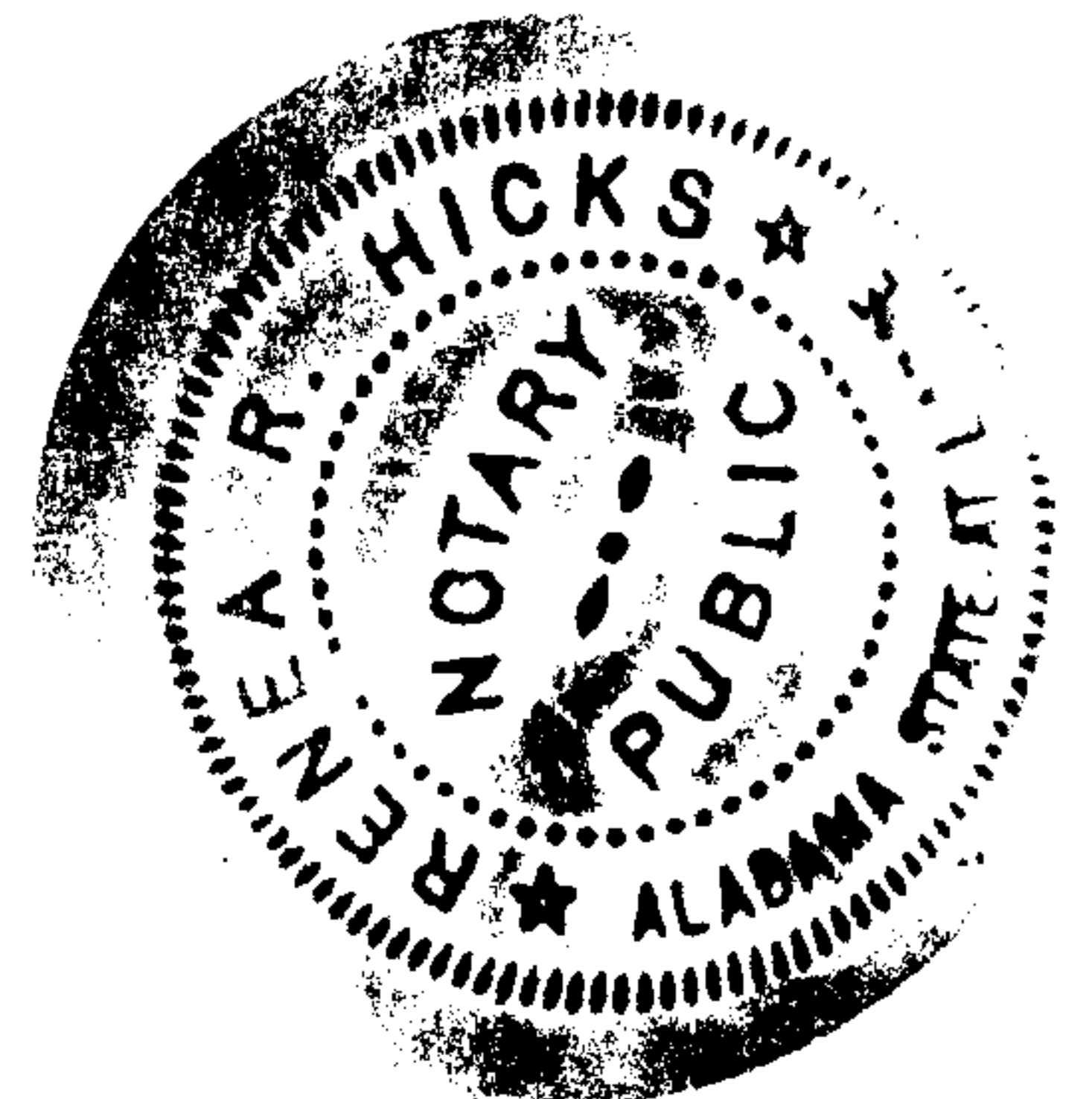
