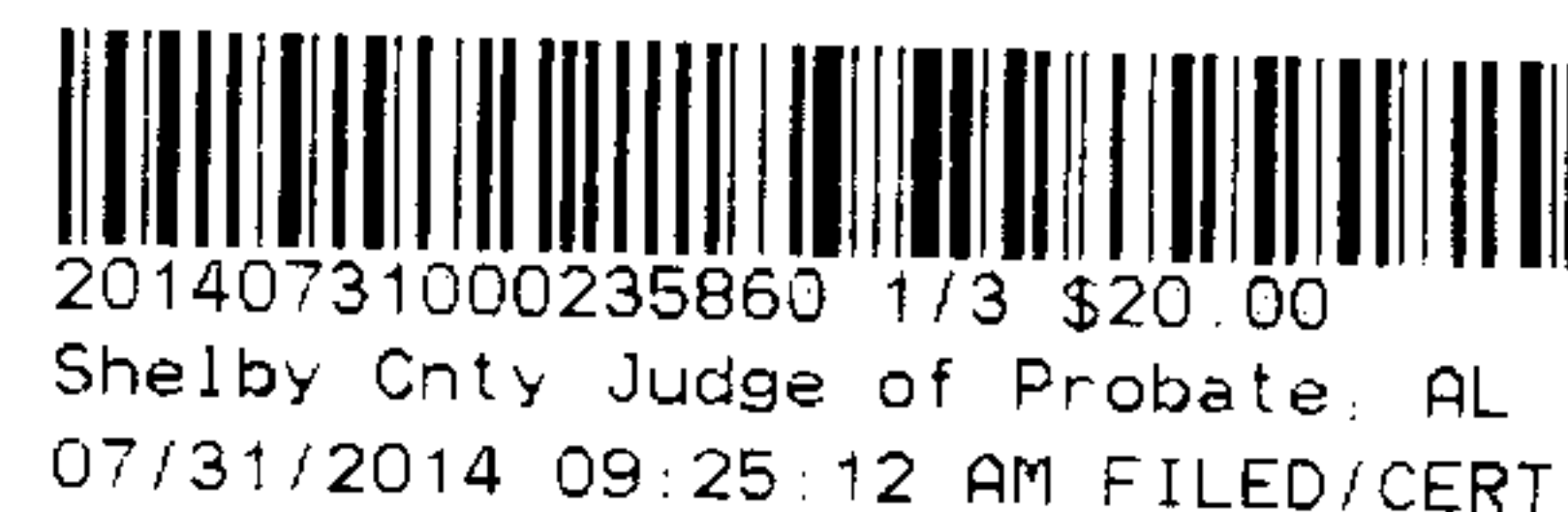


SUPPLEMENTAL DECLARATION
