WILLIAM BLACK and WILLIAM T. BLACK, III are one and the same person.


JUDITH BLACK and JUDITH J. BLACK are one and the same person.

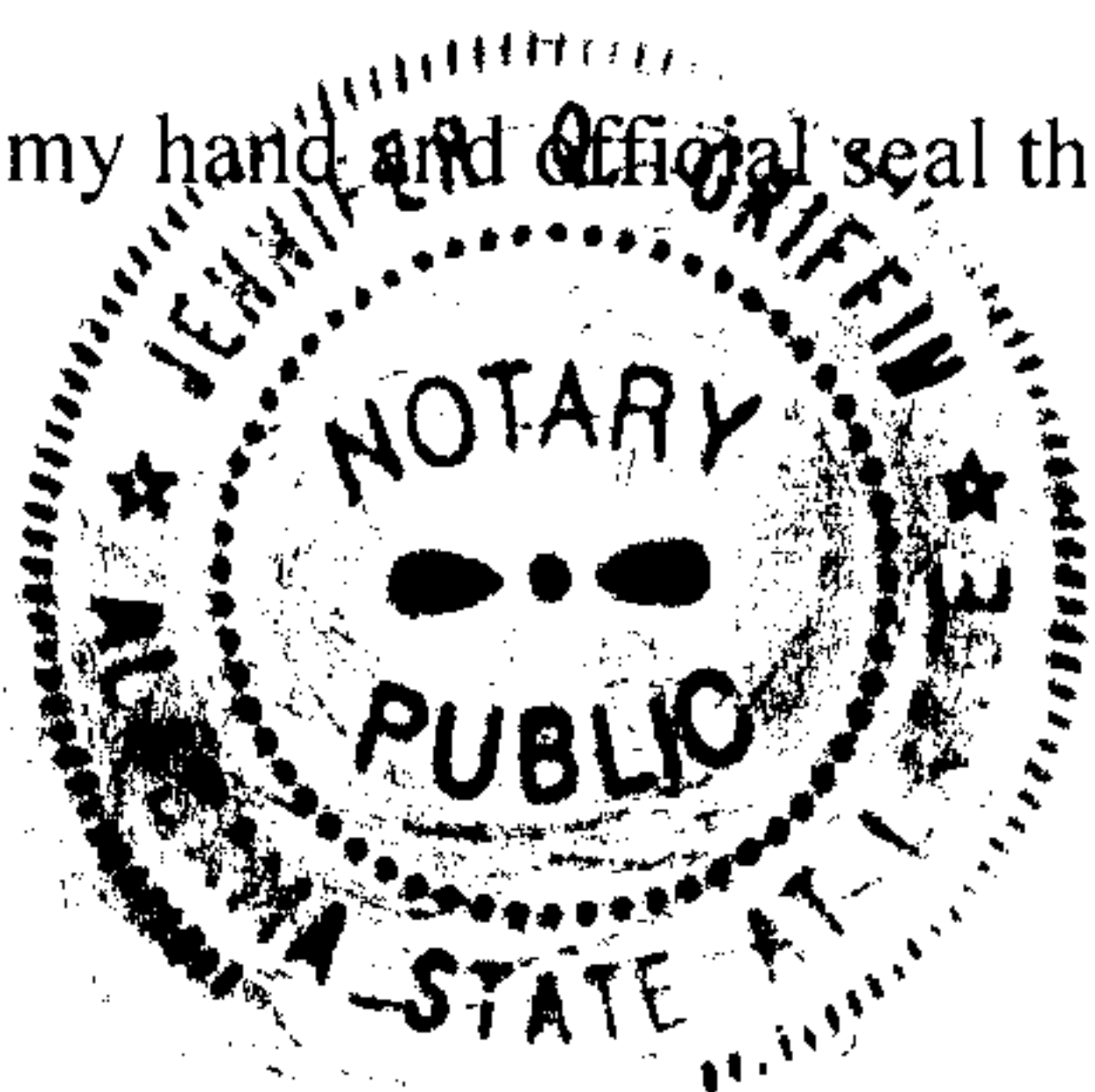


