

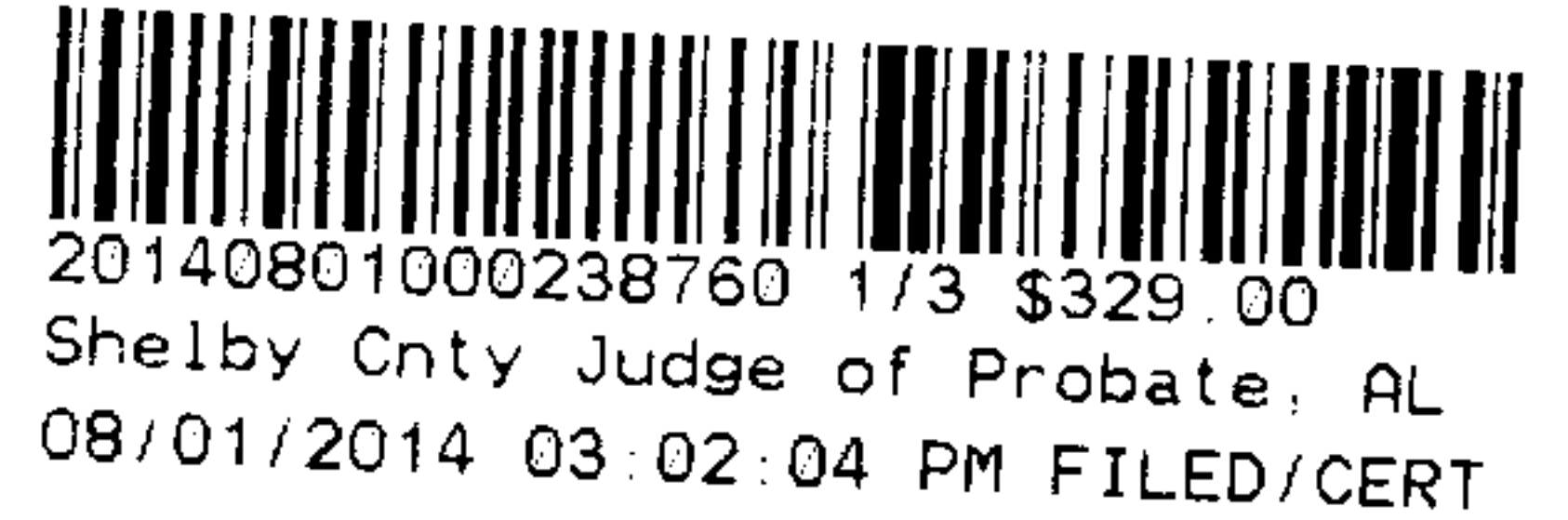

**KNOW ALL MEN BY THESE PRESENTS**, That in consideration **THREE HUNDRED NINE THOUSAND DOLLARS AND ZERO CENTS (\$309,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, ***Richard L. Massie, a single man***, (herein referred to as ***Grantor***) grant, bargain, sell and convey unto ***Jillian Scheinert and Nicholas L. Massie*** (herein referred to as ***Grantees***), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

**SUBJECT TO:**

1. Ad valorem taxes due and payable October 1, 2014.
2. Easements, restrictions, rights of way, and permits of record.

**TO HAVE AND TO HOLD** Unto the said **GRANTEES** as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, and I am (we are) lawfully seized in fee simple of said premises, that they are free from all encumbrances unless otherwise noted above, that I (we) have a good right to sell and convey the same as aforesaid, that I (we) will, and my (our) heirs, executors and administrators shall, warrant and defend the same to the said Grantees, heirs, executors and assigns forever, against the lawful claims of all persons.

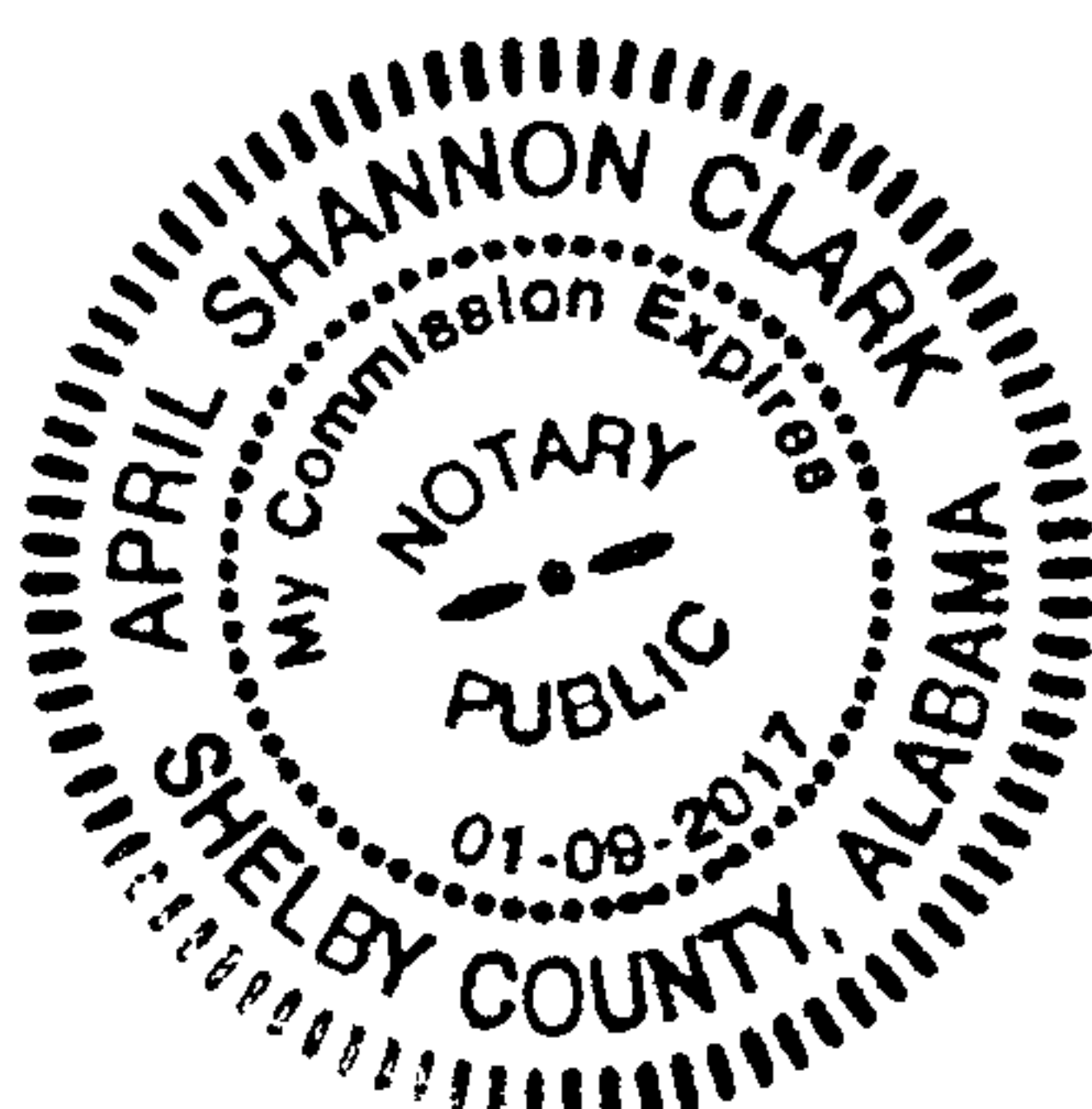

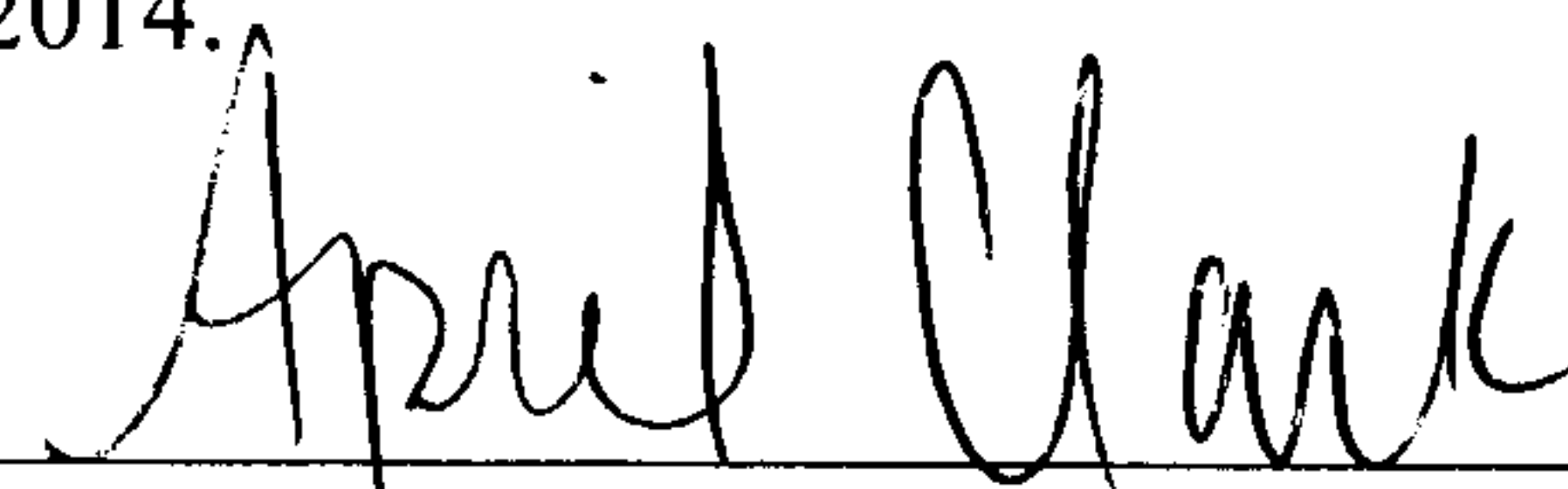

## Exhibit "A" Legal Description

### Parcel 1

Commence at a point where NE boundary of North Boundary Street intersects the NW boundary of Main Street and run along the NW boundary of Main Street on a Northeasterly direction 244.00 feet to the point of beginning; thence continue North along this line 86.00 feet; thence turn an angle of 90 degrees 00 minutes to the left for 150.00 feet; thence turn an angle of 90 degrees 00 minutes to the left for 86.00 feet; thence turn an angle of 90 degrees 00 minutes to the left for 150.00 feet to the point of beginning; being situated in the S  $\frac{1}{2}$  of the SW  $\frac{1}{4}$  of Section 21, Township 22 South, Range 3 West, Shelby County, Alabama; being situated in Shelby County, Alabama

### Parcel 2

A parcel of land located in the NW  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  of Section 11, Township 22 South, Range 3 West, being more particularly described as follows:

Commence at the SW corner of said Section 11; thence run North 90 degrees 00 minutes 00 seconds East along the south line thereof for a distance of 985.12 feet; thence run North 01 degrees 43 minutes 00 seconds West for a distance of 1622.26 feet to the point of beginning, thence continue North 01 degrees 43 minutes 00 seconds West for a distance of 500.33 feet; thence run North 64 degrees 51 minutes 29 seconds West for a distance of 406.70 feet; thence run South 32 degrees 58 minutes 45 seconds West for a distance of 362.49 feet; thence run South 57 degrees 01 minutes 15 seconds East for a distance of 692.23 feet to the point of beginning.

Commence at the SW corner of said Section 11; thence run North 90 degrees 00 minutes 00 seconds East along the South line thereof for a distance of 985.12 feet; thence run North 01 degrees 43 minutes 00 seconds West for a distance of 2129.59 feet; thence run North 64 degrees 51 minutes 29 seconds West for a distance of 406.70 feet to the point of beginning of a 50-foot wide easement lying Southwest of the following described line, thence continue North 64 degrees 51 minutes 29 seconds West for a distance of 821.27 feet to the Southeasterly right of way of Shelby County Highway No. 119 and the end of said easement.
