That in consideration of Ninety and 00/100 (\$90,000.00) Dollars (the entire amount of which is paid from the proceeds of a purchase money mortgage executed and recorded simultaneously herewith) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, I, Ken Sullivan, a married man (herein referred to as grantors) do grant, bargain, sell and convey unto April Mixon and Sylvester Mixon, a married couple (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

This deed was prepared without the benefit of a title search.


Subject to all rights of way, easements, covenants and restrictions of record.




