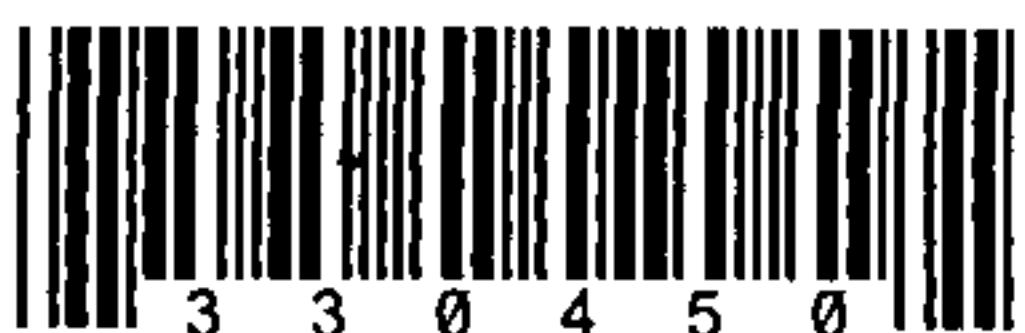
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 6th day of December, 2002, Marcus A. Bryant and Melissa C. Bryant, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for National Bank of Commerce of Birmingham, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20021217000630070, said mortgage having subsequently been transferred and assigned to Federal National Mortgage Association, by instrument recorded in Instrument Number 20140618000184840, in the aforesaid Probate Office ("Transferee"); and

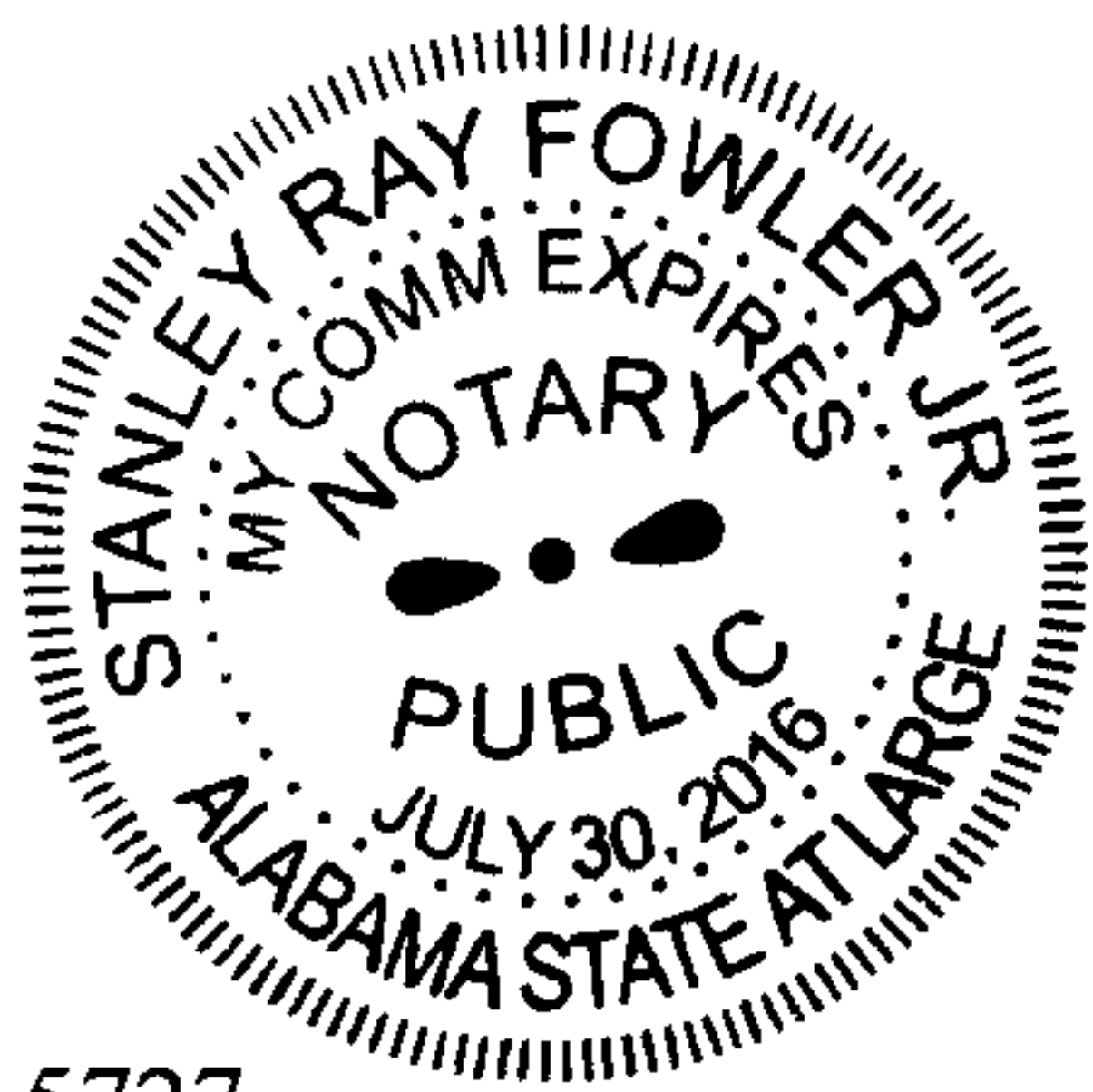

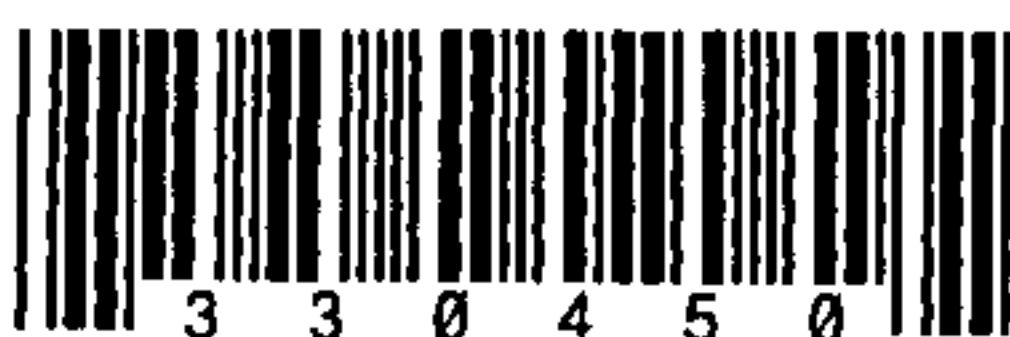
