NONRECOURSE ASSIGNMENT OF JUDGMENT AND LIEN

WHEREAS, Shelby County and Anthony Cairo have agreed that Shelby County will assign its interest in said judgment and recorded lien, without warranty and without any recourse whatsoever, to Anthony Cairo in consideration of the sum of \$3,100.00;

NOW, THEREFORE, premises considered, and in consideration of the payment by Anthony Cairo to Shelby County of the sum of \$3,100.00, Shelby County, to the extent that it may legally do so and without any recourse whatsoever to Shelby County, assigns to Anthony Cairo its interest in the aforesaid judgment and lien against Charles Alfred Cairo as described above, and any and all sum or sums of money or other benefit or advantage which may be had or obtained by reason of such judgments and liens. This assignment is without warranty of any kind, and specifically does not warrant the collectibility of the judgment or lien or the solvency of Charles Alfred Cairo. Shelby County represents to Anthony Cairo that it has not received or collected any sums whatsoever on said judgment or lien.

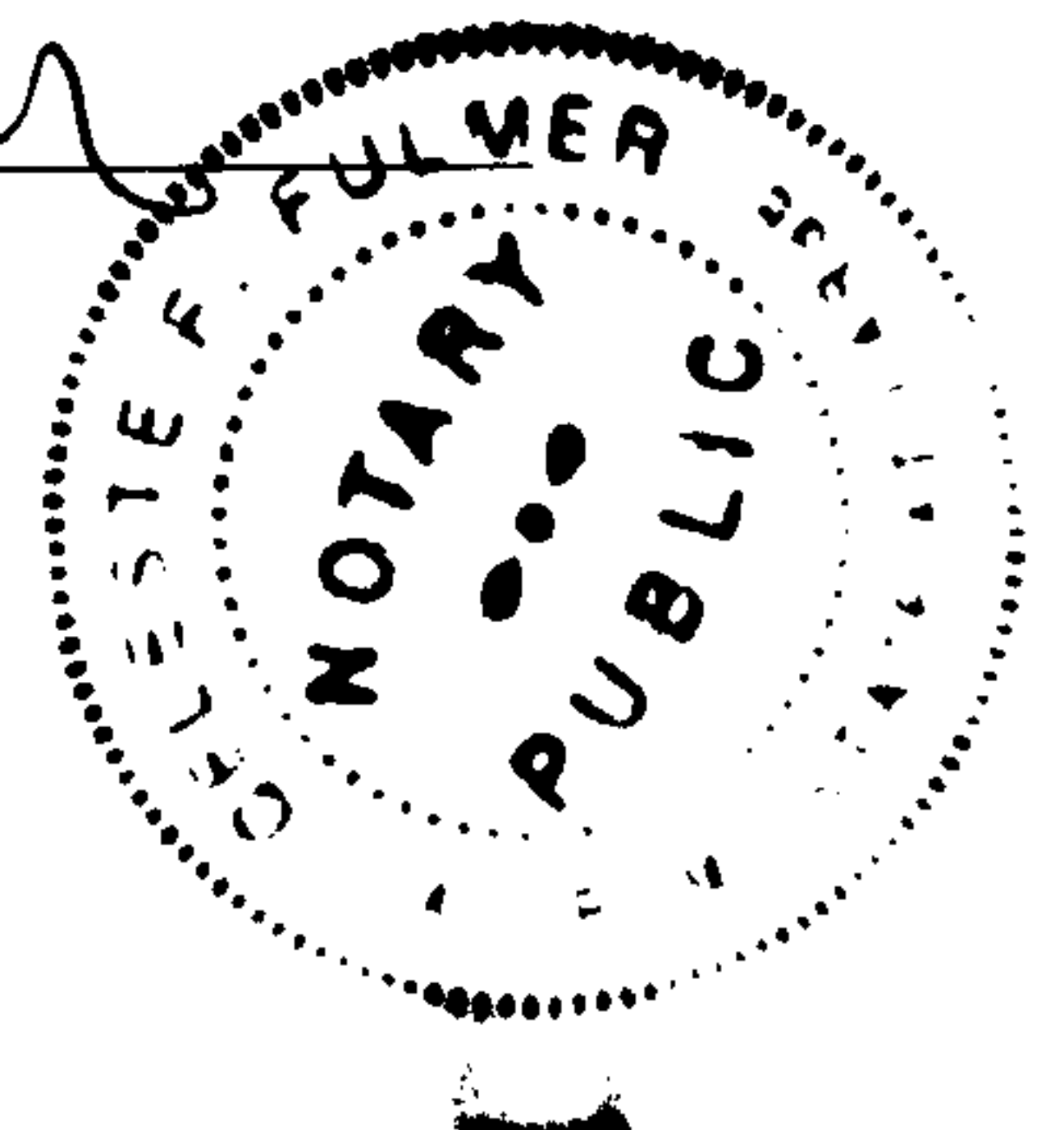
