


**CERTIFICATION OF TRUST

3. The Frances King Burns Trust dated September 2, 2011 has a definite beneficiary. The same person is not the sole trustee and sole beneficiary.
4. Excerpts from the trust agreement that establish the trust, designate the Trustee and set forth powers of the Trustee will be provided upon request. The administrative and/or managerial powers of the trustees are shown on the Powers of Trustee, and include the power to acquire, sell assign, convey, pledge, encumber, lease, borrow, manage and deal with real and personal property interests.
