\$1.00 cash in hand paid and in further consideration of the mutual benefit to the Grantor and Grantee herein, the undersigned, County Board of Education of Shelby County, Alabama (hereinafter "Grantor") does hereby grant, bargain, sell, and convey unto the City of Chelsea, Alabama, a municipal corporation of the State of Alabama (hereinafter "City"), a permanent, non-exclusive easement and right-of-way, including all right, title, and interest in and to any timber growing or at any time located within the right-of-way and easement limits, upon the land hereinafter described, together with the right to locate or relocate utilities, and to enter upon such described easement area and grade, level, fill, drain, pave, build, maintain, repair, and build a road or roadway, together with such bridges, culverts, ramps, and cuts as may be necessary, on, over, and across such right-of-way easement area situated and lying in the county of Shelby, state of Alabama, more particularly described on Exhibit "A", attached hereto and part and parcel hereof as fully as if set out herein, which said Exhibit "A" consists of two pages, one being the metes and bounds description and the other being a plat site or diagram showing the relative location of such easement.
