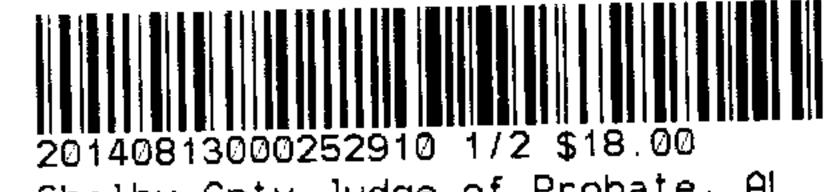

## State of Alabama County of Shelby

KNOW ALL MEN BY THESE PRESENTS, that in consideration of One Hundred Fifty Eight Thousand Five Hundred Dollars and No Cents (\$158,500.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Gloria S. Kircus, a single woman (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Charles L. Rectenwald and Belinda R. Feagin (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 43, according to the Survey of Meadow Brook Townhomes, Phase II, 1st Sector, as recorded in Map Book 12, Page 41, in the Probate Office of Shelby County, Alabama. Mineral and mining rights excepted.

**SUBJECT TO**: (1) Ad valorem taxes for current and subsequent years, (2) easements, restrictions reservations, rights-of-way, limitations, covenants and conditions of record, if any, (3) mineral and mining rights not owned by the Grantor, if any.

And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEES, their heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEES, their heirs, executors and assigns forever, against the lawful claims of all persons.
