**Articles of Organization of Ray Operations LLC**

The undersigned, acting pursuant to the Alabama Limited Liability Company Act, as last amended, hereby adopt the following Articles of Organization:

**FIRST:** The name of the Limited Liability Company is: Ray Operations LLC.

**SECOND:** The period of duration shall be perpetual.

**THIRD:** The purposes for which the Limited Liability Company is organized are:

- (a) To conduct services on a contract basis for business enterprises and individuals;
- (b) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, sell, and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;
- (c) To transact any or all lawful business permitted under the Alabama Limited Liability Company Act.

**FOURTH:** The location and street address of the initial registered office shall be:

185 County Road 111  
Montevallo, Alabama 35115

The initial registered agent at said address is Benjamin Ray Smith.

**FIFTH:** The name and address of the initial member of the Limited Liability Company is:

**SIXTH:** The name and address of the initial Operating Manager who is to serve until the first annual meeting of the Members or until his successor is elected and qualified is Benjamin Ray Smith.


**SEVENTH:** The Limited Liability Company shall have the right to admit additional members to the Limited Liability Company upon unanimous consent of all of the members of the Limited Liability Company.

**EIGHTH:** The members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company following an act of dissolution or disassociation of a member, or the occurrence of any other event, which terminates the continued membership of a member of the Limited Liability Company.

**NINTH:** The initial ownership percentages and legal monetary entitlement of the Limited Liability Company shall be 100% to Benjamin Ray Smith.

**TENTH:** The Limited Liability Company, to the extent allowed by law, shall be taxed for all purposes as a sole proprietorship.
