WHEREAS, heretofore, on, to-wit: the 30th day of April, 2009, Melissa D. 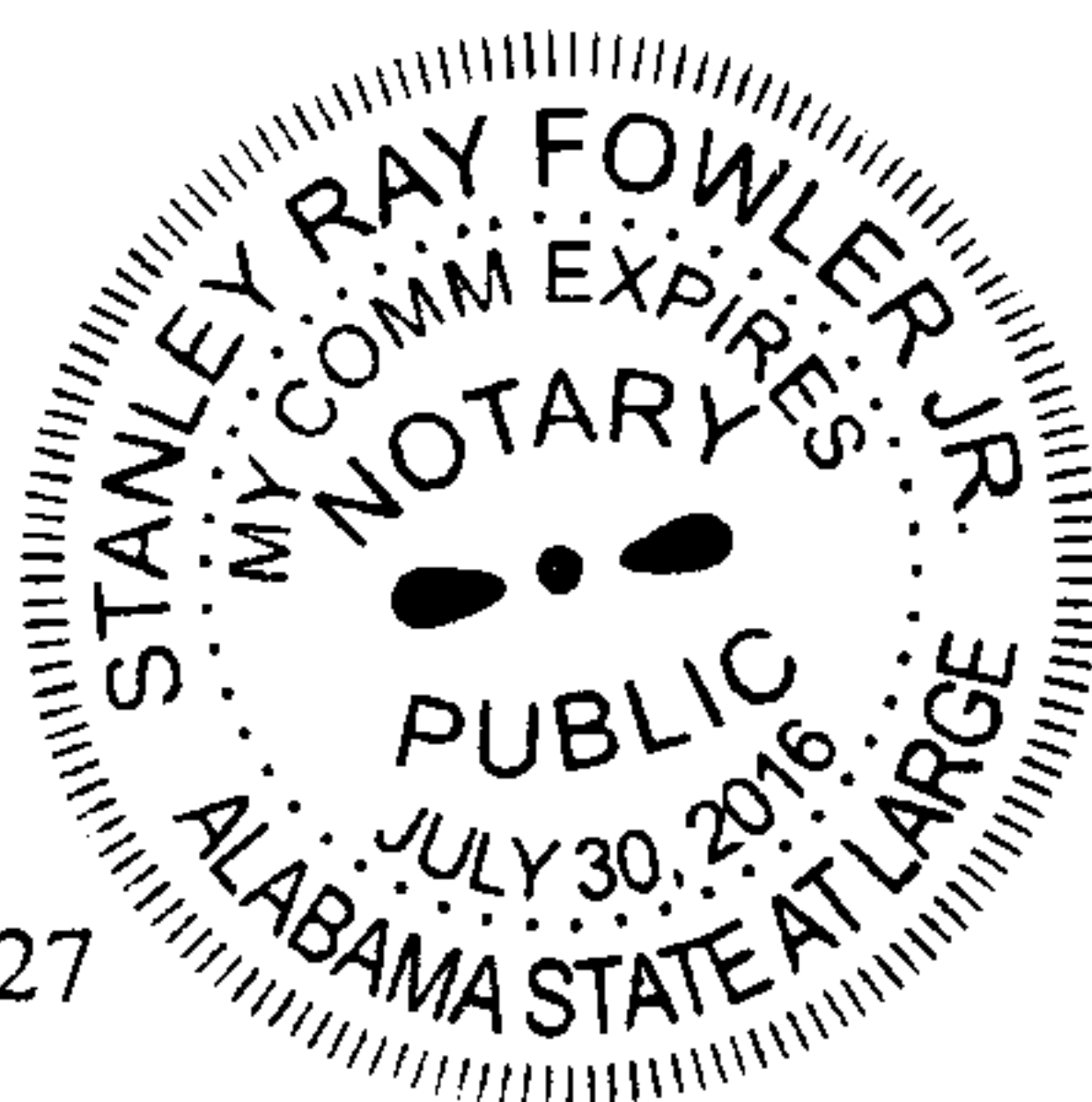
