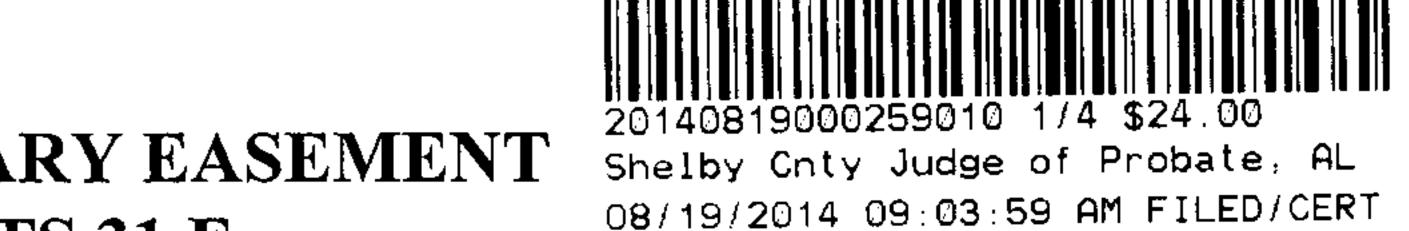

Commencing at the SW corner of the NW ¼ of the NE ¼ of Section 15, Township 19 South, Range 2 West, run thence N 00°17'54" E a distance of 388.50 feet, more or less, to the Point of Beginning; run thence S 77°15'04" E a distance of 129.19 feet, more or less, run thence S 31°58'31" E a distance of 21.11 feet, more or less, run thence N 77°15'04" W a distance of 127.33 feet, more or less, run thence N 35°20'00" W a distance of 22.45 feet, more or less, to the Point of Beginning; Containing 0.044 acres, more or less.

To have and to hold the said easement and right of way unto Shelby County and unto its successors and assigns for a period of three years, or until the completion of Project No.STPBH-9802 (905) whichever is later.

And the said grantor(s) hereby covenant(s) with Shelby County that we (I) are (am) lawfully seized and possessed of the afore-described tract or parcel of land; that we (I) have a good and lawful right to convey it; that it is free from all encumbrances; and that I (we) will warrant and forever defend the title and quiet possession thereto against the lawful claims of all persons whomsoever.

As a further consideration for the payment of the price above-stated, we (I) hereby release Shelby County, its employees and officials, from all claims for damage, from whatsoever cause, present, or prospective, incidental, or consequential, to the exercise of any of the rights herein granted.

The grantor hereby grants permission, with right of ingress and egress, to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and\or structures from the above-described right of way.

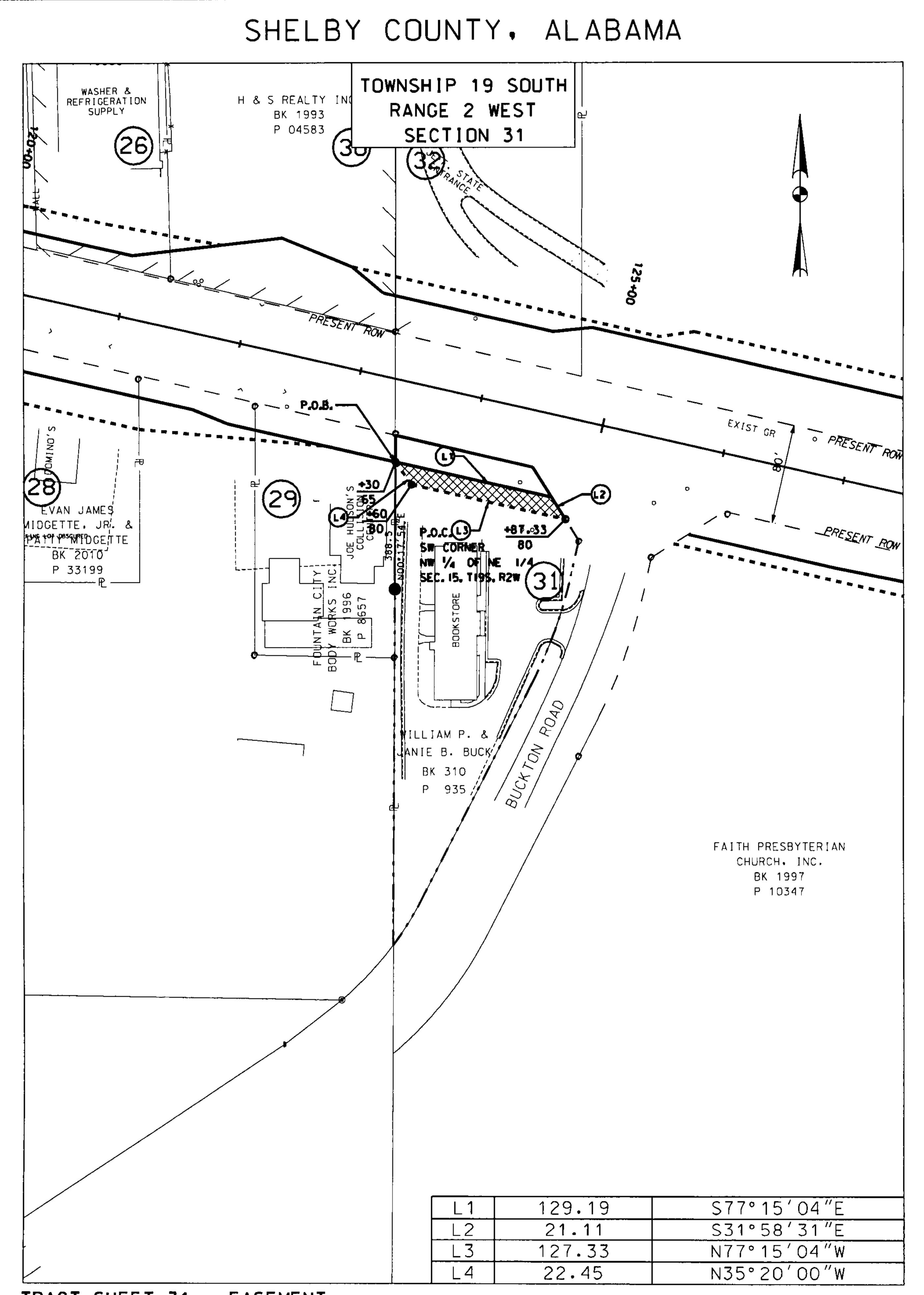

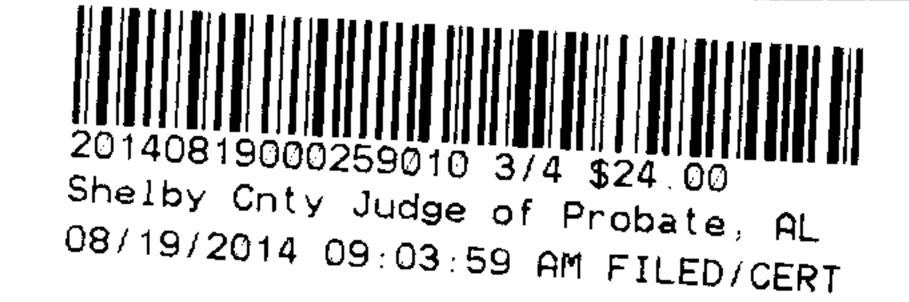
