KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of January, 2010, James Lindsey, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for DHI Mortgage Company LTD, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20100120000018650, said mortgage having subsequently been transferred and assigned to Lakeview Loan Servicing, LLC, by instrument recorded in Instrument Number 20131021000416930, in the aforesaid Probate Office ("Transferee"); and

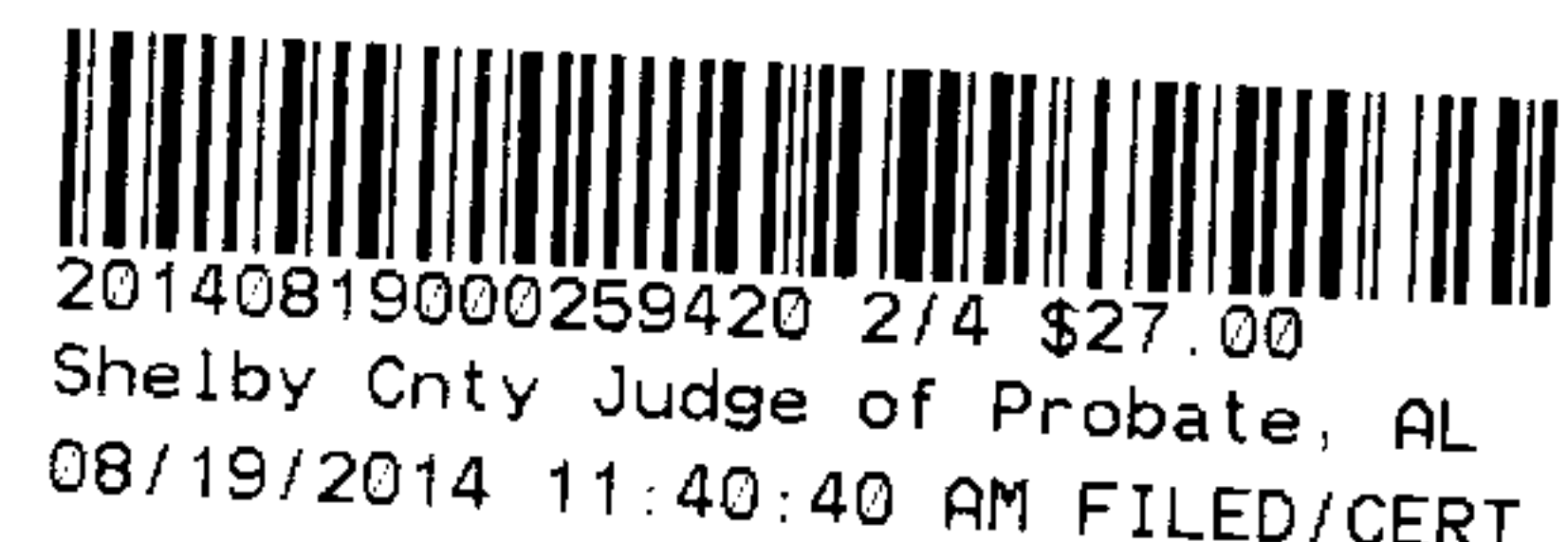

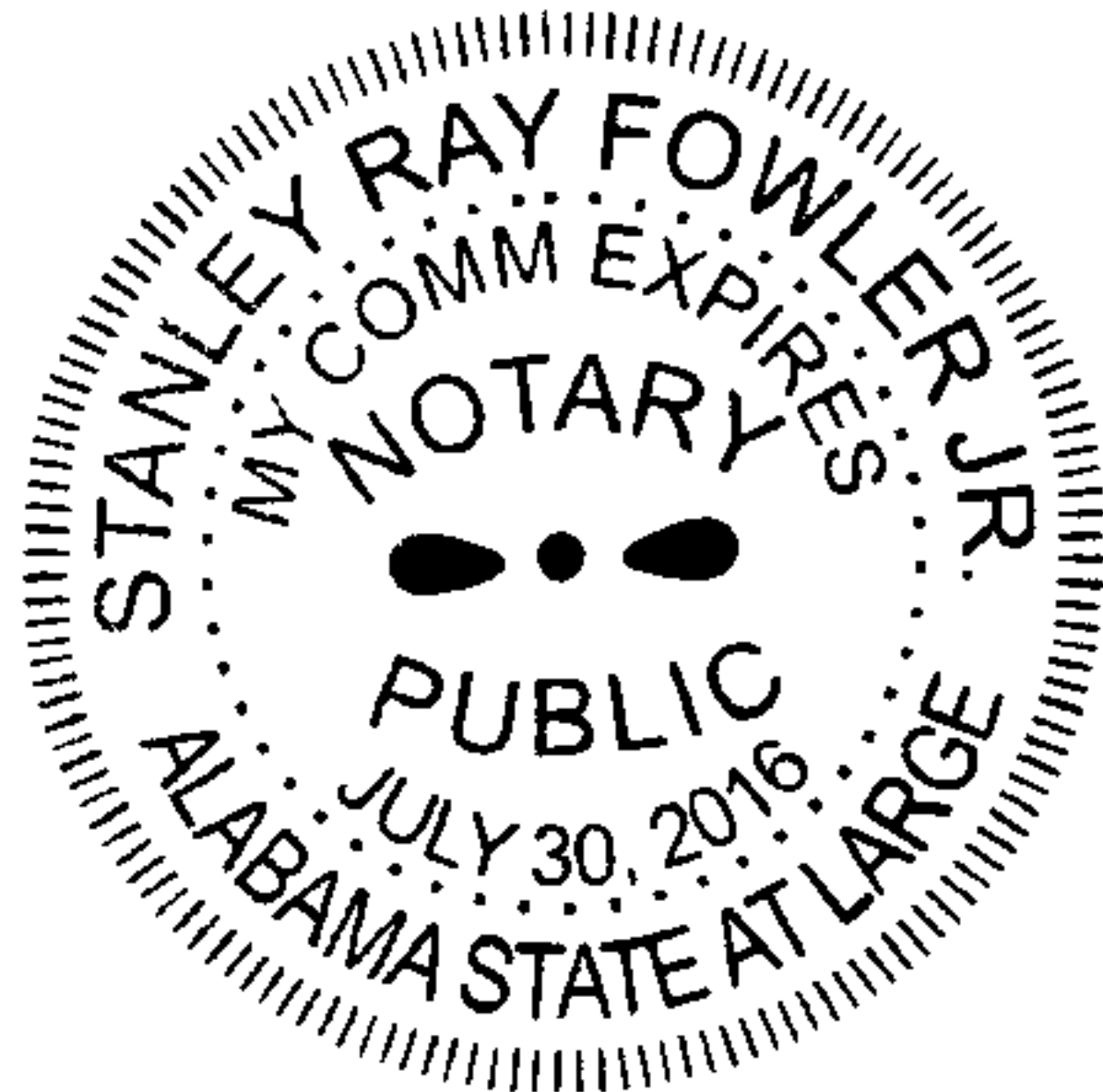

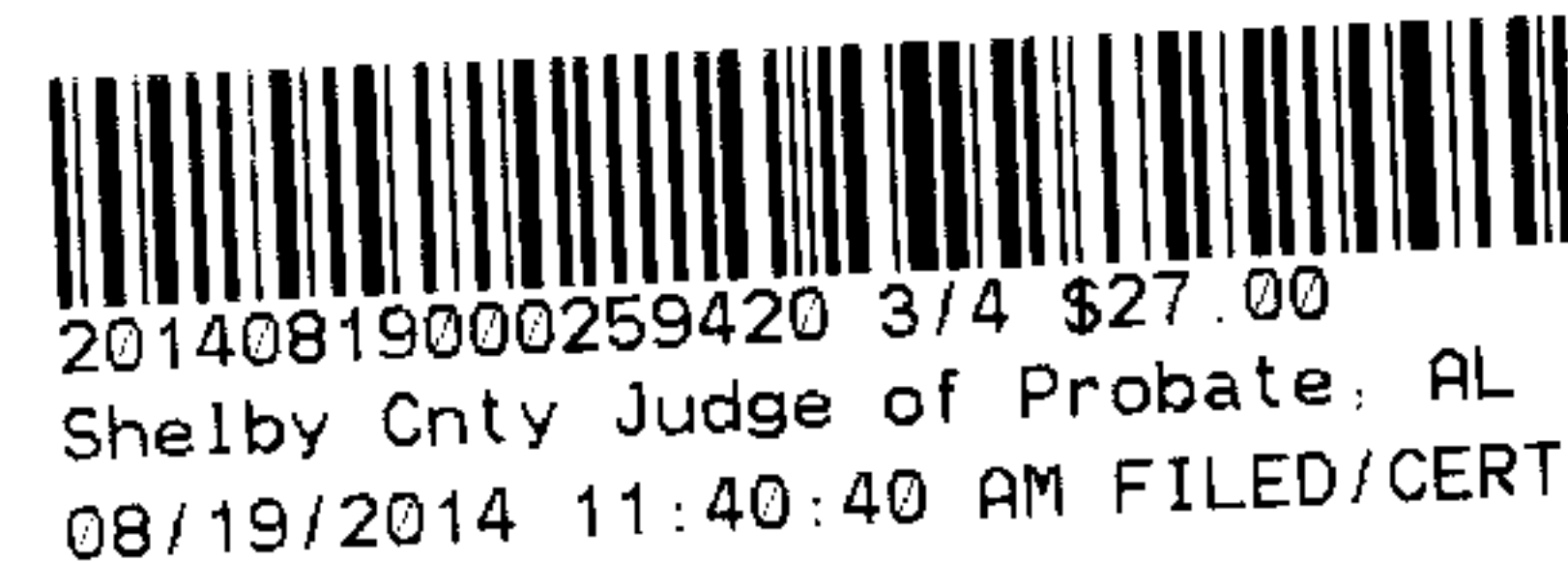
