**ARTICLE I  
NAME**

The name of the limited liability company is Mach3 Events, LLC (the "Company").

**ARTICLE II  
TYPE**

The Company is a limited liability company.

**ARTICLE III

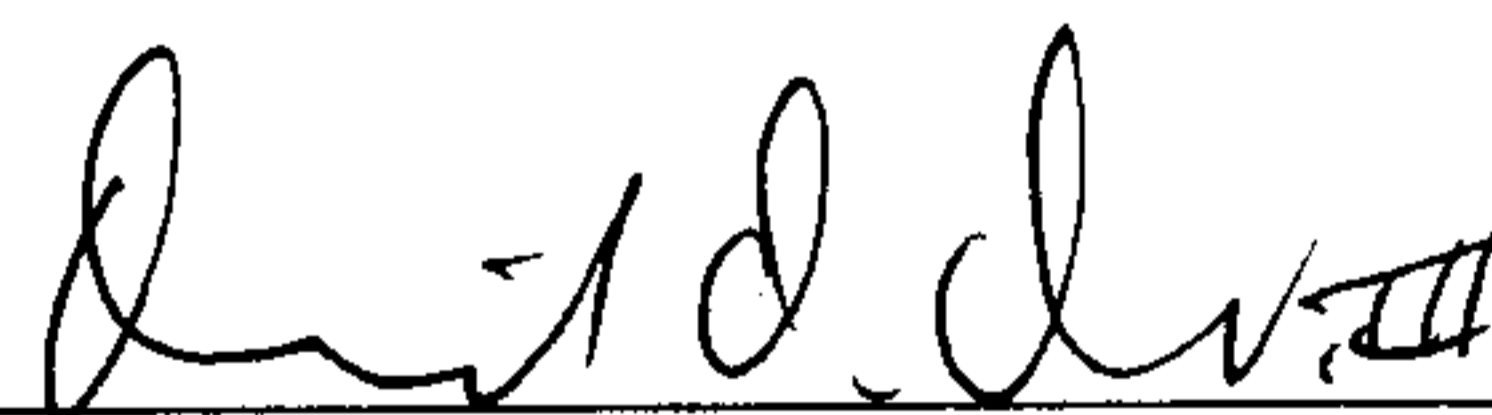
**ARTICLE VII
