Jason McCracken, whose address is 8585 Highway 41 South, Leeds, Alabama 35094.

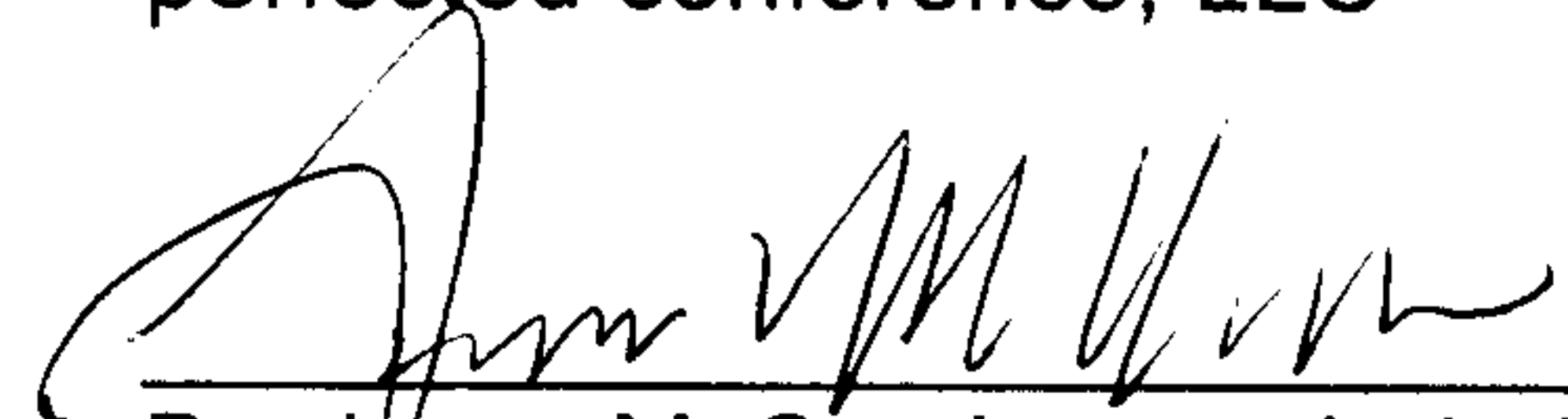

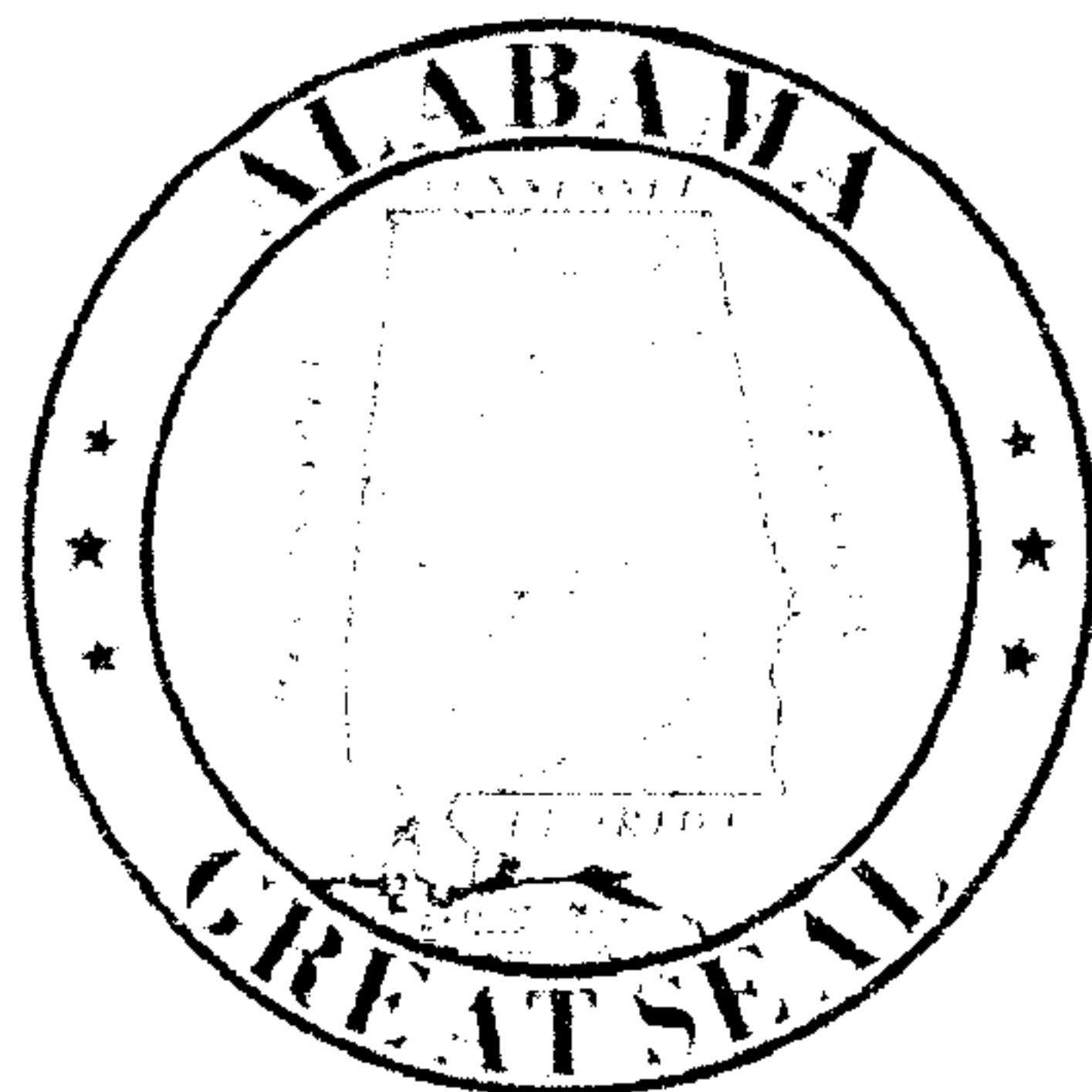
