

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of July, 2006, Alfred Peevy and Allison Peevy, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for First Franklin a Division of National City Bank of Indiana, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument number 20060727000362550, said mortgage having subsequently been transferred and assigned to U.S. Bank National Association, as trustee, on behalf of the holders of the First Franklin Mortgage Loan Trust 2006-FF14 Mortgage Pass-Through Certificates, Series 2006-FF14, by instrument recorded in Instrument Number 20130412000151600, in the aforesaid Probate Office ("Transferee"); and

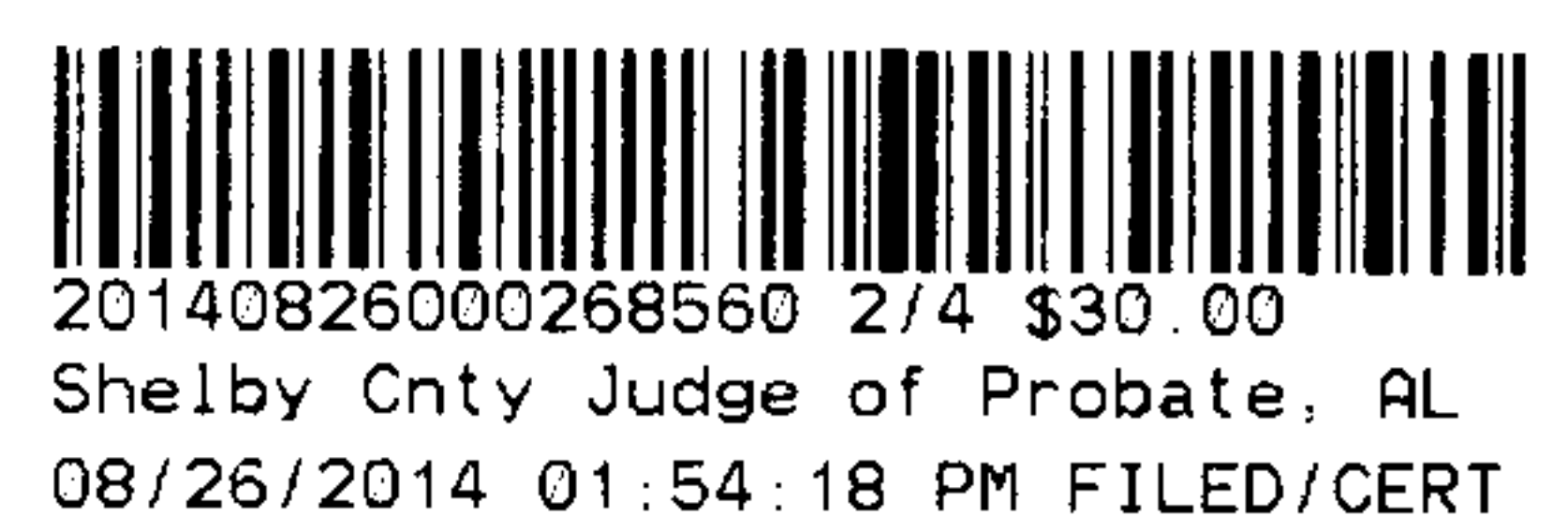

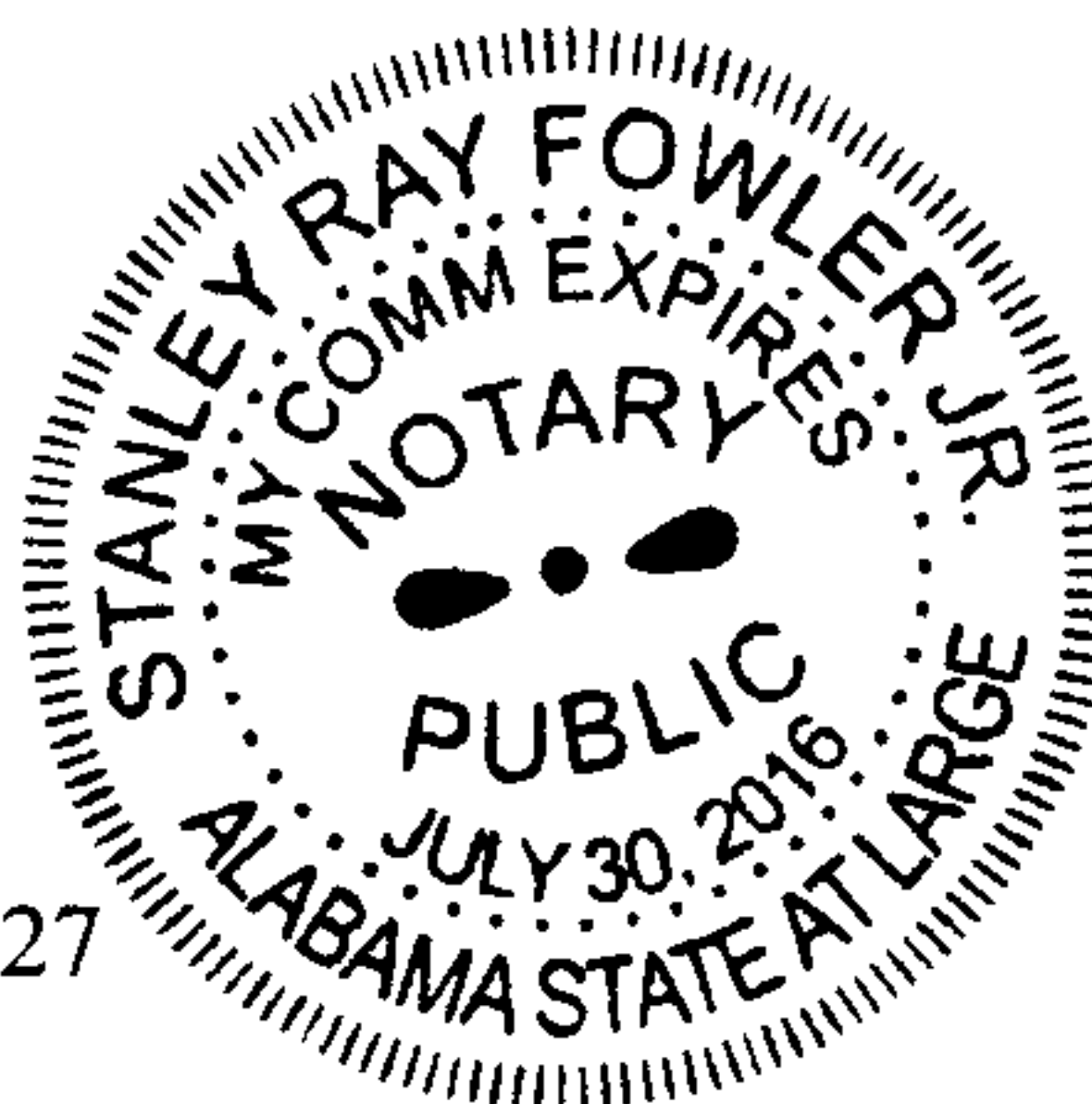
