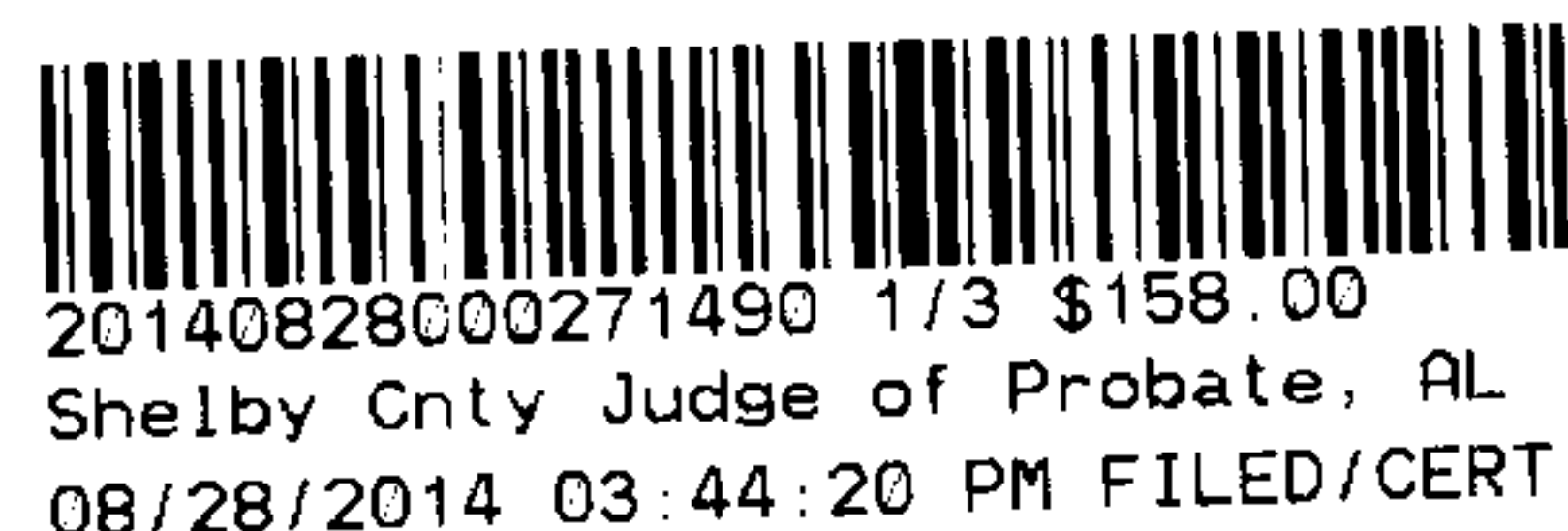

**CERTIFICATE OF FORMATION
OF

2. The limited liability company will have perpetual existence.
