**Articles of Incorporation
AgSam Enterprises, Inc.**

According to the provisions of Alabama Business and Nonprofit Entities Code, the undersigned hereby adopts the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the Corporation shall be AgSam Enterprises, Inc. ("the Corporation").

**ARTICLE II
DURATION**

The duration of the Corporation shall be perpetual.

**ARTICLE III
PURPOSE**

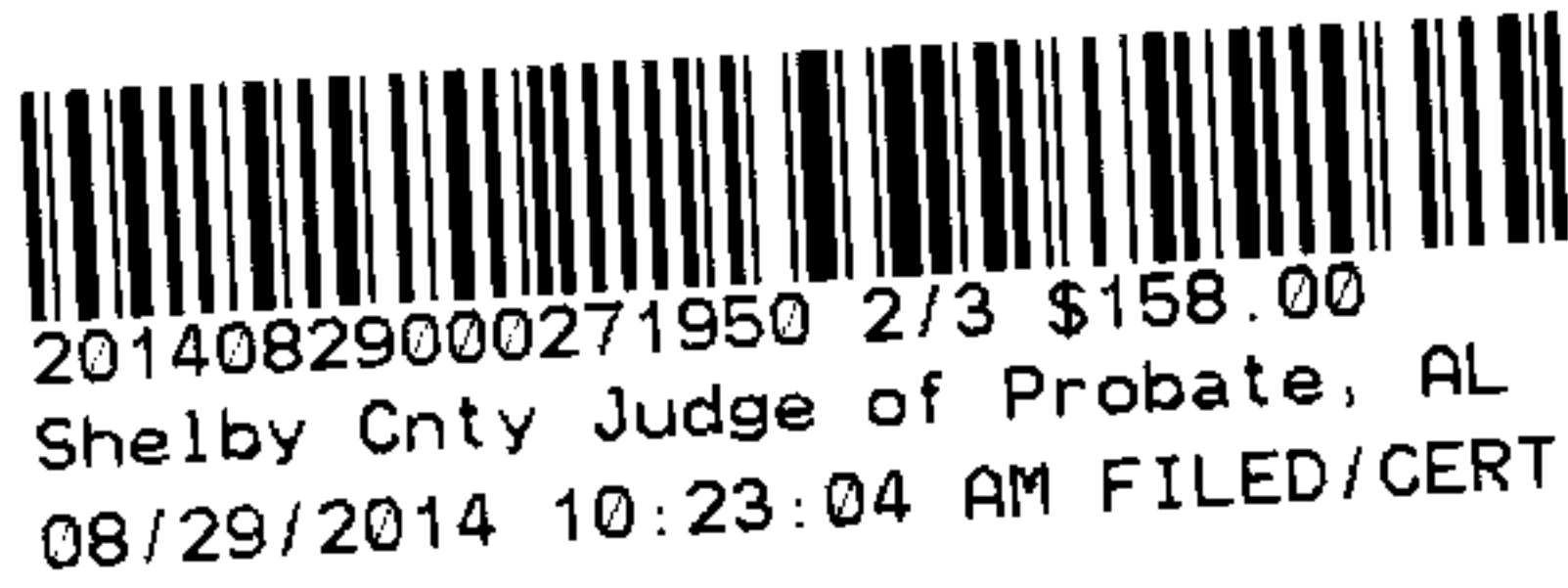
The Corporation has been organized to engage in any lawful business.

AUTHORIZED SHARES**

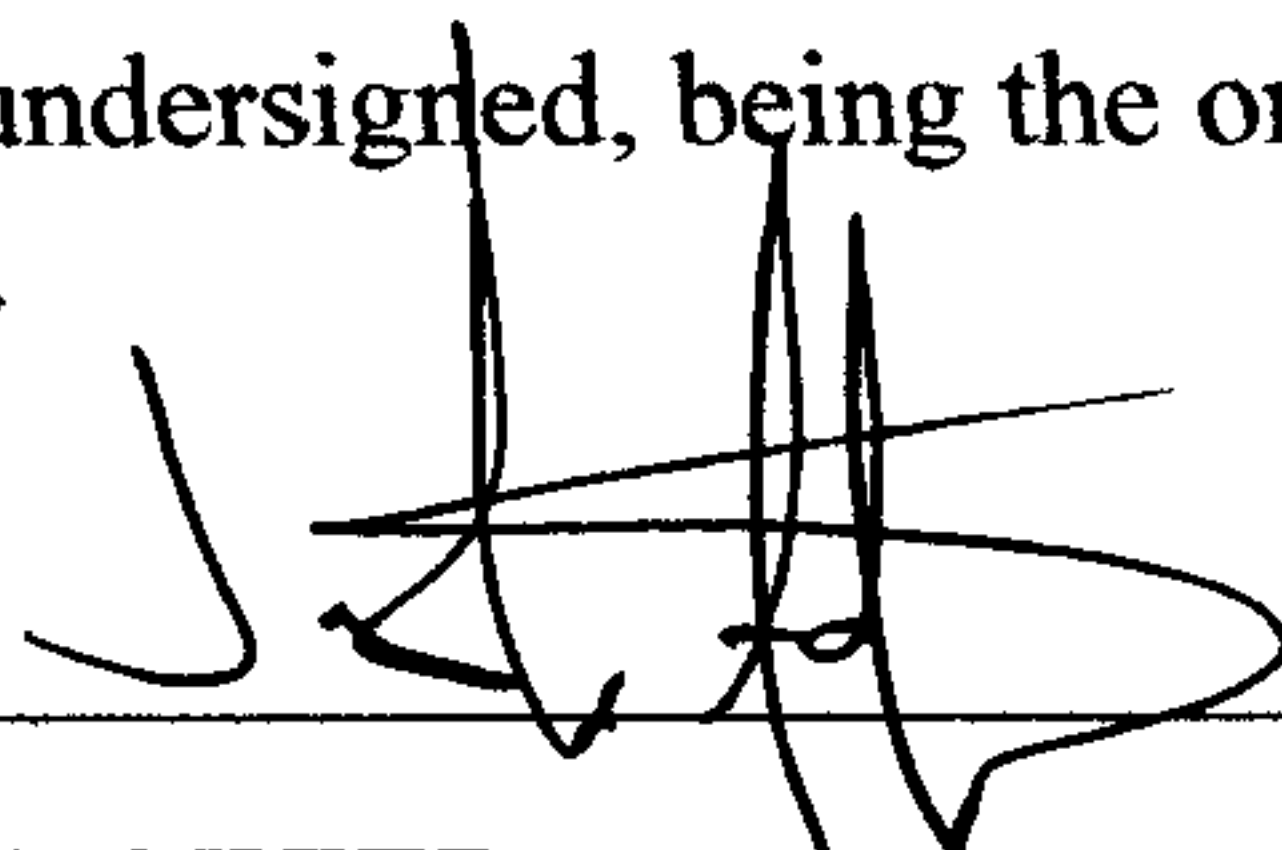

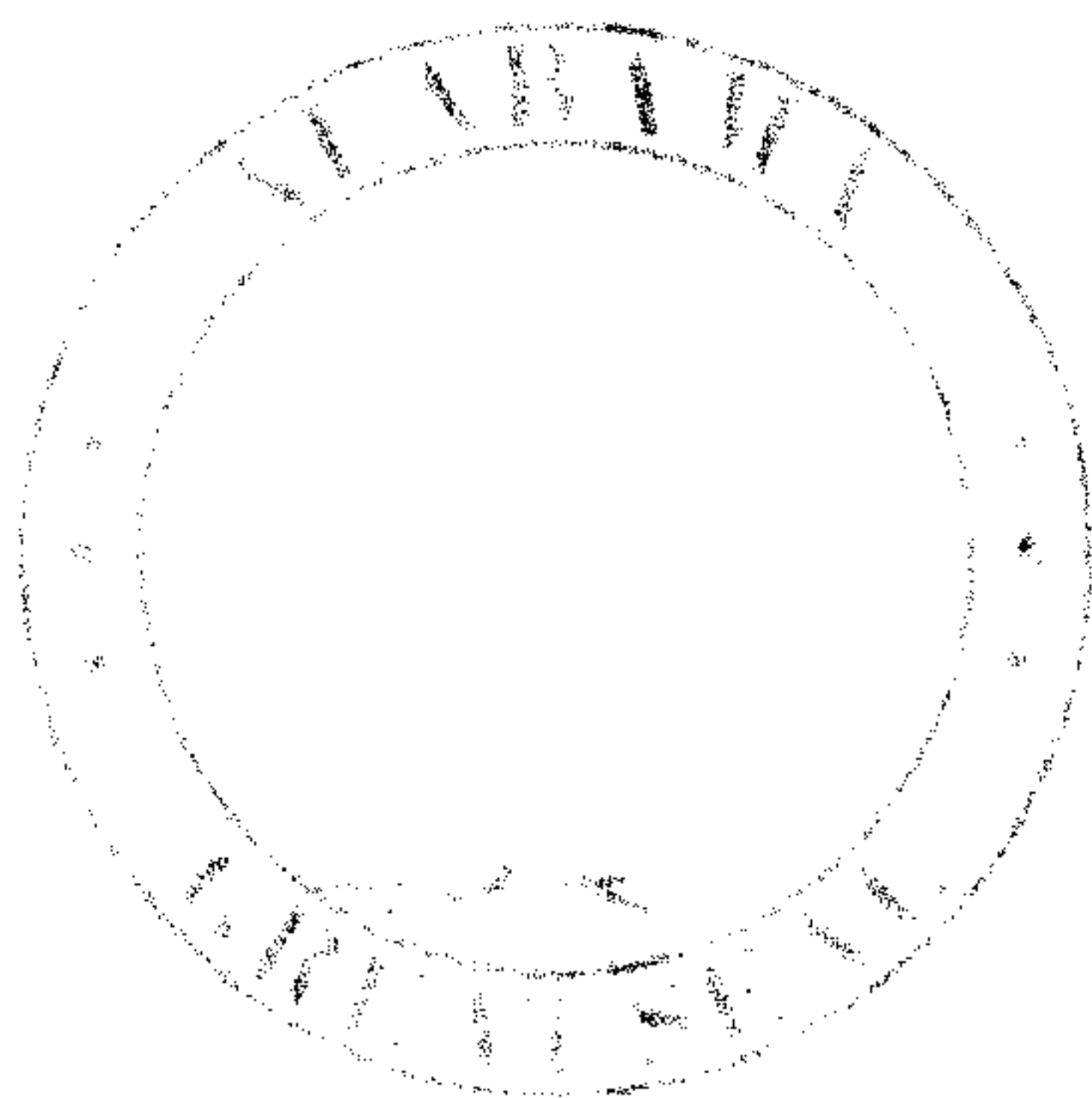
