

ARTICLES OF INCORPORATION OF NUMINOUSNEOISM ART, INC.

The undersigned natural person being over the age nineteen (19) years and a citizen of the United States of America, for the purpose of forming a profit S Corporation under and pursuant to the provision of Alabama State Law, has these Articles of Incorporation to constitute a charter for carrying on its pursuits for achieving its objective and purposes with the filing therefore and pursuit to law.

ARTICLE I

ARTICLE II

The period of duration shall be perpetual or until it is dissolved in accordance with the law.

ARTICLE III

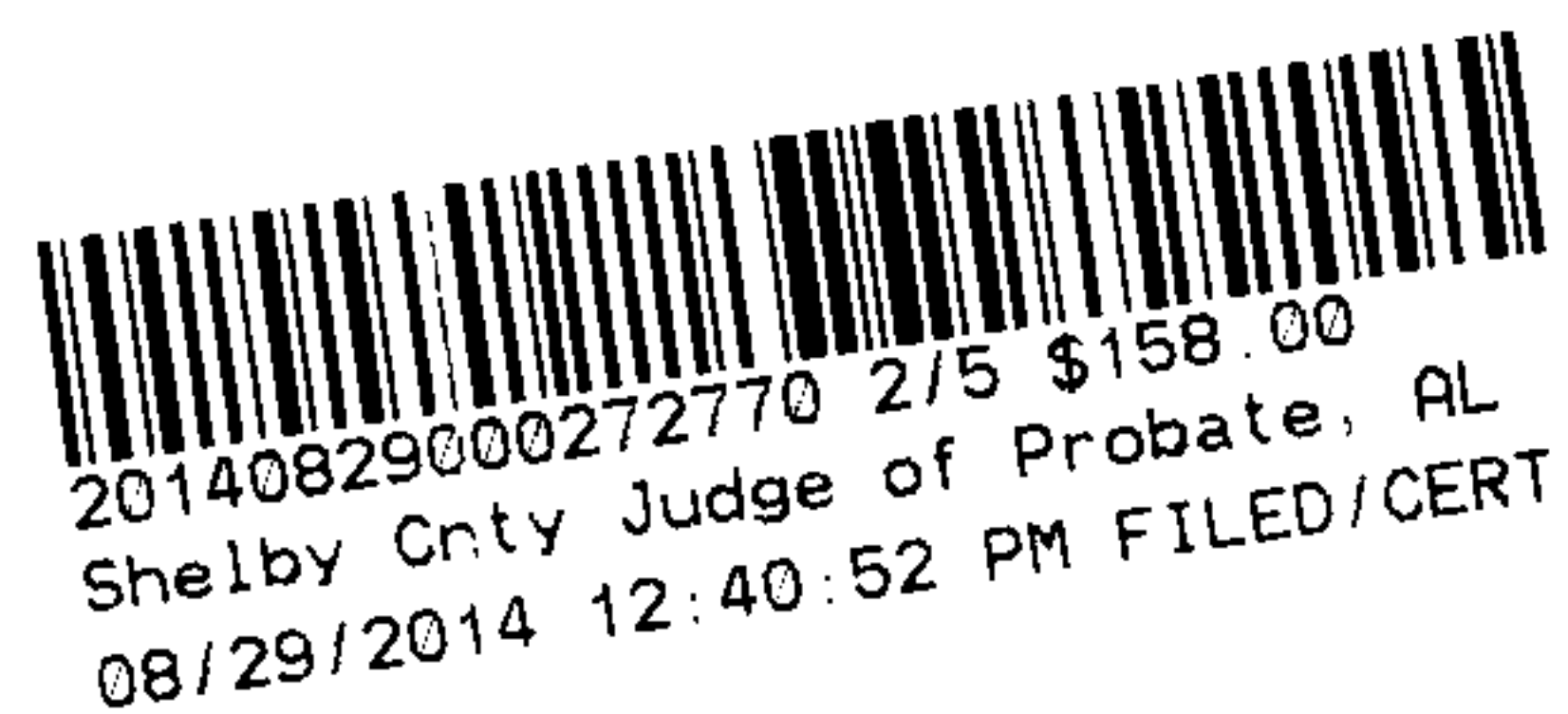
ARTICLES VIII

ARTICLES IX

The officers of the S Corporation of NUMINOUSNEOISM™ ART, INC. are appointed by **The BLACK ARTIST** John Solomon Sandridge CEO, and the powers, authorities, duties, and procedure for appointment and removal of officers shall be set forth in these Articles of Incorporation. **The BLACK ARTIST** John Solomon Sandridge CEO shall have full authority and responsibility for the S Corporation's direction, growth, development and oversight including, without limitation, decisions of operation and those means for improvement. Subsequent directors will be appointed consistent with the Articles of Incorporation and the Bylaws.

ARTICLES X

The BLACK ARTIST John Solomon Sandridge CEO, shall have the power/authority to direct/amend the Bylaws that contain provisions for the regulation and management of the affairs of the S Corporation, including, without limitation; (a) regulation and management of the affairs of the S Corporation, including, without limitation the method by which notice of each meeting is given; (b) the qualifications for members of the board of directors and their respective term of office; (c) procedures for filling of vacancies on the board of directors; (d) the qualifications for removing of members of the S Corporation's board of directors; (e) the establishment of standing committees, heads of committees boards, if any and the responsibilities of each, so established; (f) the establishment of a quorum for transacting business; (g) the designation of officer position consistent with these Articles of Incorporation; the power, authorities, duties, term of office and the method of appointment to the Bylaws.

ARTICLES XI

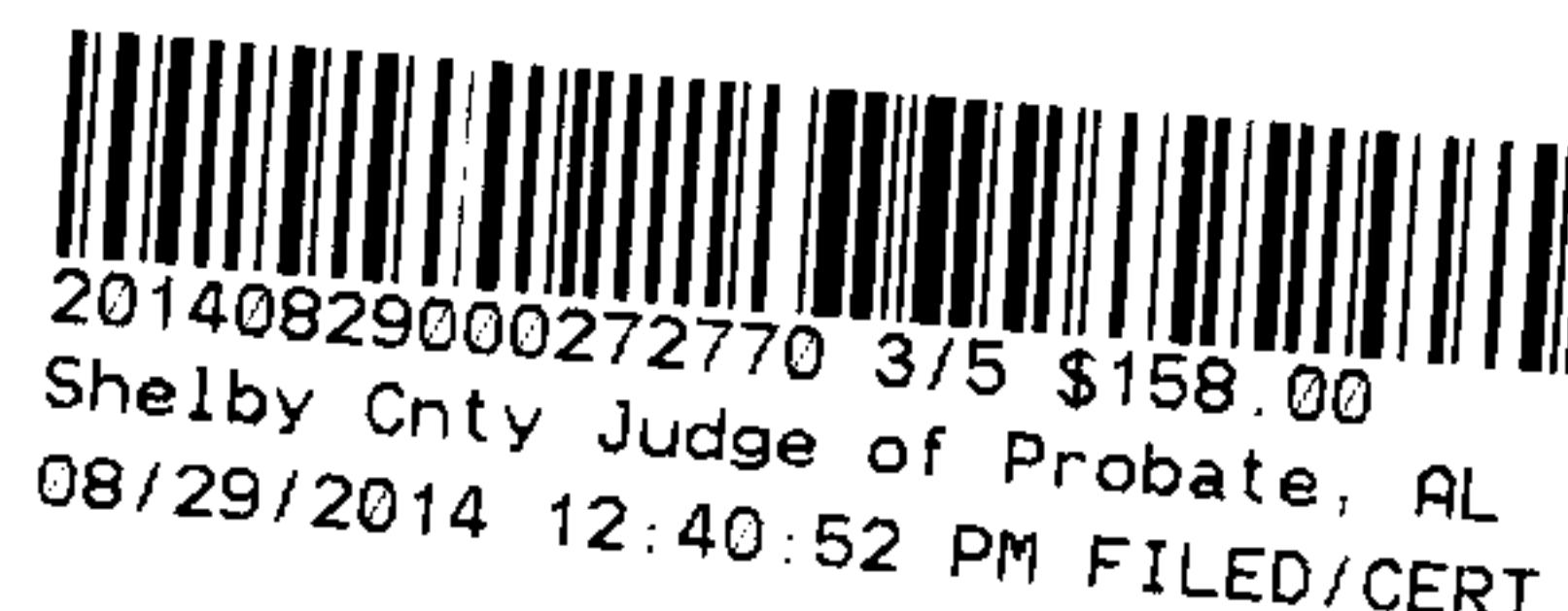

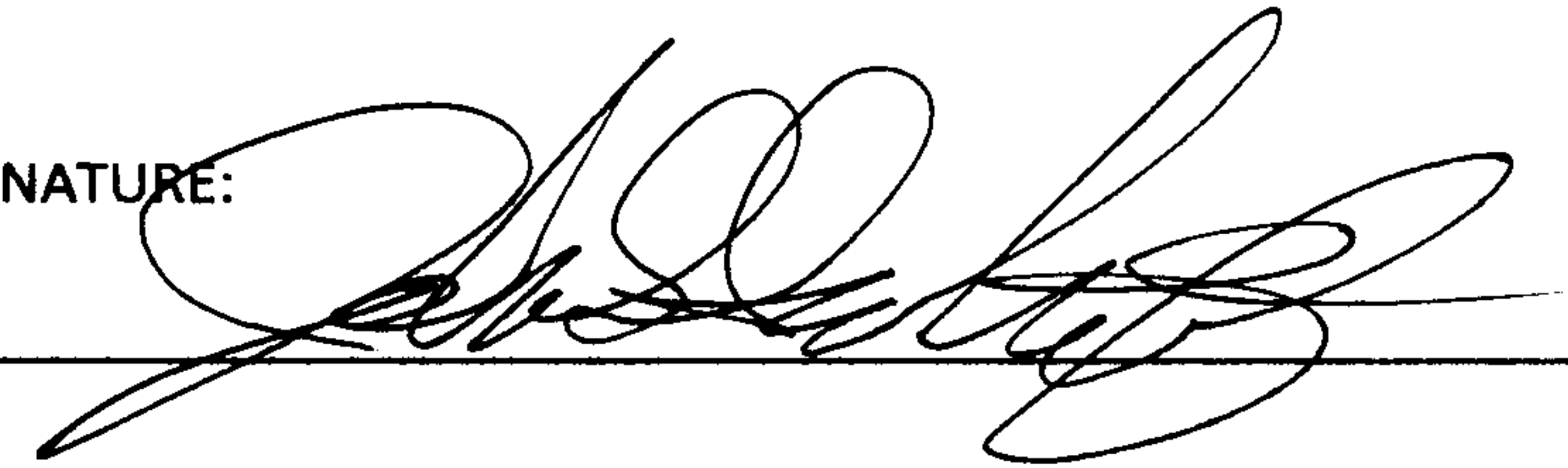
ARTICLES XIII

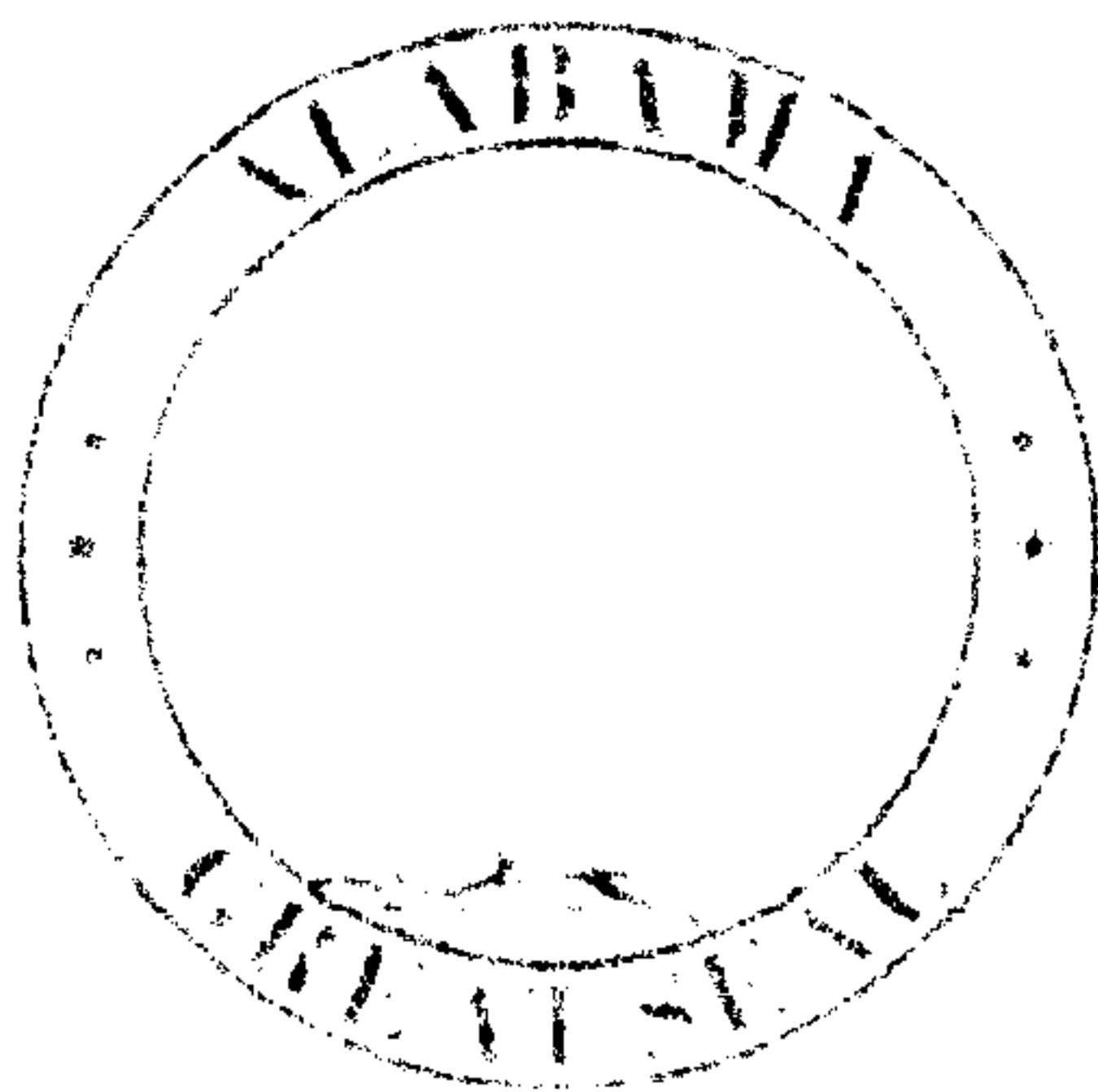
