Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

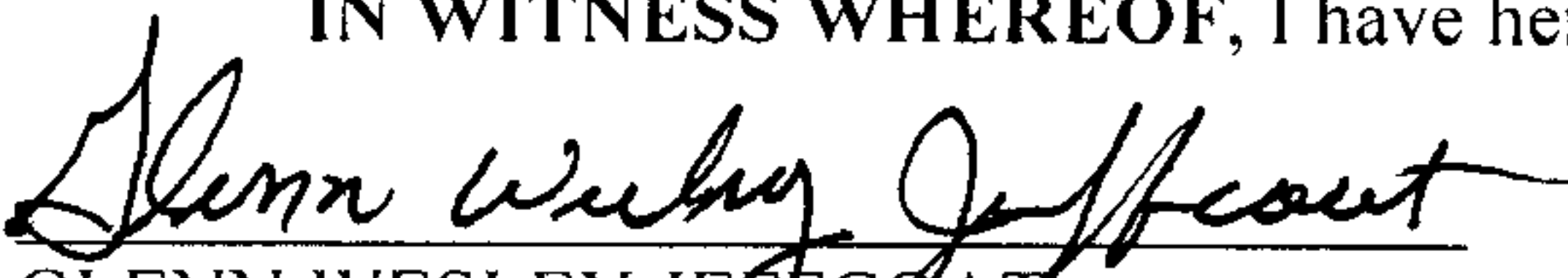
GLENN WESLEY JEFFCOAT and GLENN W. JEFFCOAT are one and the same person.

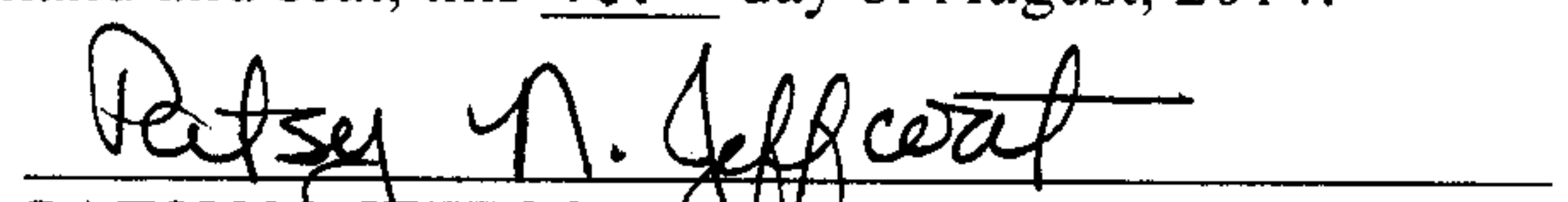
TO HAVE AND TO HOLD to the said grantee, his, her or their successors and assigns forever.

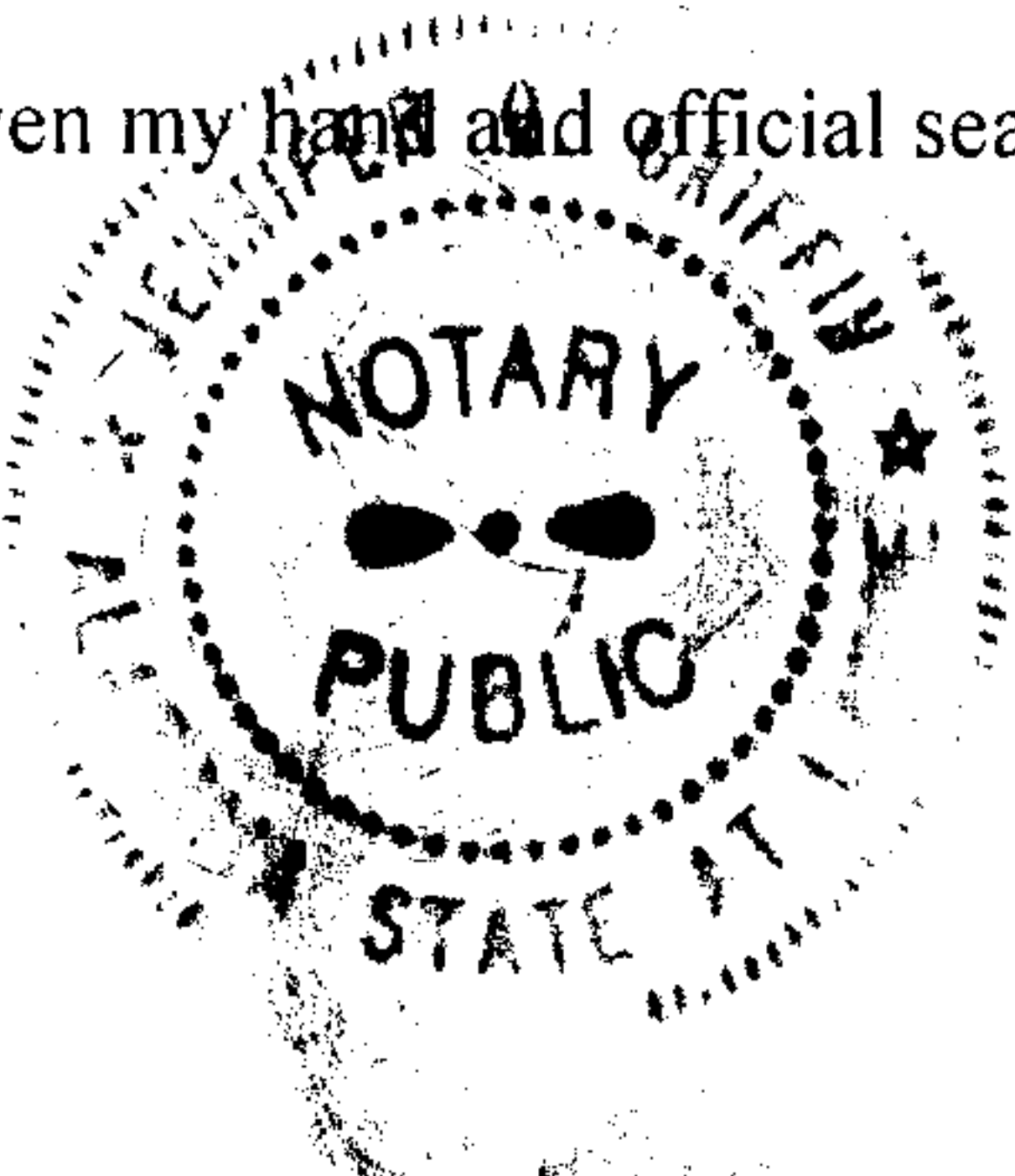

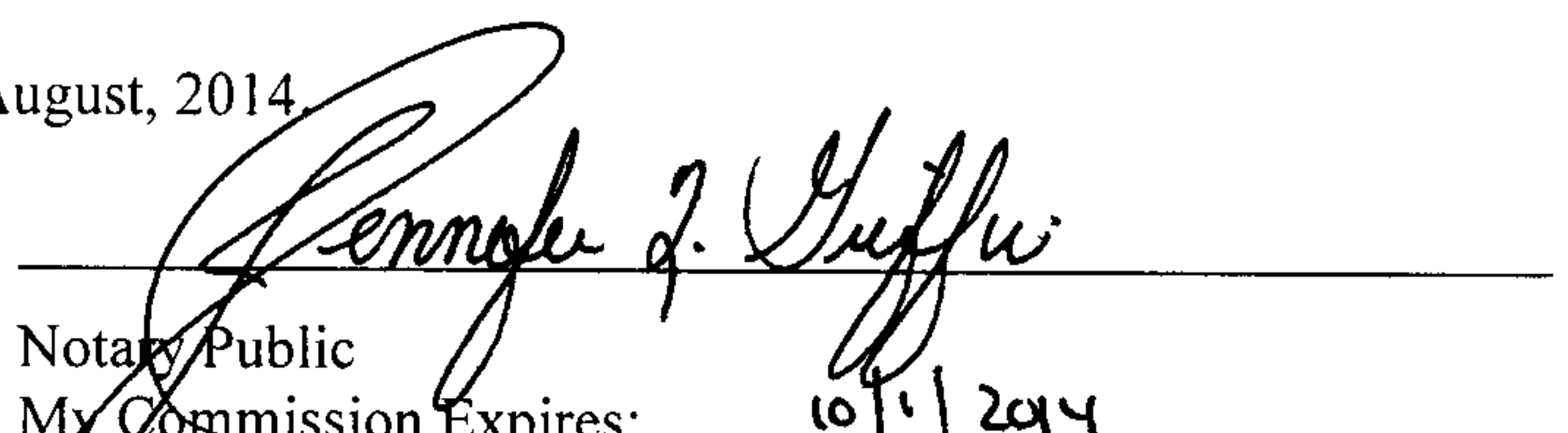
