ARTICLES OF ORGANIZATION
OF
RIO JO, LLC
An Alabama Limited Liability Company

Pursuant to the provisions of Sections 10A-5-2.01, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is Rio Jo, LLC, an Alabama Limited Liability Company (the "Company").

Cessation of Membership

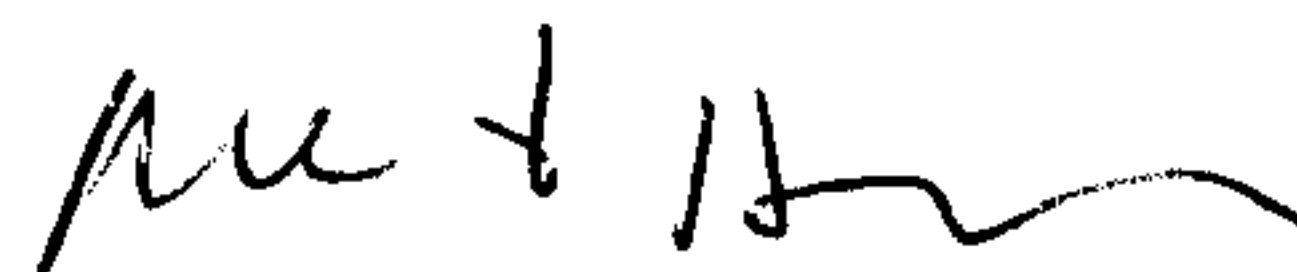
The cessation of membership of one or more members will not result in the dissolution of the Company.

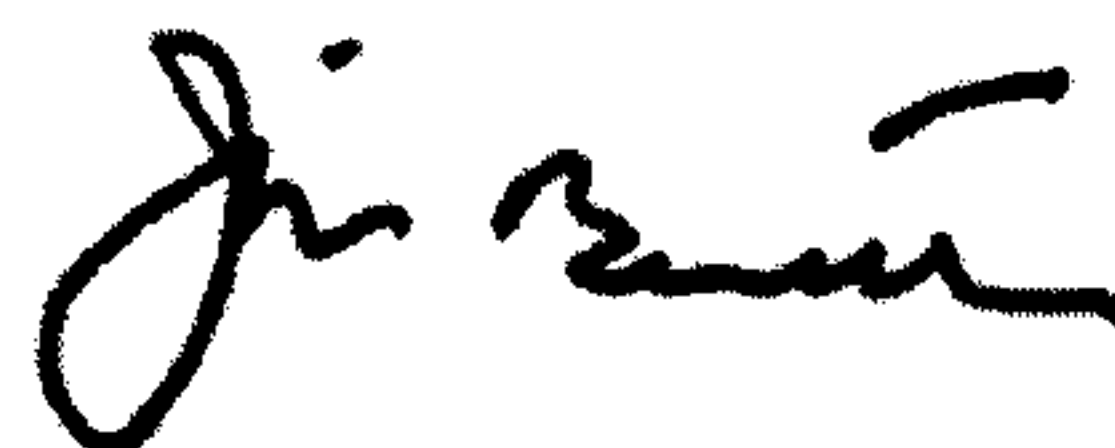
