



KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 9th day of April, 2012, Thomas K. Atkinson, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Fairway Independent Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument Number 20120502000152220, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, NA "Transferee"), by instrument executed on May 9, 2014 and recorded on May 14, 2014 in Instrument 20140514000144850, in the aforesaid Probate Office; and
