ARTICLE ONE

The name of the Corporation is Restoration Life.

ARTICLE TWO

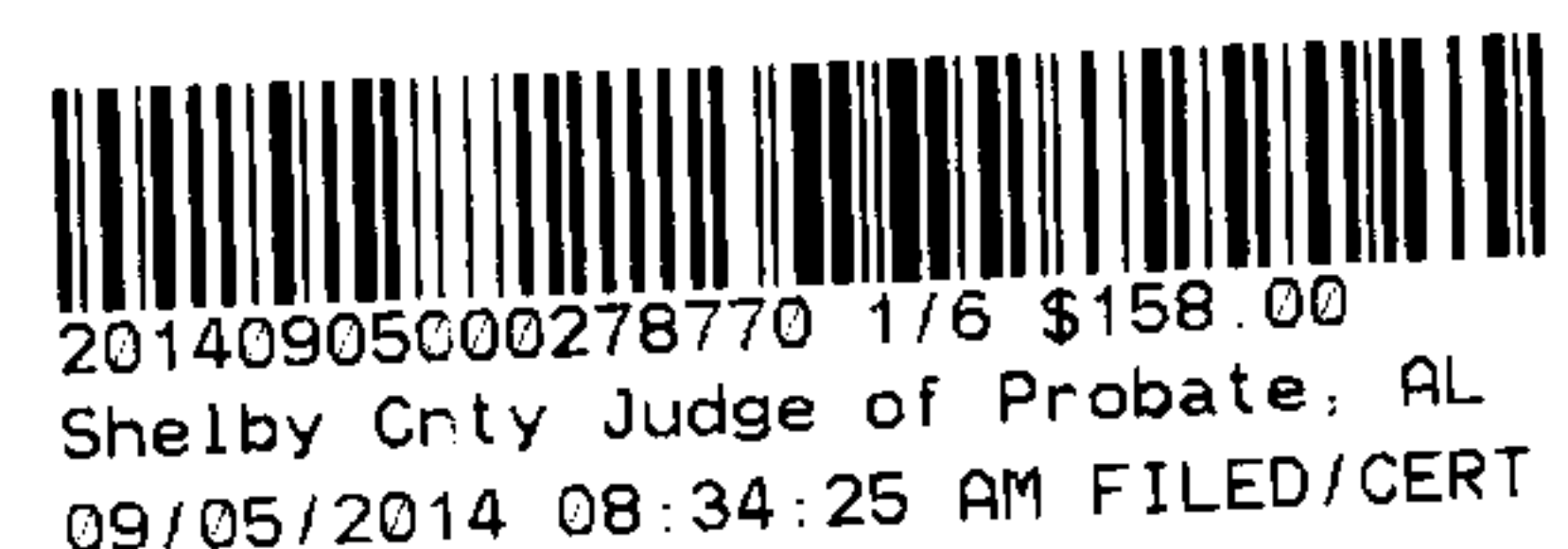
The term of existence of the Corporation is perpetual; and the corporate existence will commence on August 28th, 2014.

ARTICLE THREE

This nonprofit corporation has members.

ARTICLE FOUR

The corporation is organized in order to engage in any lawful purpose(s) not for pecuniary profit but specifically to engage our communities with the love of Jesus Christ, restoring, encouraging and assisting each other to fulfill God's purpose for our lives. The purposes include the transaction of any lawful business for which nonprofit corporations may be incorporated in Alabama under Title 10A, Chapter 3, Code of Alabama.

ARTICLE EIGHT

ELECTION OF DIRECTORS:

The Directors are not to be appointed by members of the Corporation and shall serve until the first annual meeting.

ARTICLE NINE

CHANGE IN THE NUMBER OF DIRECTORS:

A change in the number of Directors of the Corporation shall be made only by amendment to the By-Laws of the Corporation.

ARTICLE TEN

INTERNAL AFFAIRS:

The internal affairs of the Corporation shall be governed in accordance with the following provisions: The president shall preside at all membership meetings; by virtue of the office be chairperson of the Board of Directors; present at each annual meeting of the organization an annual report of the work of the organization; appoint all committees, temporary or permanent; see that all books, reports and certificates as required by law are properly kept or filed; be one of the officers who may sign the checks or drafts of the organization; and have such powers as may be reasonably construed as belonging to the chief executive of any organization.

The vice president shall, in the event of the absence or inability of the president to exercise his office, become acting president of the organization with all the rights, privileges

and powers as if he had been the duly elected president.

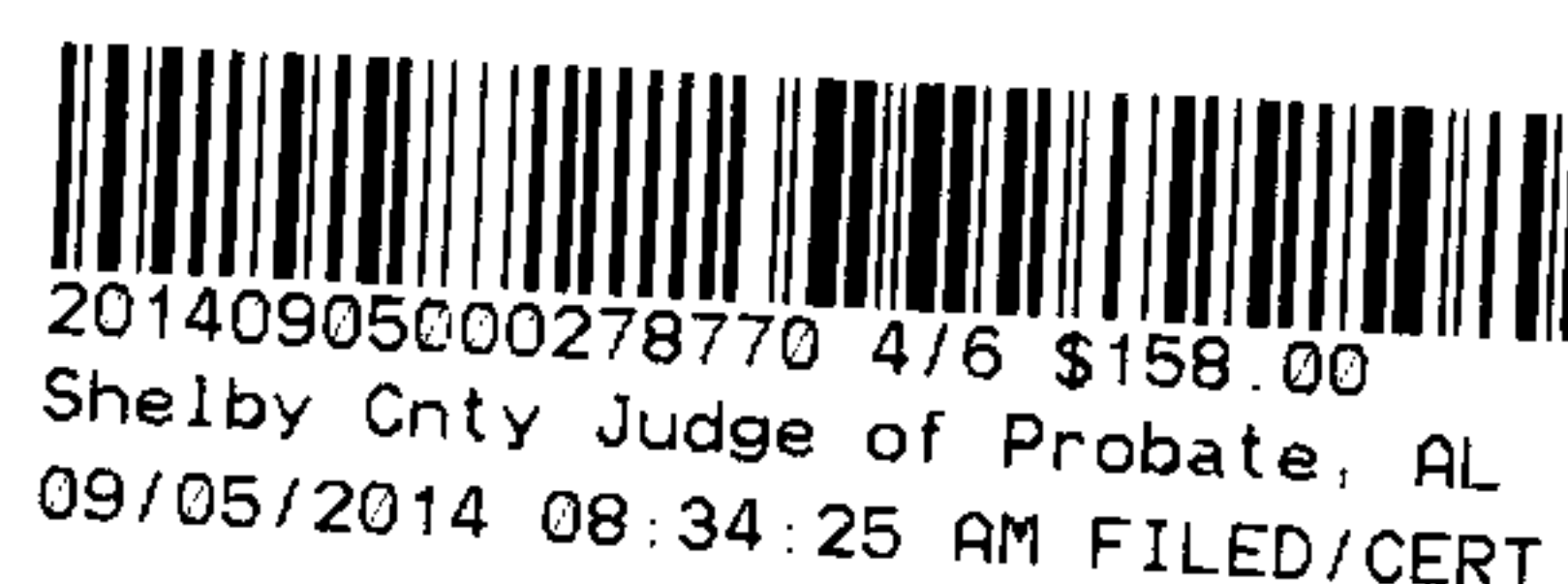
The secretary shall keep the minutes and records of the organization in appropriate books; file any certificate required by any statute, federal or state; give and serve all notices to members of the organization; be the official custodian of the records and seal of the organization; be one of the officers required to sign the checks and drafts of the organization; present to the membership at any meetings any communication addressed to the secretary of the organization; submit to the Board of Directors any communications which shall be addressed to the secretary of the organization; attend to all correspondence of the organization; and exercise all duties incident to the office of secretary.

The Treasurer shall have the care and custody of all monies belonging to the organization; be solely responsible for such monies or securities of the organization; and be one of the officers who shall sign checks or drafts of the organization. No special fund may be set aside that shall make it unnecessary for the Treasurer to sign the checks issued upon it.

The Treasurer shall render, at stated periods as the Board of Directors shall determine, a written account of the finances of the organization; and such report shall be physically affixed to the minutes of the Board of Directors of such meeting; and shall exercise all duties incident to the office of Treasurer.

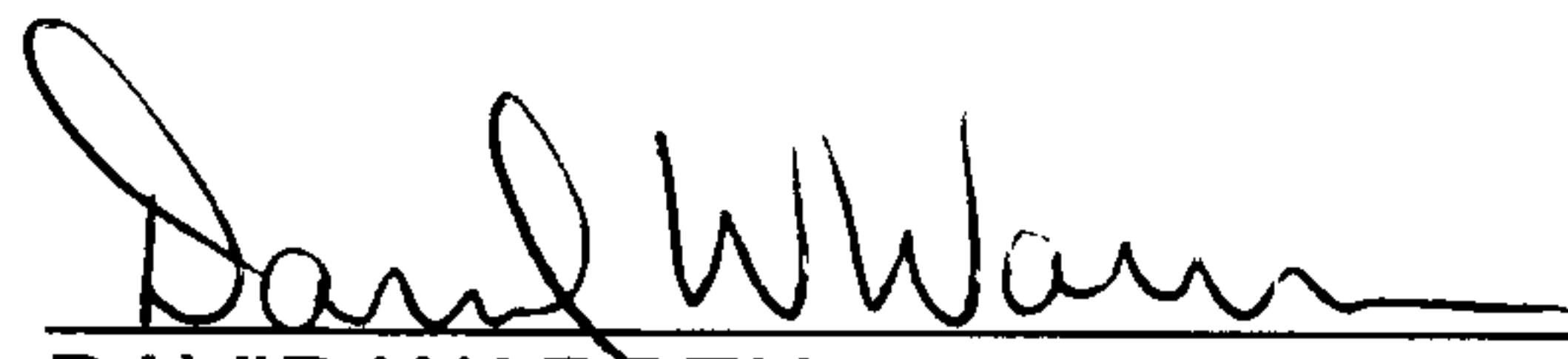
Officers shall by virtue of their office be members of the Board of Directors.

No officer or director shall for reason of the office be entitled to receive any salary or compensation, but nothing herein shall be construed to prevent an officer or director

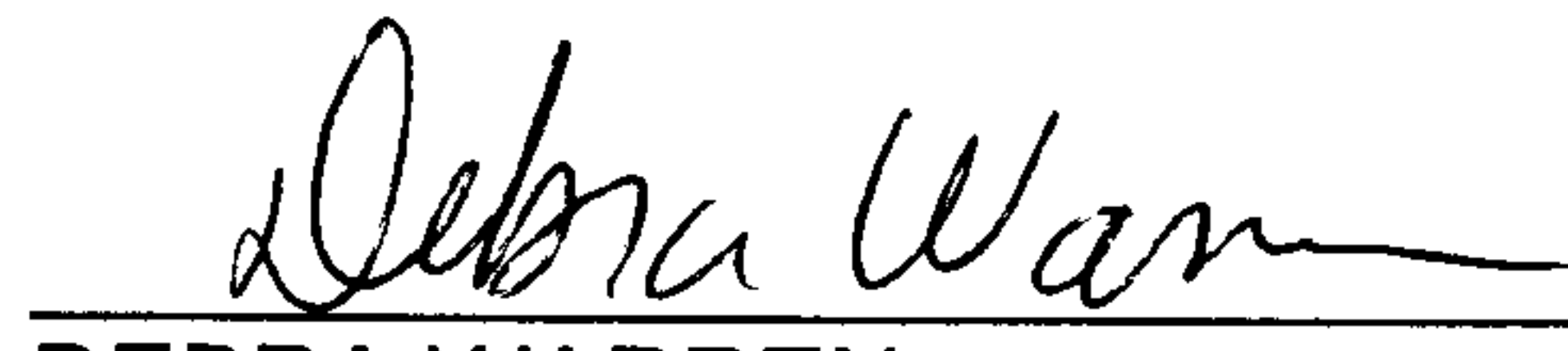


from receiving any compensation from the organization for duties other than as a director or officer.

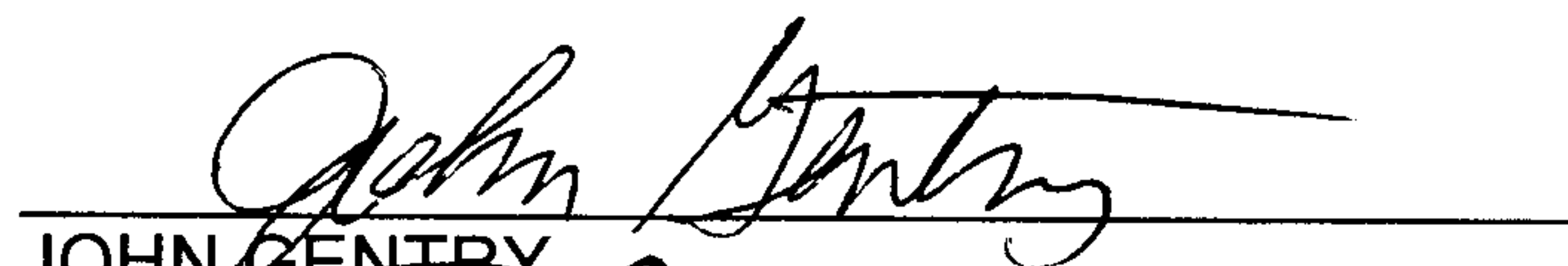

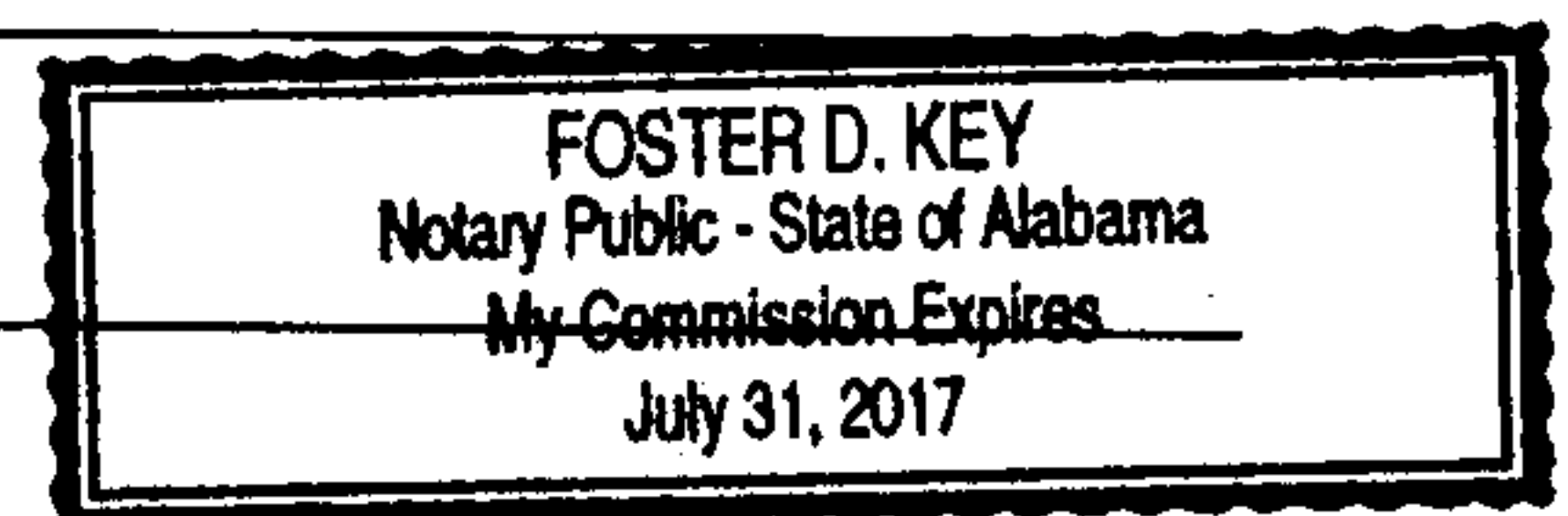

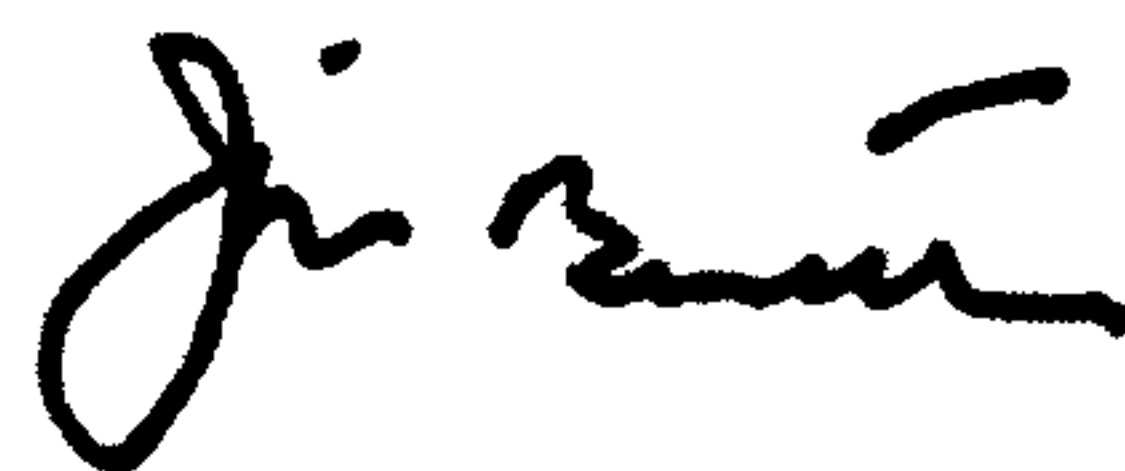
