



ARTICLES OF ORGANIZATION OF LAAB-769, LLC

THESE ARTICLES OF ORGANIZATION of *LAAB-769, LLC* are made and entered into on this the 5th day of September, 2014, by Abel Martinez, III (the "Member").

RECITALS

The member desires to enter into the business and has considered the various forms of entities to use for that purpose and has decided that a limited liability company to be formed under the Alabama Limited Liability Company Law is the preferred entity.

PERIOD OF DURATION


The Company shall exist in perpetuity unless dissolved pursuant to the Alabama Limited Liability Company Law (the "Law") or these Articles of Organization.

ARTICLE VIII

GOVERNANCE

Any Member may upon ten (10) days advance notice given to the other Member(s) call a meeting of the Members. Such notice shall state the date, time, place and purpose of the meeting. Those Members holding a majority of interests shall constitute a quorum for the conduct of business. Members not present in person at such meeting may grant a written proxy to any other person entitling such person to vote such Member's interest at the meeting. Any Member may waive notice of the meeting. Action of the Members may be adopted by written consent without meeting. Unless otherwise provided in these Articles of Organization, the vote of Members owning more than 51 percent (%) of the interests of the Company shall be controlling.

ARTCILE IX

MANAGEMENT

Management of the Company shall be vested in the Members.

ARTICLE X

DISTRIBUTIONS



ARTICLE XI

DISASSOCIATION: ASSIGNMENT

A Member shall have the right to disassociate voluntarily from the Company upon ninety (90) days written notice to the other Member(s). No Member shall have the right to assign all or any portion of his or her interest in the Company without the written consent of the other Members. If the other Members consent to the assignment of another Member's interest in the Company, then such other Member shall be free to assign his or her interest as set forth in the written consent. An assignee of a Member's interest only

entitles such person to the financial rights of the assignor Member to the extent assigned. As assignee of an interest in the Company may become a Member only if the other Members unanimously consent in writing. A Member who assigns all his or her interest in the Company does not cease to be a Member until the assignee of such interest is substituted as a Member by unanimous written consent of the other Members. A person ceases to be a Member of the Company upon the occurrence of the events specified in § 10A-5-6.06.

ARTICLE XII

LIQUIDATION

Upon dissolution of the Company, its affairs shall be wound up and its assets distributed in accordance with the Law, as amended.

ARTCILE XIII

OPERATING AGREEMENT

Members of the Company may enter into an operating agreement to regulate or establish the affairs of the Company, the conduct of its business, and the relations of its Members. Such operating agreement may contain any provisions regarding the affairs of the Company, the conduct of its business and the relation of its Members that are not inconsistent with laws of the State of Alabama or these Articles of Organization.

ARTICLE XIV

MISCELLANEOUS

- (1) The Company shall keep at its registered office the records required by § 10A-5-2.06 of the Law and such records shall be subject to inspection and copying at the reasonable request of a Member.
- (2) The laws of the State of Alabama shall govern the business of the Company and the relation of its Members.
- (3) Except as may be modified by an operating agreement, the Articles of Organization set forth herein constitute the entire understanding and agreement among the Members with respect to the subject matter hereof, and there are no other agreements.




