Lot 29, according to the Survey of Oakdale Estates, as recorded in Map Book 5, Page 98, in the Probate Office of Shelby County, Alabama.

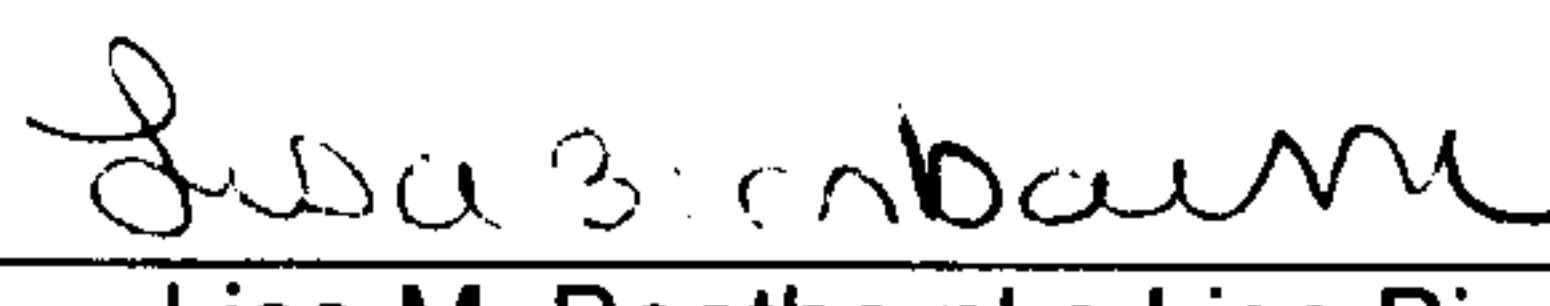
Subject to all rights of way, easements, covenants and restrictions of record.

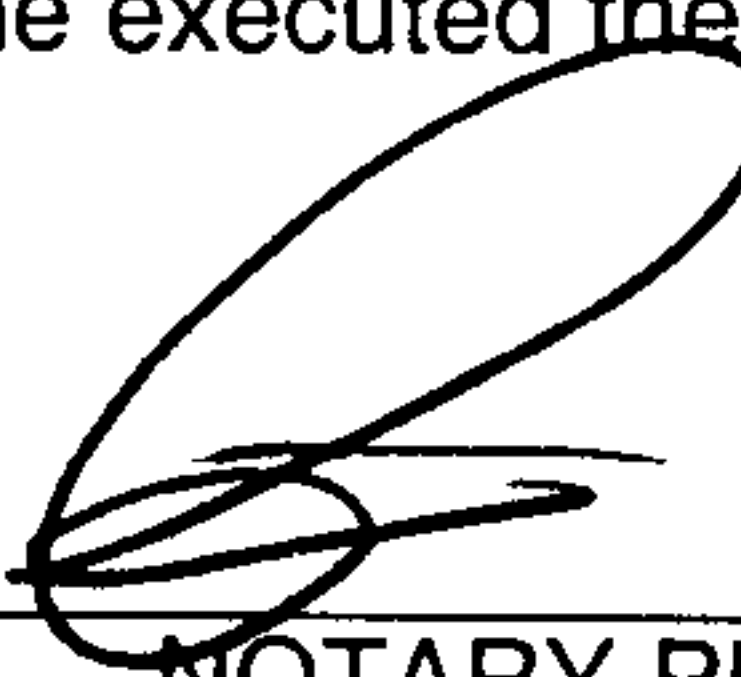

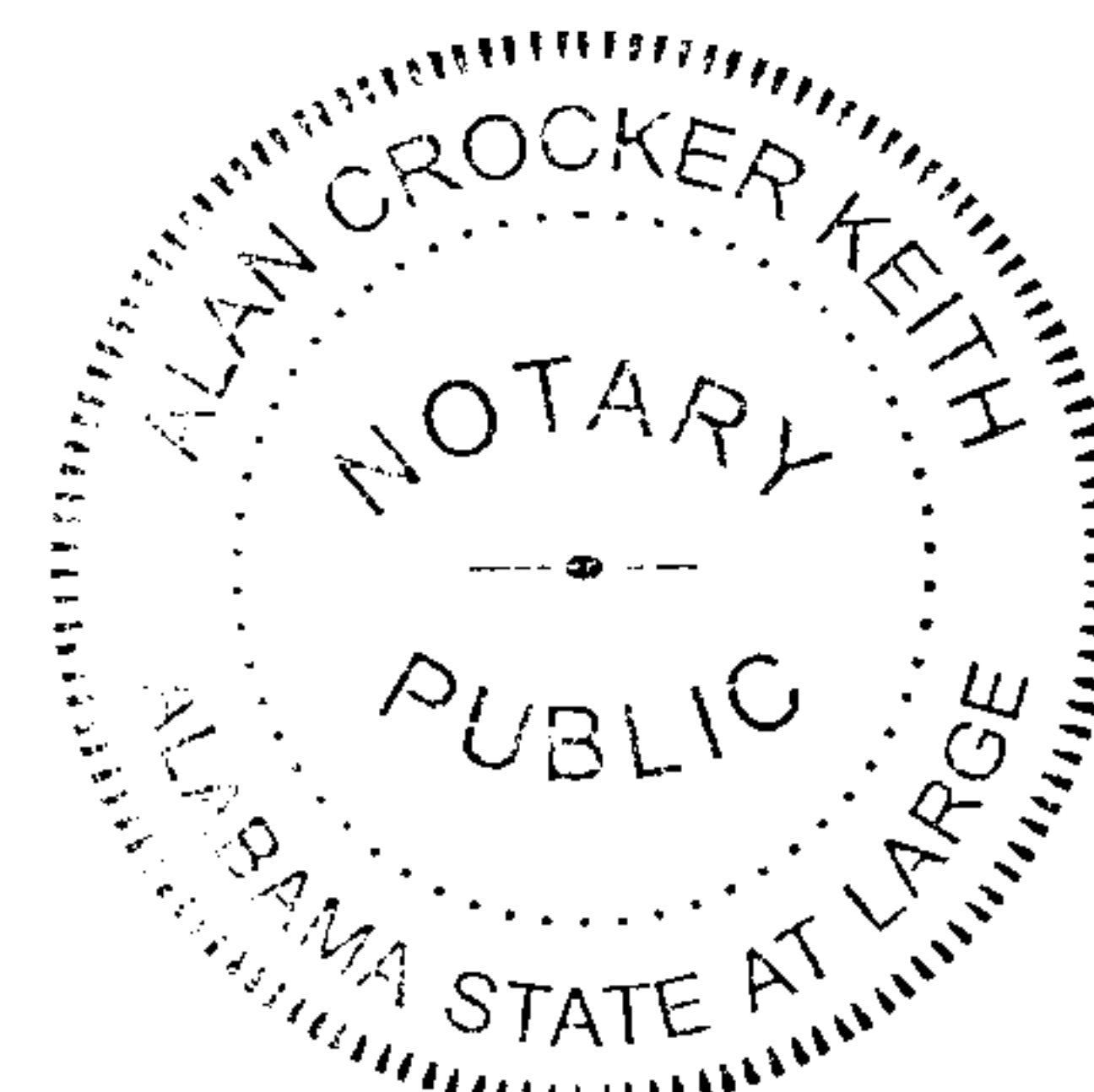
