

ARTICLES OF ORGANIZATION

Pursuant to the provisions of Title 10A-1-1.01, et seq., *Code of Alabama 1975* (the "Alabama Business and Nonprofit Entity Code") and Title 10A-5-1.01, et seq., *Code of Alabama 1975* (the "Alabama Limited Liability Law"), the undersigned hereby adopts the following Articles of Organization:

ARTICLE ONE

The name of Limited Liability Company is **FITNESS PRO'S LLC**.

ARTICLE TWO

A copy of the name reservation certificate from the Office of the Secretary of State is attached hereto and incorporated herein by reference.

ARTICLE THREE

The Limited Liability Company is organized for the following purposes:

- (a) To engage in the business of providing a venue for customers/clients to engage in exercise and fitness; and
- (b) To provide personal training of customers/clients in the art of exercise and fitness; and
- (c) To engage in any lawful activity in connection with the primary purpose(s) of the company.

ARTICLE FOUR

The period of duration of the company shall be perpetual unless and until it is dissolved in accordance with applicable law.

ARTICLE FIVE

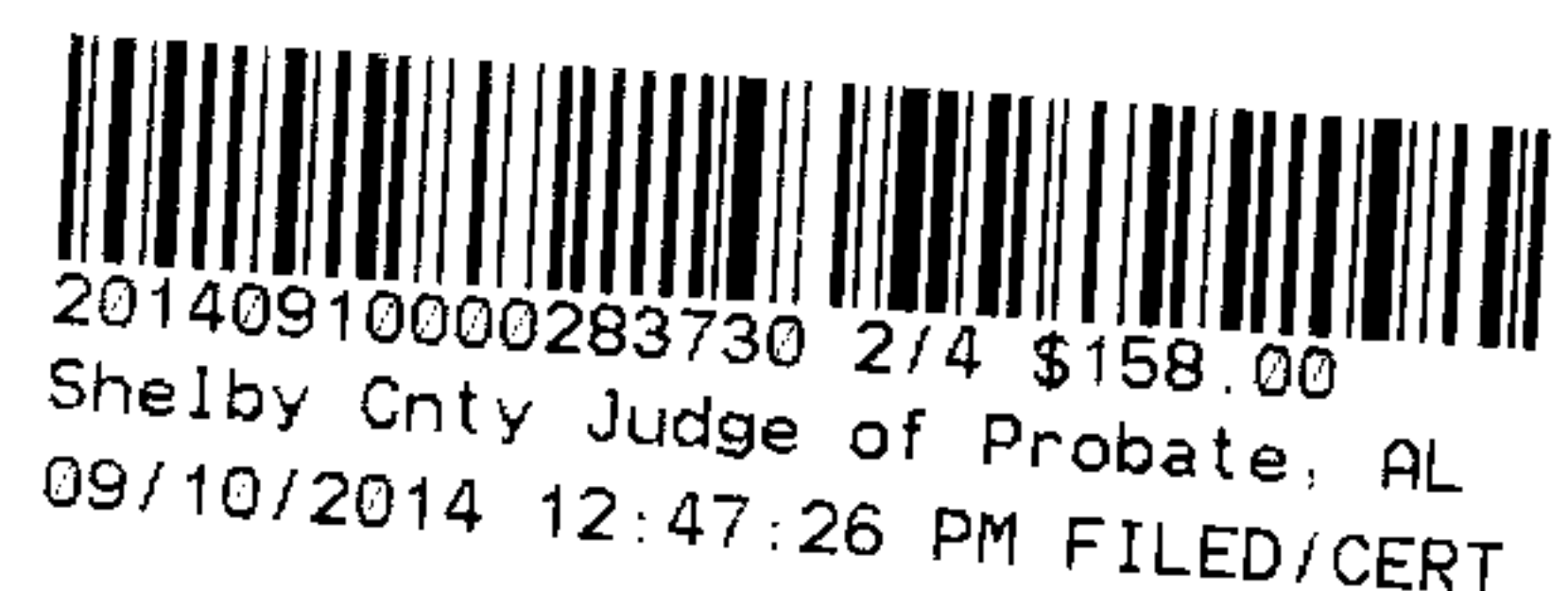

The remaining member or members of the Limited Liability Company shall have the right to continue business after the cessation of membership of any member of the Limited Liability Company.

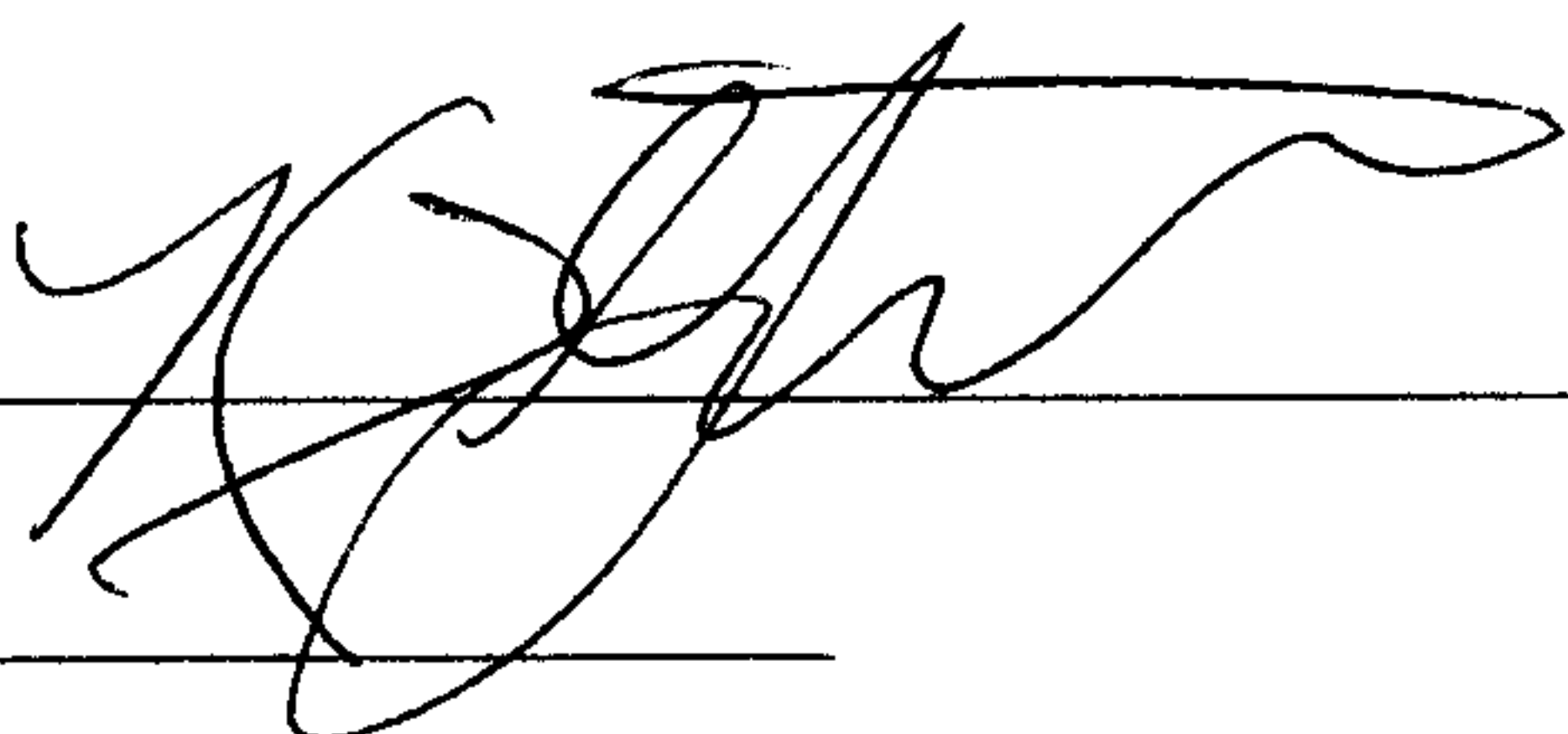

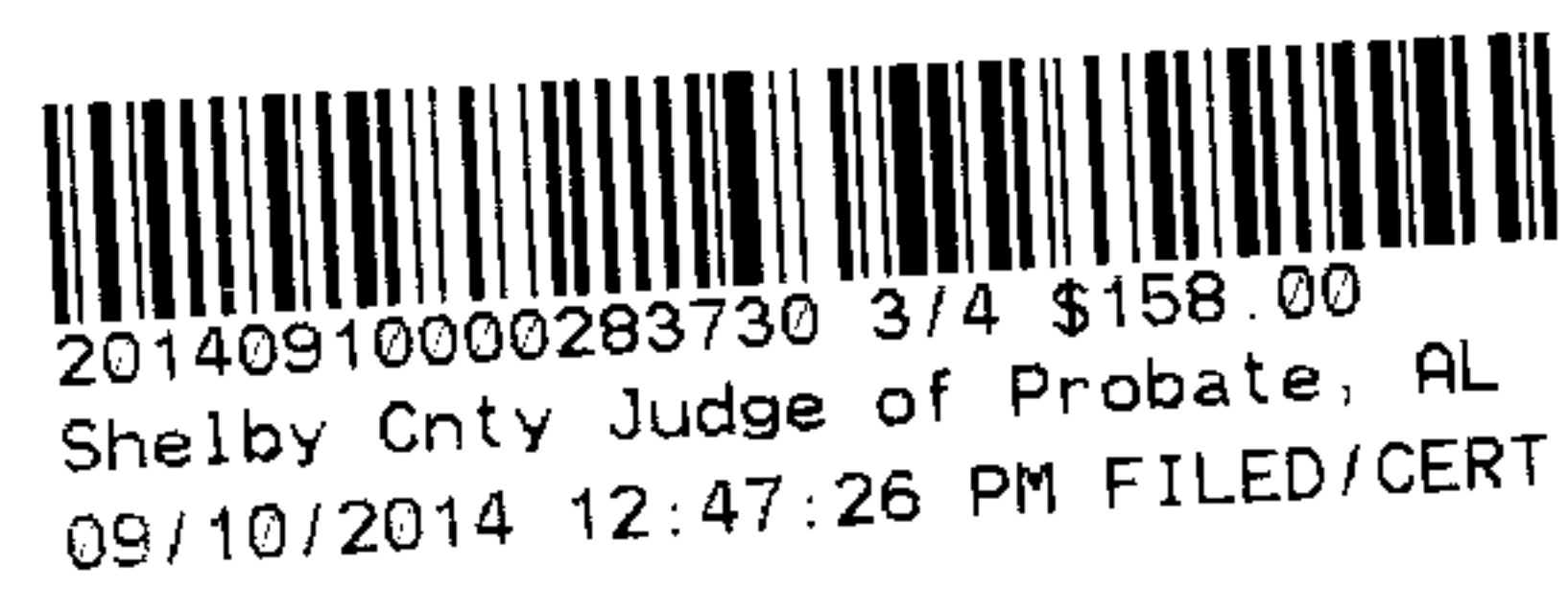

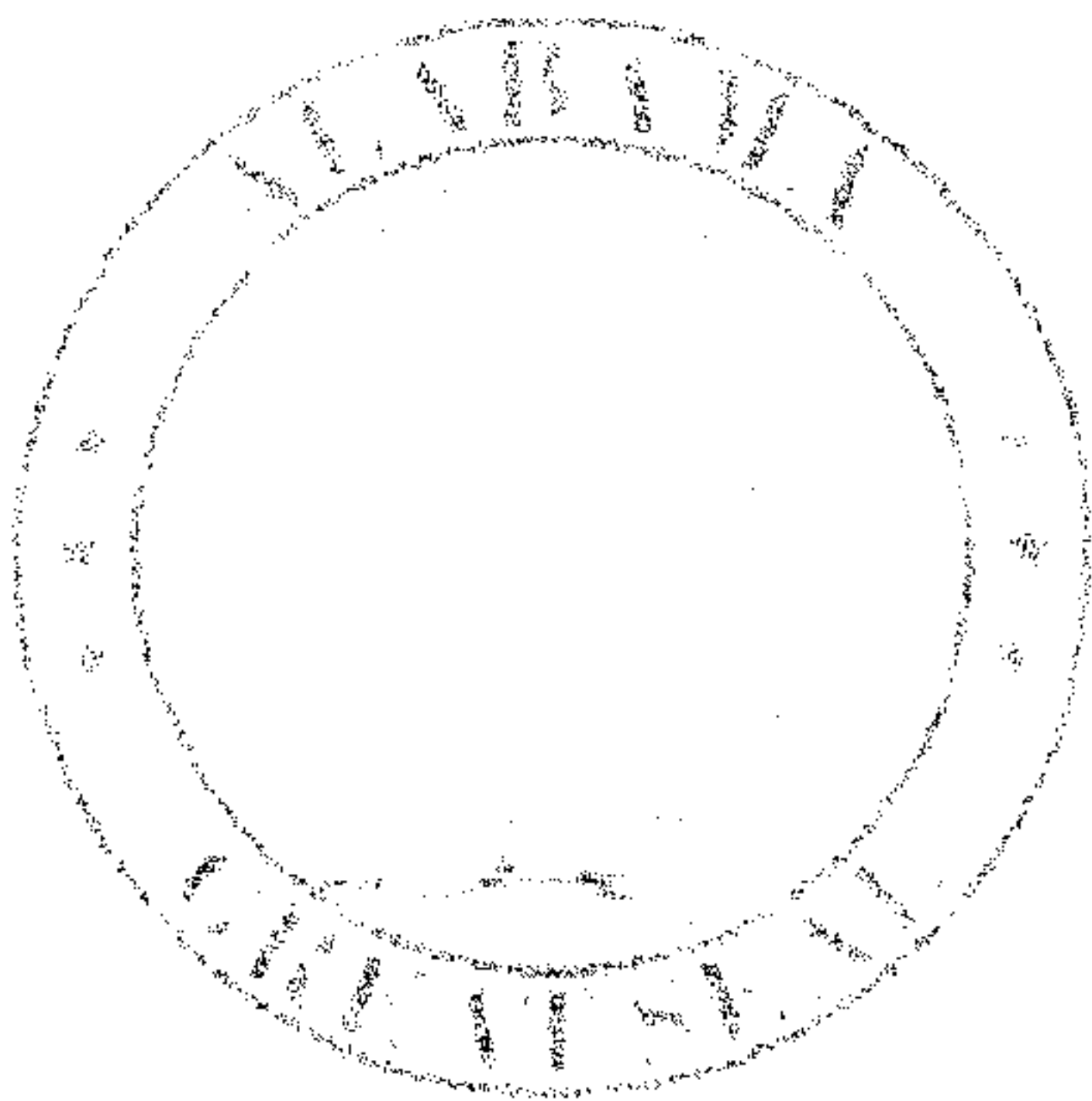
