

#### ARTICLES OF ORGANIZATION

Pursuant to the provisions of Title 10A-1-1.01, et seq., Code of Alabama 1975 (the "Alabama Business and Nonprofit Entity Code") and Title 10A-5-1.01, et seq., Code of Alabama 1975 (the "Alabama Limited Liability Law"), the undersigned hereby adopts the following Articles of Organization:

#### ARTICLE ONE

The name of Limited Liability Company is FITNESS PRO'S LLC.

#### ARTICLE TWO

A copy of the name reservation certificate from the Office of the Secretary of State is attached hereto and incorporated herein by reference.

## ARTICLE THREE

The Limited Liability Company is organized for the following purposes:


