KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Hundred Eighty-Three Thousand And No/100 Dollars (\$183,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Rodrigo Diaz and Erika Diaz**, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **David Colby Hill and Kelli Hill** (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.
