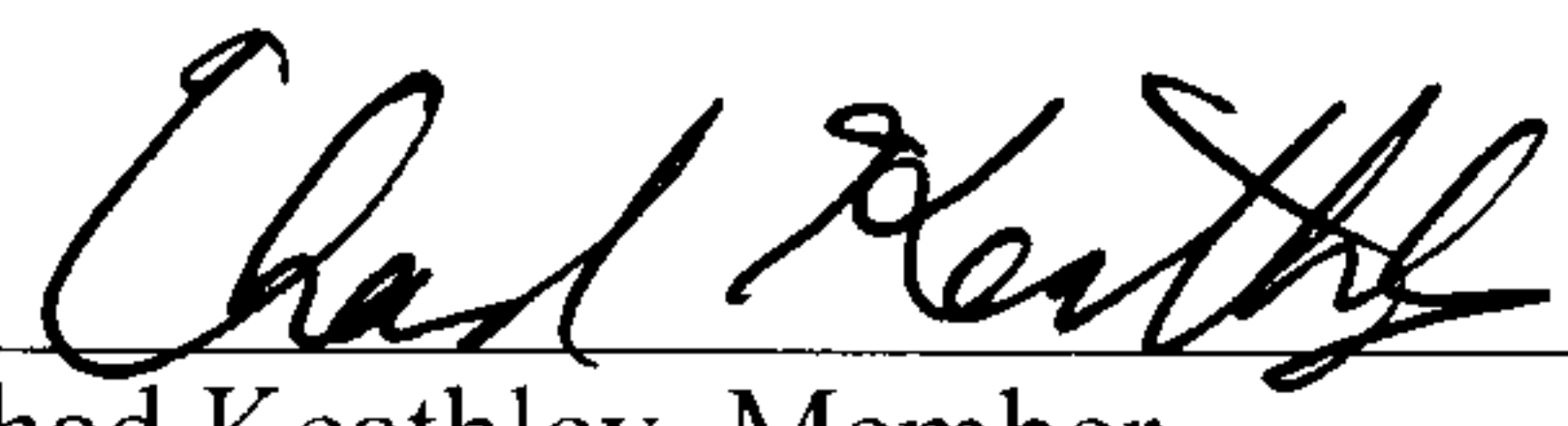
CERTIFICATE OF FORMATION OF RELIANT MEDIA, LLC.

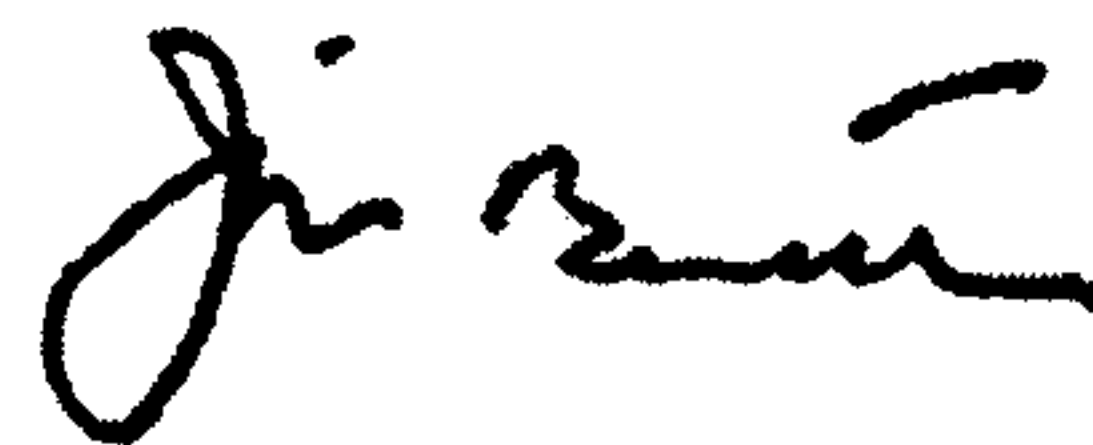
