KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 17th day of October, 2005, Tonya Gluth, a single woman and Herbert W. 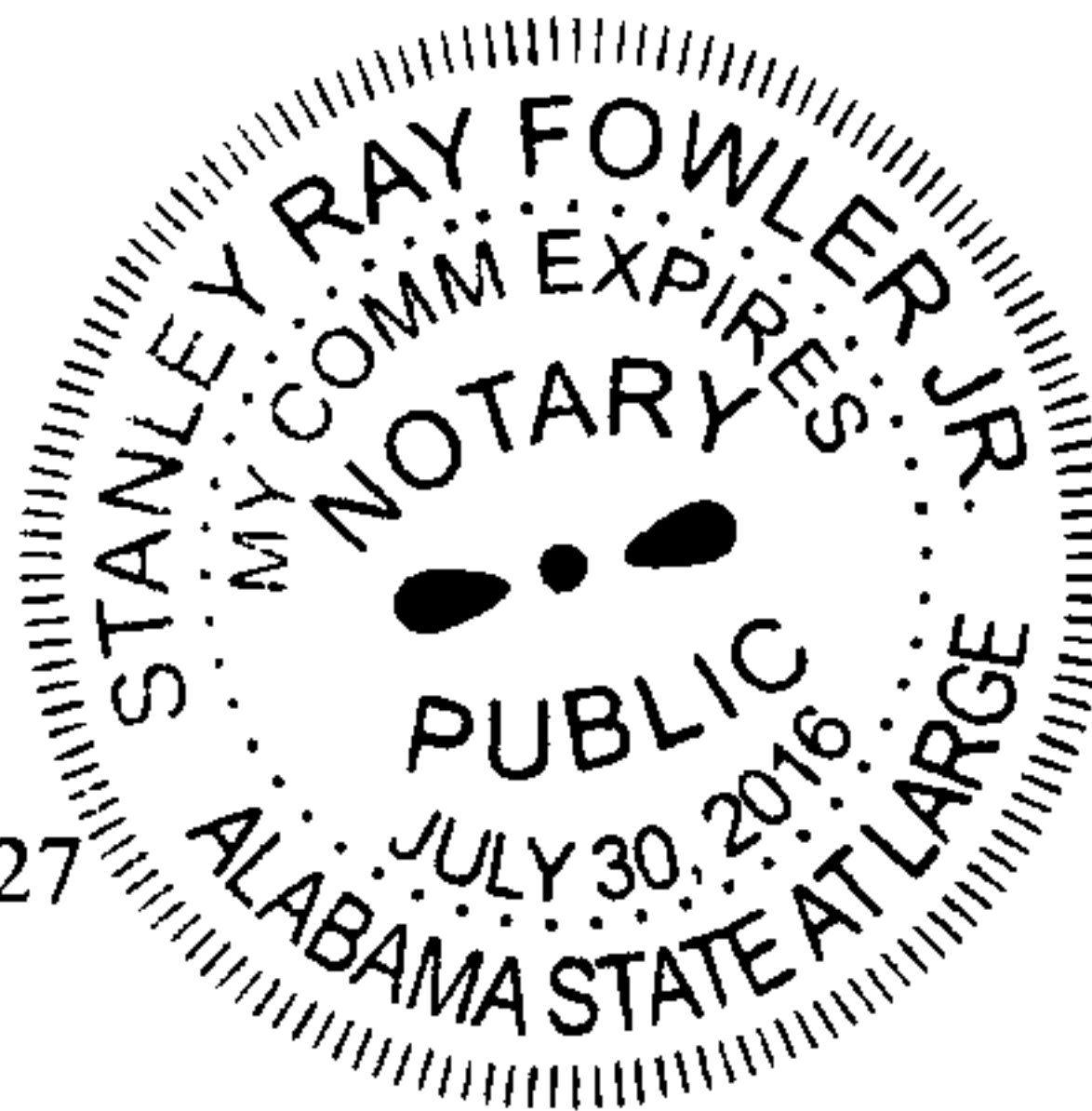
