**LIMITED POWER OF ATTORNEY**

US Bank National Association, a national banking association organized and existing under the laws of the United States of America, 180 East Fifth Street, Corporate Trust, 2<sup>nd</sup> Floor, St. Paul, MN 55101 hereby constitutes and appoints CitiMortgage Inc., and in its name, aforesaid Attorney-In-Fact, by and through any officers appointed by the Board of Directors of CitiMortgage, Inc. to execute and acknowledge in writing or by facsimile stamp all documents customarily and reasonably necessary and appropriate for the task described in items (1) through (4) below; provided however, that the documents described below may only be executed and delivered by such Attorneys-In-Fact if such documents are required or permitted under the terms of the related servicing agreements and no power is granted hereunder to take any action that would be adverse to the interests of the Trustee or the Holders. This Power of Attorney is being issued in connection with CitiMortgage, Inc.'s responsibilities to service certain mortgage loans (the "Loans") held by US Bank National Association in its capacity as Trustee. 4. Endorse on behalf of the undersigned all checks, drafts and/or other negotiable instruments made payable to the undersigned.
