

ARTICLES OF INCORPORATION OF ACANTHUS GROUP, INC.

- 1. The name of the entity being formed is Acanthus Group, Inc., hereinafter referred to as the "Company."
 - 2. The type of entity being formed is a corporation.
- 3. The purpose for which the Company is being formed is the transaction of any lawful business for which corporations may be incorporated under the Alabama Business Corporation Law, as amended, including, without limitation, any and all business activities which are related to owning and operating a public relations business.
- 4. The street address and mailing address of the initial registered office of the Company is 4000 Eagle Point Corporate Drive STE 500, Birmingham, Alabama 35242, Shelby County. The name of its initial registered agent at that address is Northwest Registered Agent Service, Inc.
- 5. The name and address of the organizer of the Company is Matthew I. Goforth, 2700 Highway 280 South, Birmingham, AL 35223.
- 6. The number of shares of capital stock the Company is authorized to issue is 10,000 shares of common stock, par value \$0.01 per share.
- 7. The name and address of the initial director of the Company is Rick Journey, PO Box 190268, Birmingham, AL 35219.
- 8. No holder of any share or shares of any class of stock of the Company shall have any preemptive right to purchase or subscribe for shares of any class of capital stock of the Company now or hereafter authorized, including treasury shares, or for any securities convertible into or carrying any optional rights to purchase or subscribe for any shares of any class of capital stock of the Company now or hereafter authorized.
- 9. The number of directors of the Company shall be one or more, as specified in or fixed in accordance with the bylaws of the Company. The bylaws may establish a variable range for the size of the board of directors of the Company by fixing a minimum and a maximum

number of directors. The number of directors may be fixed or changed from time to time, within the minimum and maximum, by the board of directors.

10. No director shall have any liability to the Company or its shareholders for money damages for any action taken, or any failure to take any action, as a director, except liability for (A) the amount of a financial benefit received by a director to which he or she is not entitled; (B) an intentional infliction of harm on the Company or the shareholders; (C) a violation of Section 10A-2-8.33 of the Alabama Business Corporation Law, as amended; (D) an intentional violation of criminal law; or (E) a breach of the director's duty of loyalty to the Company or its shareholders.


