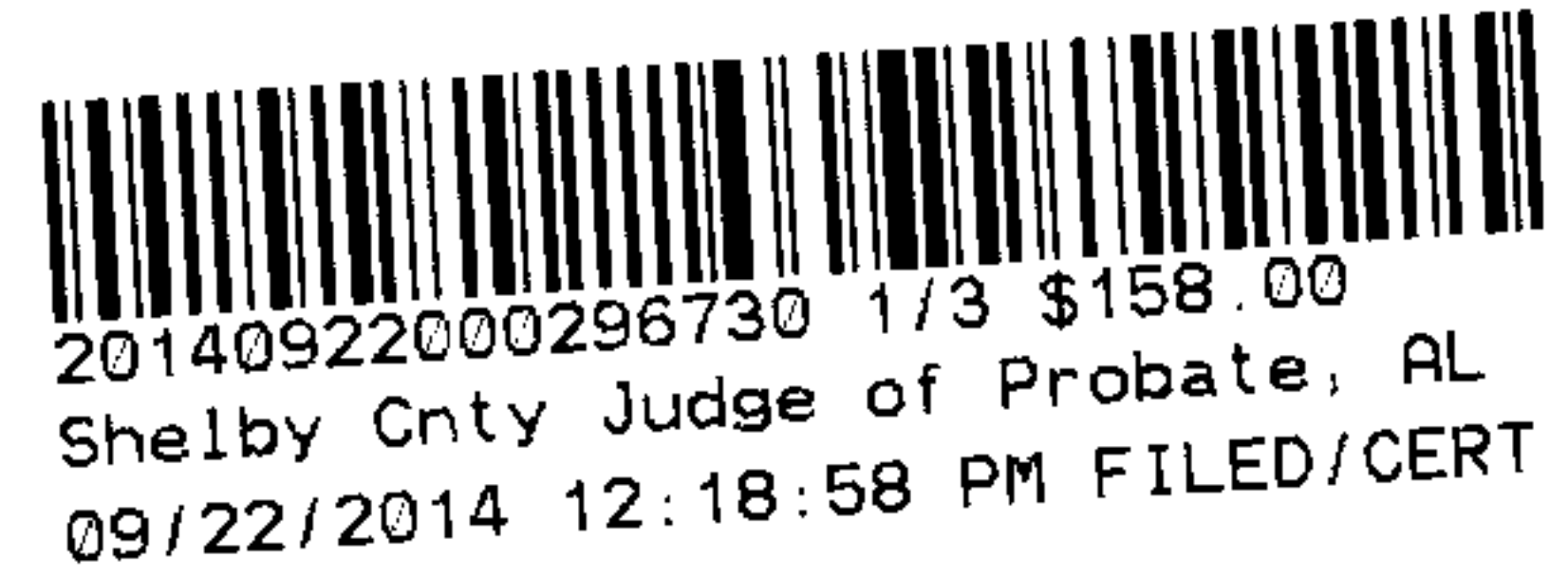

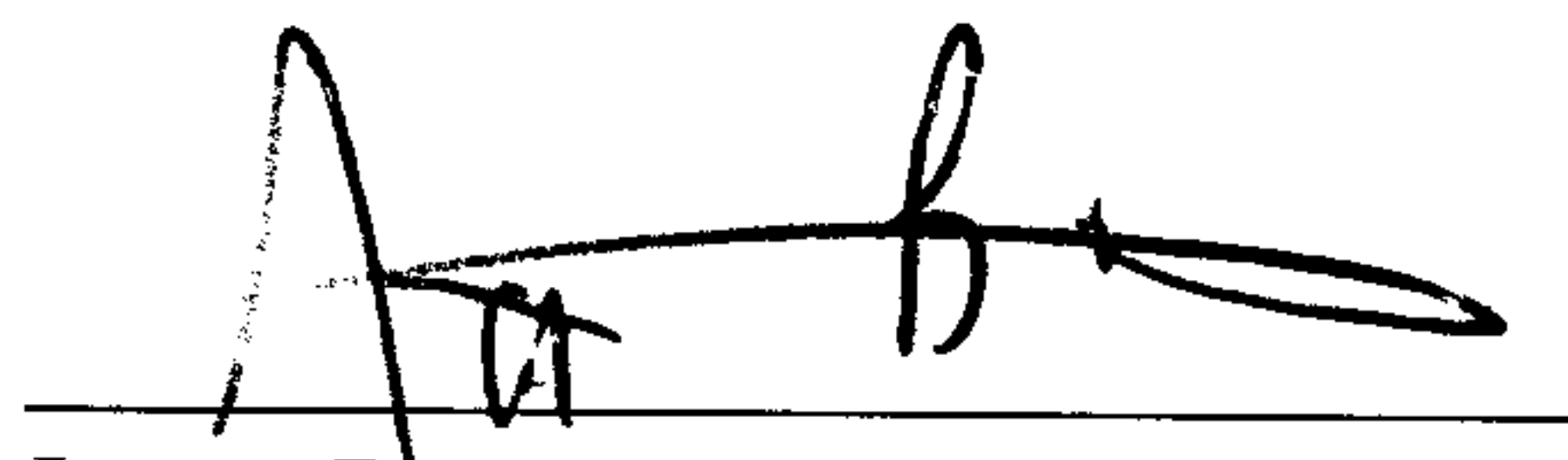
(I) Unanimously consent to the immediate dissolution of Black Widow Chimney Services, LLC
