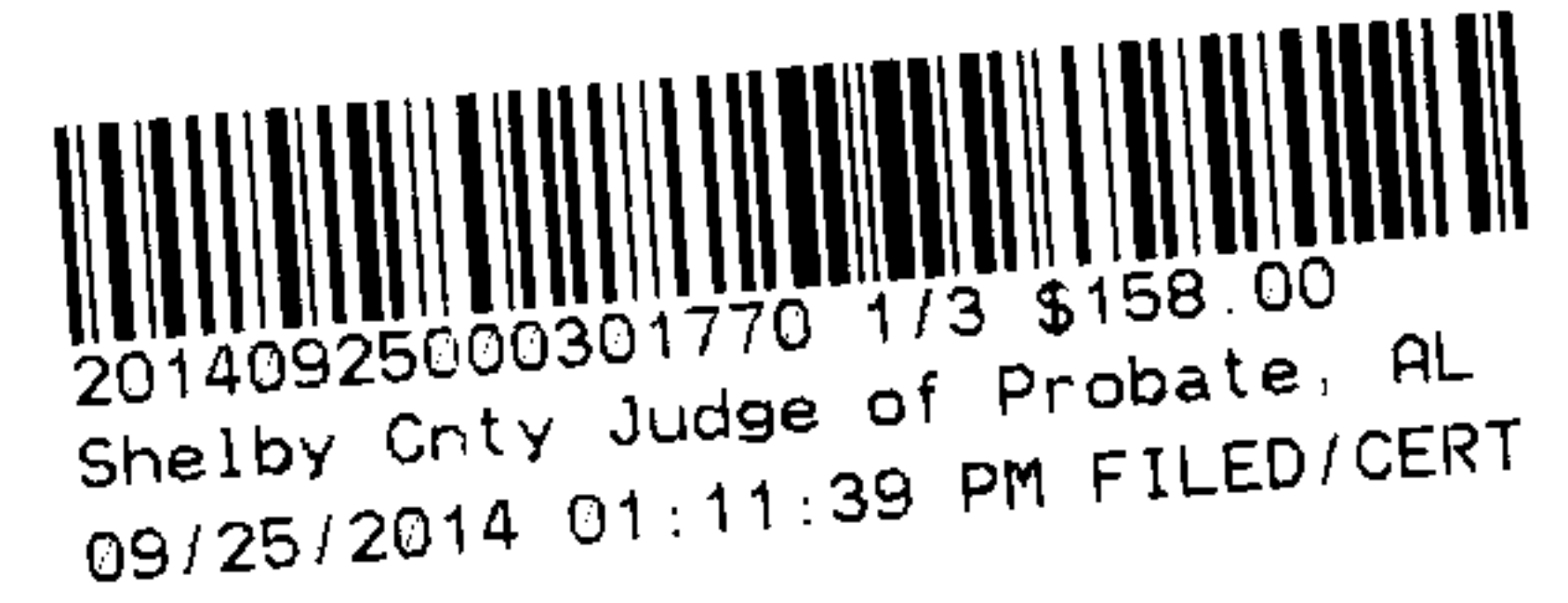

**ARTICLES OF ORGANIZATION
OF
Round Too Investments, LLC**



The undersigned organizer, desiring to form a limited liability company pursuant to the laws of the State of Alabama, hereby certifies as follows:

1. **Name.** The name of the entity is Round Too Investments, LLC.
2. **Type of Entity.** The type of entity being formed is a limited liability company.
3. **Purpose.** The purpose for which this limited liability company is organized is to engage in the transaction of any and all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.
4. **Duration.** The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Law.
5. **Registered Agent and Registered Office.** The location and mailing address of the initial registered office shall be 120 Bishop Circle, Pelham, Alabama 35124, and the name of the initial registered agent at said address shall be Connor Farmer.
6. **Initial Member.** The name of the initial member of the limited liability company is Old Cahaba Land Holdings, LLC, and the address of the initial member is 120 Bishop Circle, Pelham, Alabama 35124.
7. **Initial Manager.** The limited liability company shall be managed by a manager who shall serve as manager until a successor is elected and qualified. The name of the initial manager is Connor Farmer, and the address of the initial manager is 120 Bishop Circle, Pelham, Alabama 35124.
