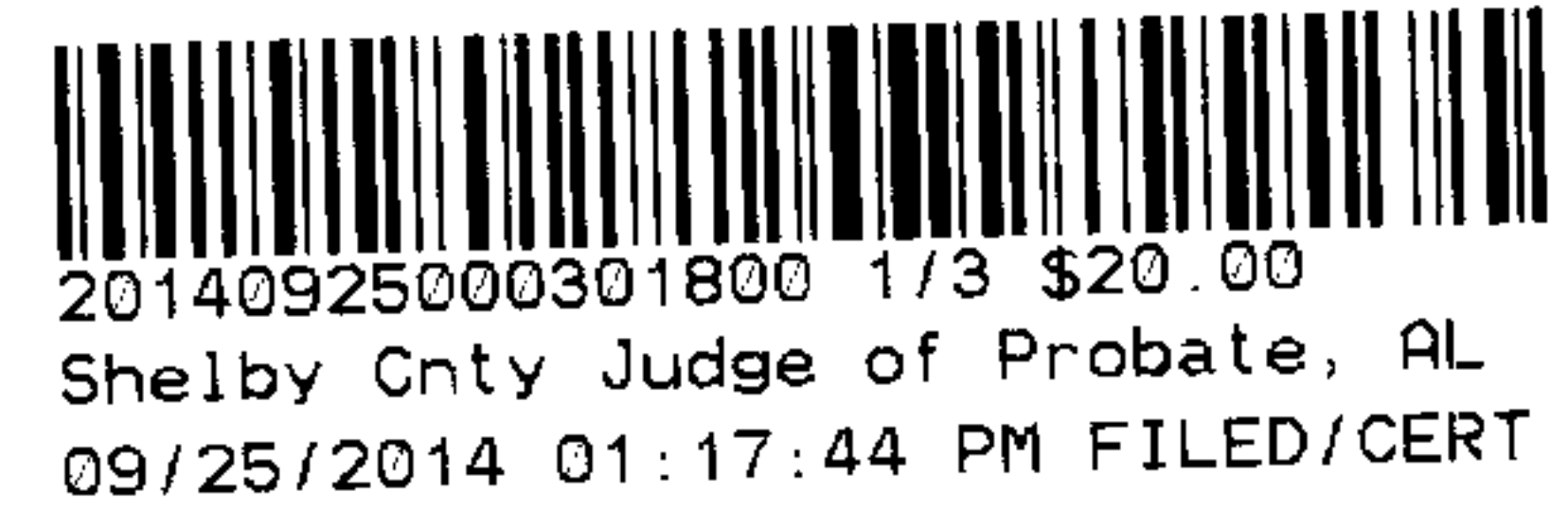

DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That I, **Dorothy H. King**, residing in Shelby County, Alabama, being over nineteen (19) years of age, do hereby appoint my daughters, **Joan K. Posey, Ann King, and Mary Jane Allen**, who reside in Birmingham, Alabama, as my true and lawful attorneys and authorize and empower them for me and in my name to:

(1) Ask, demand, sue for, collect, recover and receive all sums of money, debts, accounts, interest, dividends, annuities, and demands whatsoever as are now or shall hereafter become due, owing, payable, or belonging to me.

(2) Make, do and transact all and every kind of business of whatsoever nature she considers necessary; to draw checks on my bank account or accounts and make deposits therein and perform any and all other banking functions that I might or could do if personally present.

(3) Make, seal, and deliver; to bargain, contract, agree for, buy, sell, mortgage, hypothecate, and in any way and every way and manner, deal in and with goods and personal property, and real property, in possession or in action, and to release mortgages on lands or chattels as fully to all intents and purposes as I might or could do if personally present.

(4) Bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments and accept, seize and take possession of all lands; and deed, lease, bargain, sell (release and satisfy mortgages) release, convey, mortgage, and hypothecate lands,

tenements, and hereditaments, upon such terms and conditions, and under such covenants, as she shall deem advisable.

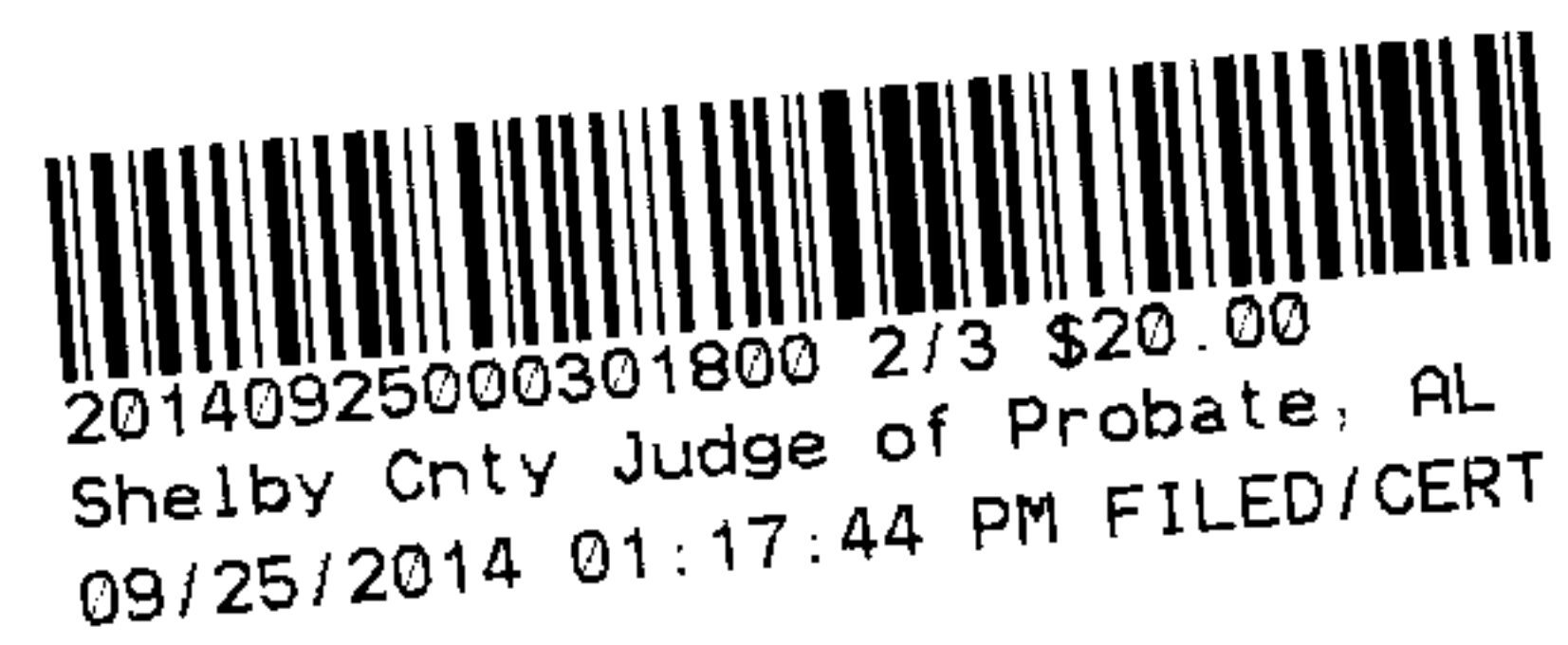
(5) Giving and granting unto **Joan K. Posey, Ann King, and Mary Jane Allen** as my true and lawful attorneys, full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done and about the premises (including, but not limited to, the specific powers granted herein) as fully to all intents and purposes as I might or could do if personally present.

(6) Giving and granting unto **Joan K. Posey, Ann King, and Mary Jane Allen** as my true and lawful attorneys, full power and authority to manage all of my health care needs; consult with all of my health care professionals and to make decisions regarding all matters having to do with health care including following any and all advance directives that I have or may enter into regarding the final stages of my life.

(7) I hereby ratify and confirm all that **Joan K. Posey, Ann King, and Mary Jane Allen**, as my true and lawful attorneys, shall lawfully do or cause to be done by virtue of these presents.

(8) I hereby grant this Power of Attorney to all three of my daughters equally and in the event it is necessary for my daughters to make decisions about any of my needs as set out in the Power of Attorney if they cannot agree then a two-thirds vote shall be considered my act and I ratify, confirm and approve a two-thirds majority vote concerning all issues in the Power of Attorney.

(9) I hereby ratify and confirm whatsoever my said attorney shall do or cause to be done in the premises. This power of attorney shall not be affected by my disability, my



incompetancy, or incapacity of the principal and is prepared pursuant to §26-1-2 of the Code of Alabama, 1975, as amended.
