ARTICLES OF ORGANIZATION

OF

rtmercer properties LLC

Pursuant to the provisions of Sections 10A-5-1.01, et seq. of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is rtmercer properties, LLC (the "Company").

ARTICLE II

Duration

The Company shall have the perpetual duration unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Law (the "Law") or the Company Operating Agreement.

ARTICLE III

<u>Purposes</u>

- (a) To invest in, acquire, hold, maintain, operate, own, lease, improve, sell, exchange, develop and otherwise use interests in real and personal property, whether tangible or intangible, for profit, and to engage in any and all activities related to or incidental thereto;
- (b) To Law as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction;
- (c) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property, whether tangible or intangible, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, whether tangible or intangible, or any interest therein;

- (d) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;
- (e) To lend money, invest and reinvest its funds and take and hold real and personal property, whether tangible or intangible, as security for the payment of funds so loaned or invested; and
- (f) To engage in any other lawful Law or activity for which limited liability companies may be organized pursuant to the Law.

ARTICLE IV

Registered Office; Registered Agent

The location and street address of the initial registered office of the Company shall be 191 Chase Drive, Pelham, Alabama 35124, and its registered agent at such address shall be Tracey L. Mercer.

The cessation of membership of one (1) or more member will not result in the dissolution of the Company.

Managers

The managers of the Company shall have the power to manage the business and affairs of the Company as provided in the Operating Agreement. 
