

To Have And To Hold to the said grantees, his, her or their heirs and assigns forever.



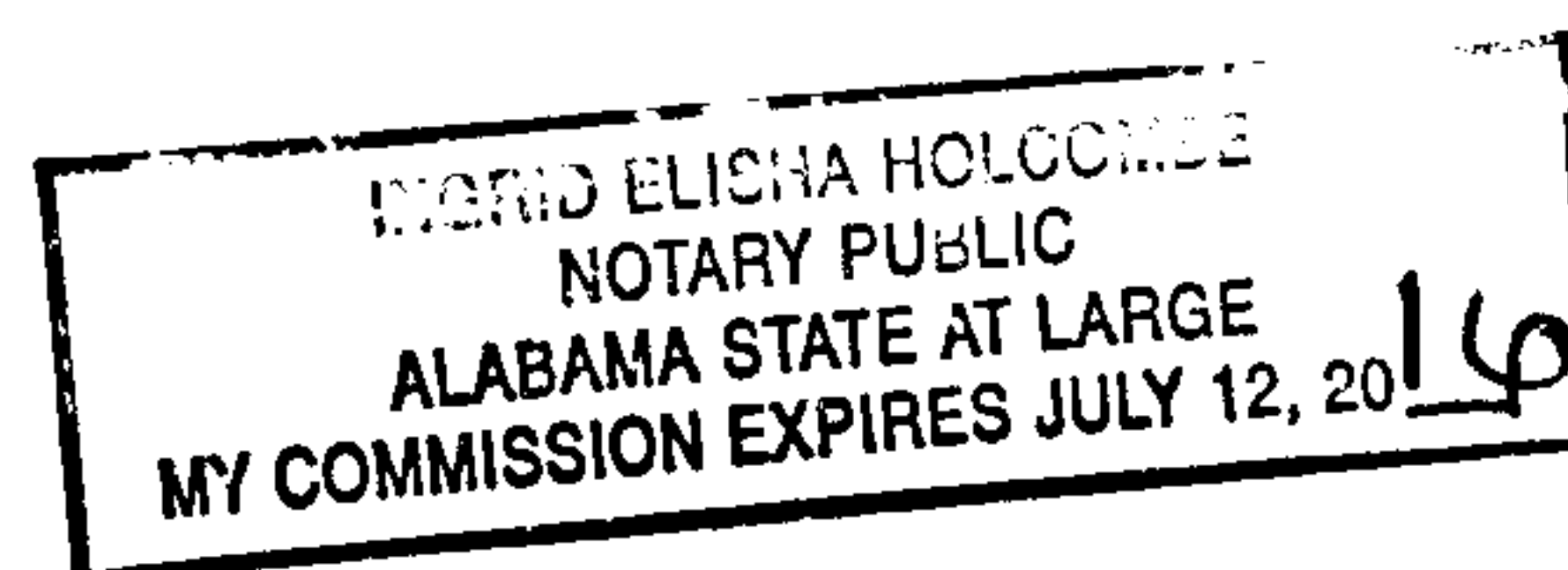
