TO HAVE AND TO HOLD, unto the said grantee and his heirs, successors and assigns forever.





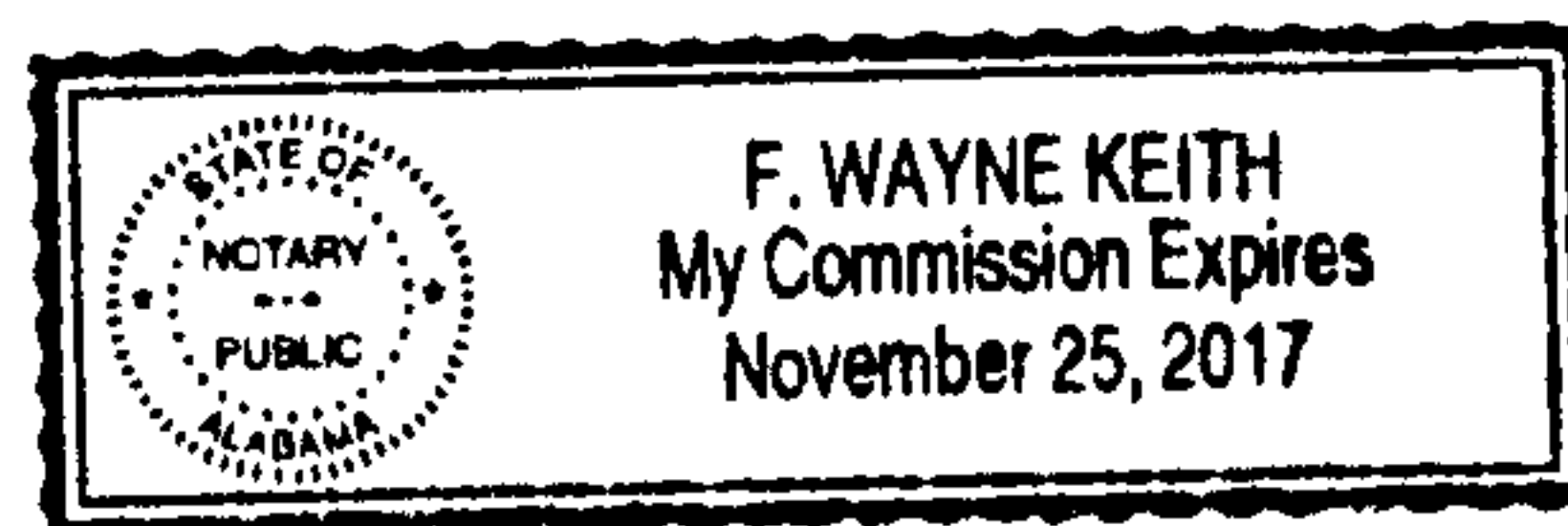
