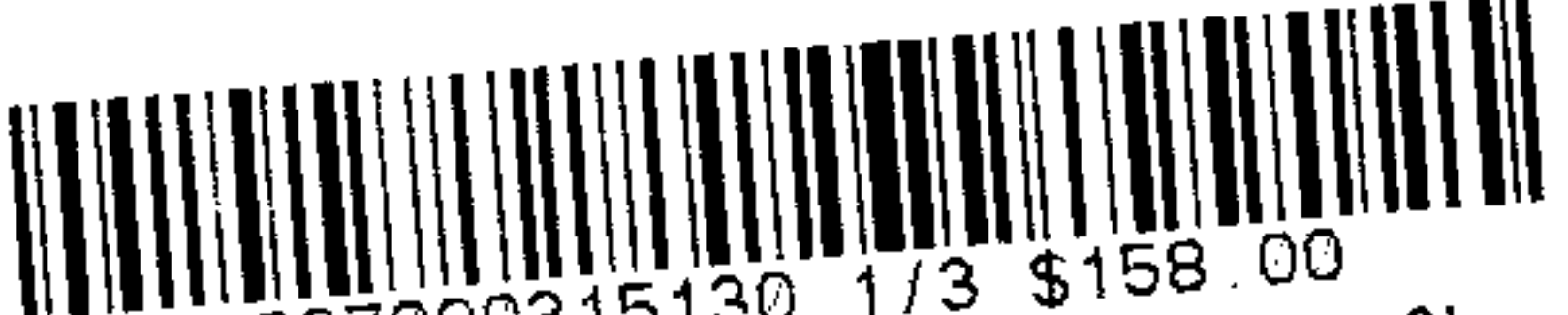

**Articles of Organization
Tuscaloosa Remodeling, LLC**

The undersigned, pursuant to the provisions of the Alabama Limited Liability Company Act, Section 10A-5-1.01, et.seq., CODE OF ALABAMA, (1975), as amended from time to time (the "Act"), hereby adopts the following Articles of Organization:

ARTICLE I

Name

The name of the limited liability company is "Tuscaloosa Remodeling, LLC" (the "Company").

ARTICLE II

Period of Duration

The period of duration of the Company shall be perpetual, unless dissolved in accordance with the provisions of the Company's Operating Agreement.

ARTICLE III

Purpose

The Company has been organized to provide remodeling services and to engage in any lawful business.

ARTICLE IV

Initial Registered Office and Agent

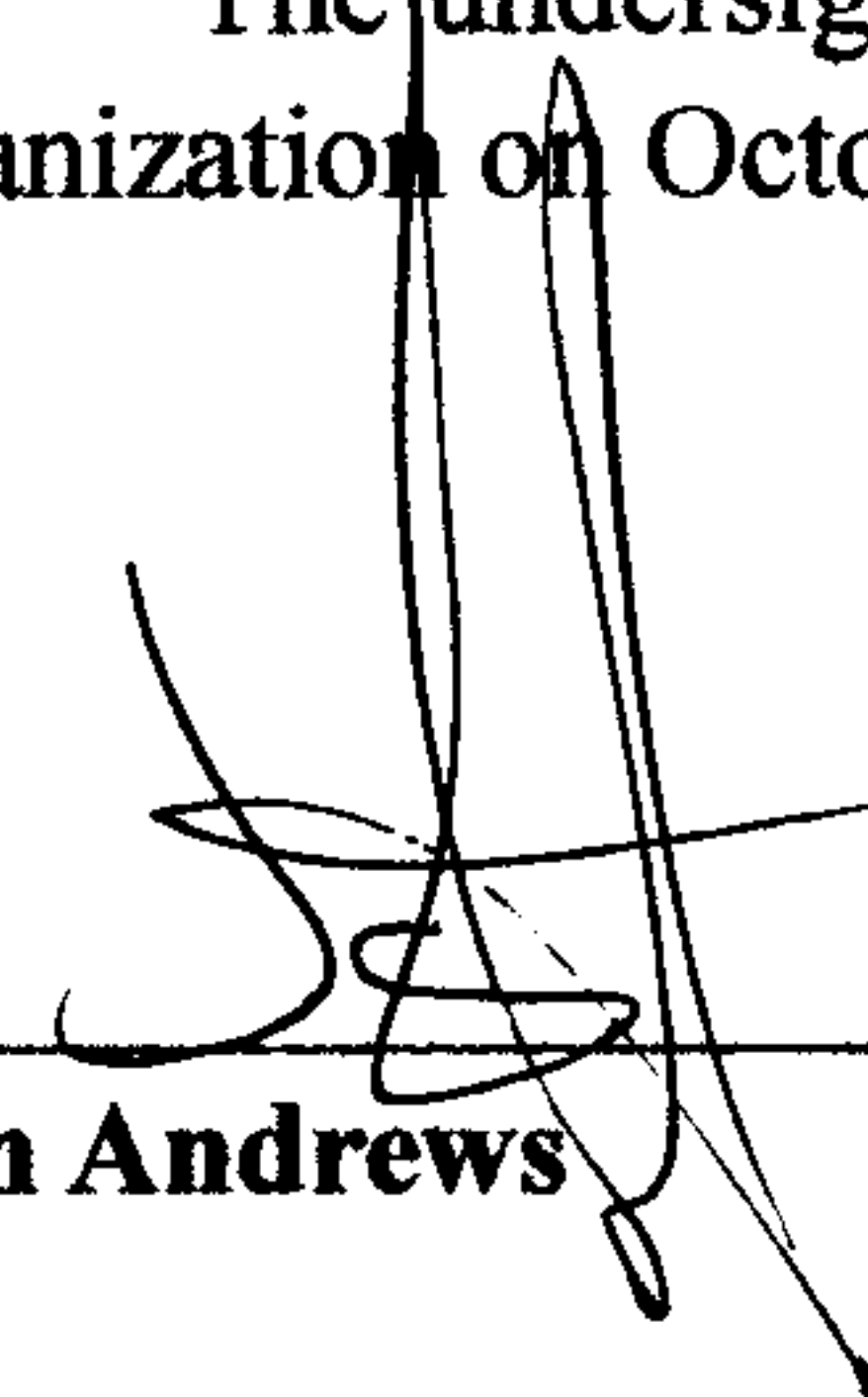

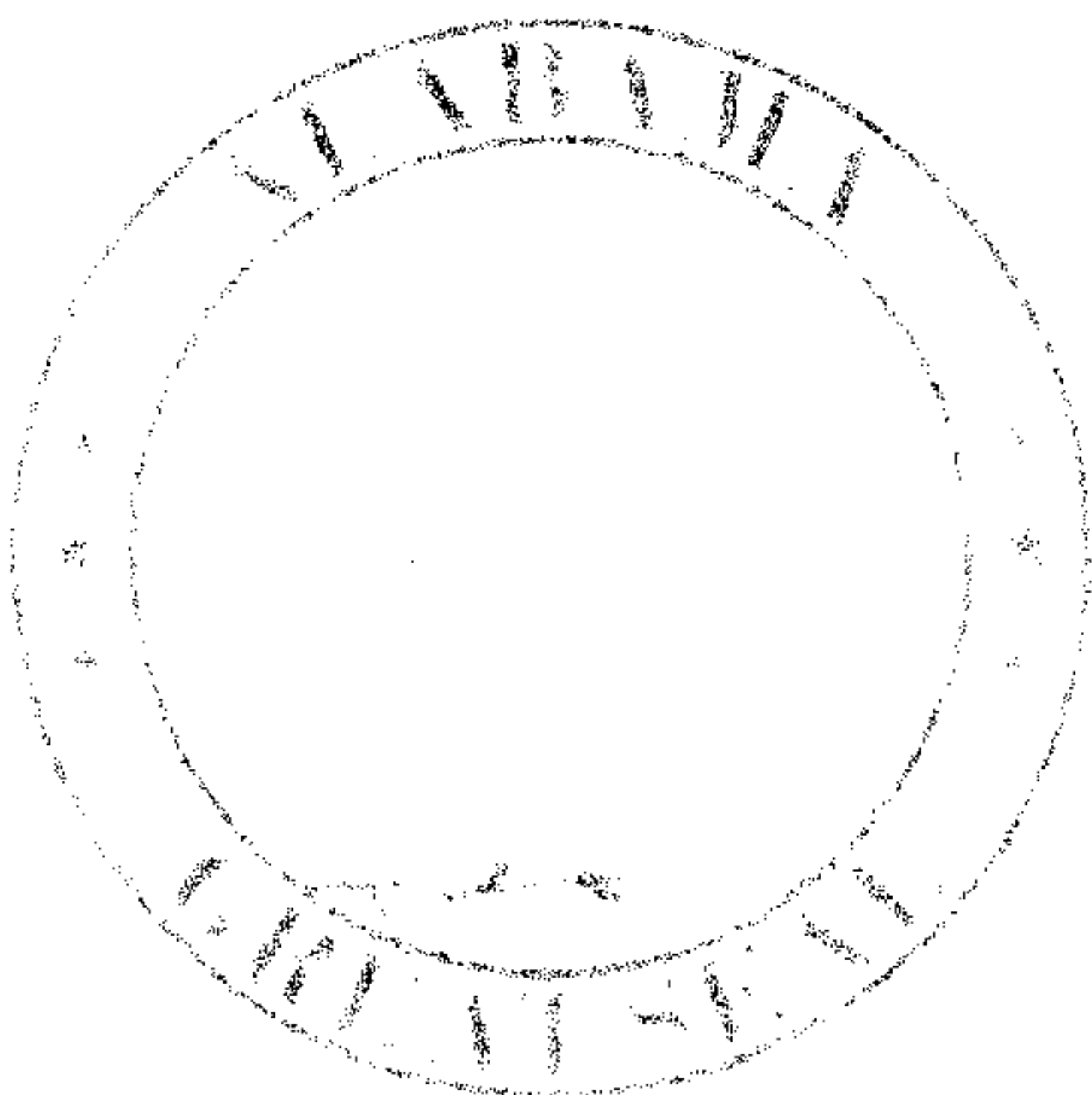
