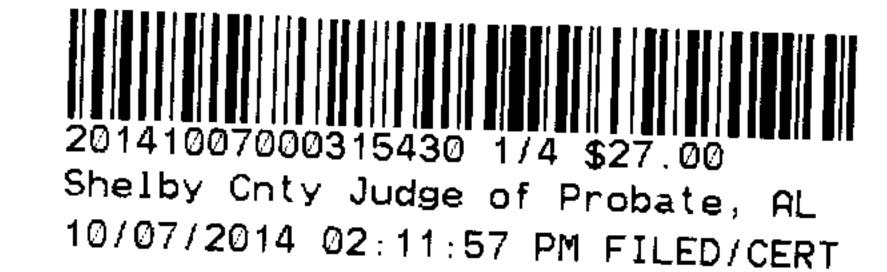

## FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 28th day of September, 2007, Alex A. Solito and Carina M. Solito, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for The Mortgage Outlet, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument Number 20071005000467760, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC "Transferee"), by instrument executed on November 14, 2012 and recorded on January 8, 2013 in Instrument 20130108000010560, in the aforesaid Probate Office; and
