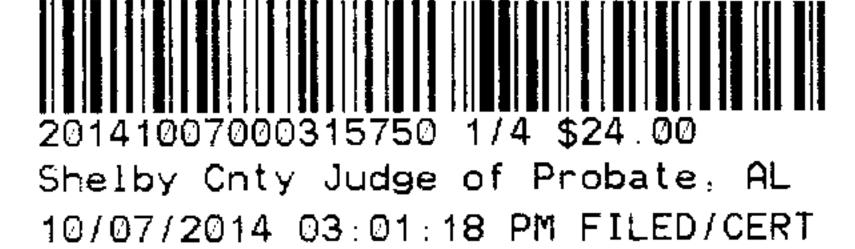

Twenty Two Thousand Eight Hundred and no/100------(\$22,800.00) dollar(s), cash in hand paid to the undersigned by Shelby County, the receipt of which is hereby acknowledged, I (we), the undersigned grantor(s), Fox Lake Farm Limited Partnership, an Alabama Limited/ have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto Shelby County the following described property, lying and being in Shelby County, Alabama and more particularly described as follows:

And as shown on the right of way map of Project No. STPBH-9802(905) of record in the Alabama Department of Transportation, a copy of which is also deposited in the office of the Judge of Probate of Shelby County, Alabama as an aid to persons and entities interested therein and as shown on the Property Plat attached hereto and made a part hereof:

Commencing at the NW corner of the NE ¼ of the SW ¼ of Section 11, Township 19 South, Range 2 West, run thence S 87°57'12" E a distance of 370.22 feet, more or less, to the Point of Beginning; run thence S 87°50'02" E a distance of 7.98 feet, to a point on a curve to the left having a radius of 1200.00 feet, a central angle of 4°37'19", a curve distance of 96.80 feet, and a chord bearing S 30°08'09" W at a distance of 96.78 feet, run thence S 14°54'17" W a distance of 238.48 feet, more or less, to a point on a curve to the left having a radius of 1170.00 feet, a central angle of 6°28'47", a curve distance of 132.32 feet, and a chord bearing S 13°07'33" W at a distance of 132.25 feet, run thence S 9°53'09" W a distance of 137.02 feet, more or less, to a point on a curve to the right having a radius of 1088.67 feet, a central angle of 28°35'48", a curve distance of 543.36 feet, and a chord bearing N 13°27'59" E at a distance of 537.74 feet, run thence N 27°45'53" E a distance of 14.09 feet, more or less, to a point on a curve to the right having a radius of 1143.49 feet, a central angle of 2°27'11", a curve distance of 48.96 feet, and a chord bearing N 28°59'29" E at a distance of 48.95 feet, to the Point of Beginning; Containing 0.208 acres, more or less.

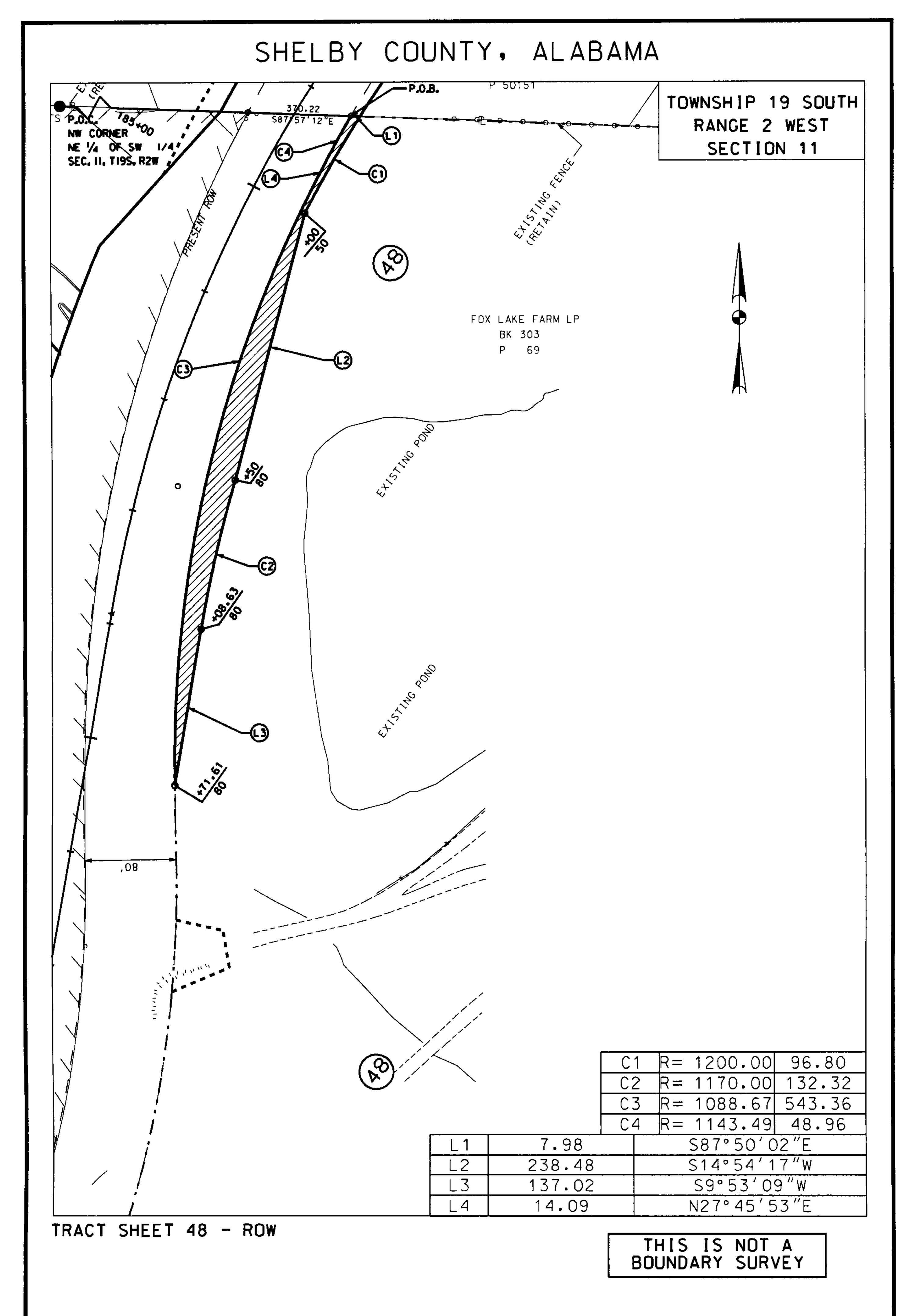
