WHEREAS, heretofore, on, to-wit: the 21st day of December, 2011, Larry G. 

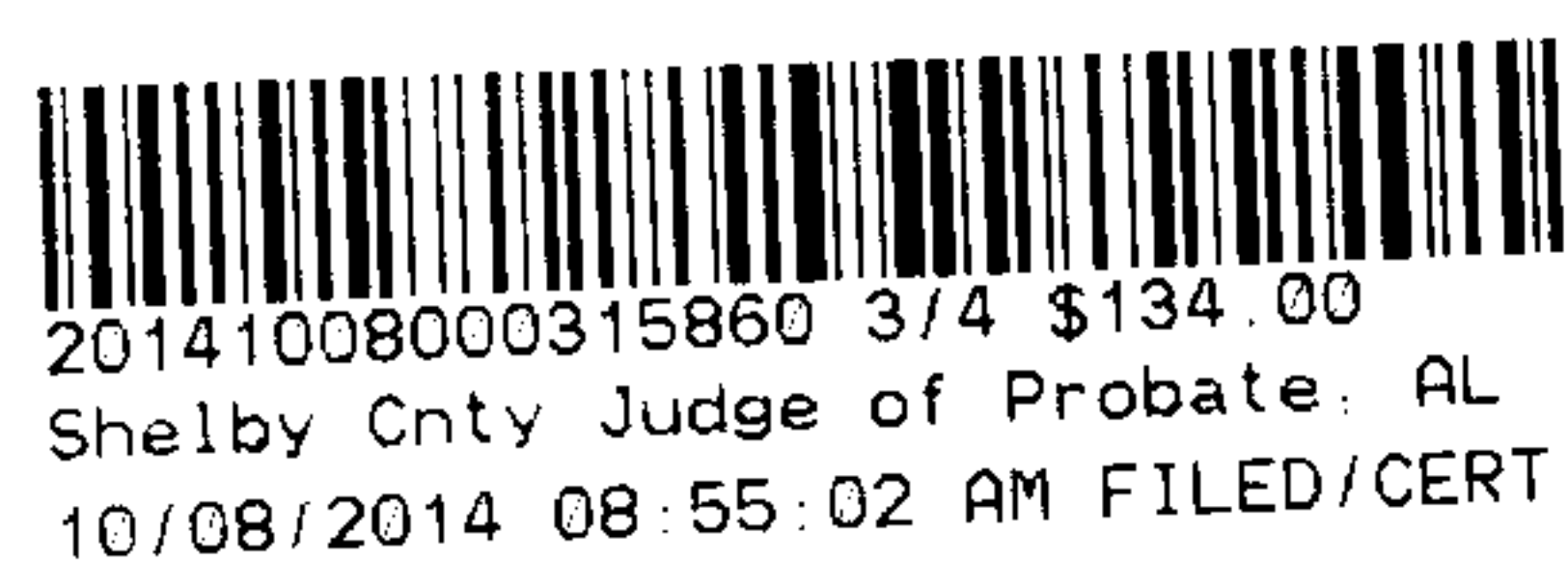
