1. Affiant has personal knowledge of the facts stated herein, particularly as relating to the family history of William S. Goad and Elizabeth Ingram Goad. Affiant is over the age of seventy (70) years, and is competent to execute this Affidavit. Affiant resides at 5160 Highway 16, Montevallo, Alabama 35115.

2. Affiant has no pecuniary or other interest in the following described property situated in Shelby County, Alabama, more particularly described, as follows:


5. William S. Goad predeceased his wife, he having died on or about June 3, 1993.



Begin at the SE corner of the SW 1/4 of SW 1/4 of Section 12, Township 22 , Range 3 West, and go thence South 89 degrees 40 minutes West along Section line, 990 feet; thence North 3 degrees 15 minutes West 1320 feet to the North line of said forty; thence North 89 degrees 40 minutes East 990 feet to the NE corner of the said forty; thence South 3 degrees 15 minutes East, 351.2 feet; thence South 41 degrees East 339.8 feet; thence South 31 degrees 30 minutes East 544.3 feet; thence South 16 degrees 50 minutes West 95.7 feet; thence South 15 degrees 20 minutes East 161.9 feet to the Section line between Section 12 and Section 13; thence along said Section line North 89 degrees 40 minutes East 174 feet; thence South 00 degrees 55 minutes East 210 feet; thence South 89 degrees 40 minutes West 630 feet; thence North 00 degrees 55 minutes West 210.01 feet to the Section line between Section 12 and Section 13; thence South 89 degrees 40 minutes West along said Section line for a distance of 10 feet to the point of beginning. Being situated in Section 12 and 13, Township 22, Range 3 West, Shelby County, Alabama.
