KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of June, 2001, Scott Donze, husband and Tina B. 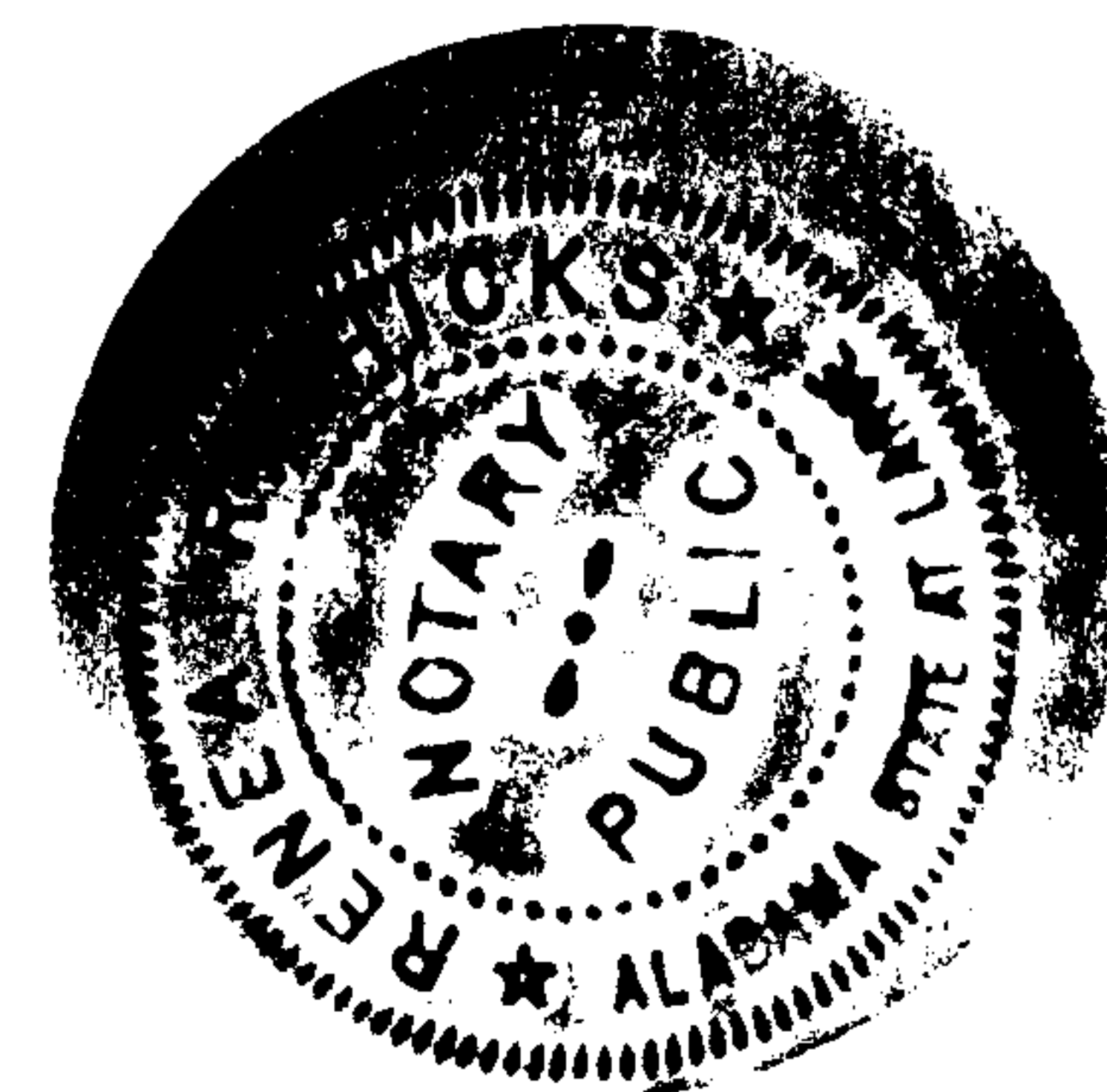
