**ORDER**

This matter came before this Court on October 14, 2014 on the Joint Motion to Approve Compromise/Settlement Agreement (Proceeding No. 215 in the main case and Proceeding No. 58 in the above adversary proceeding). Appearances were noted in the record.

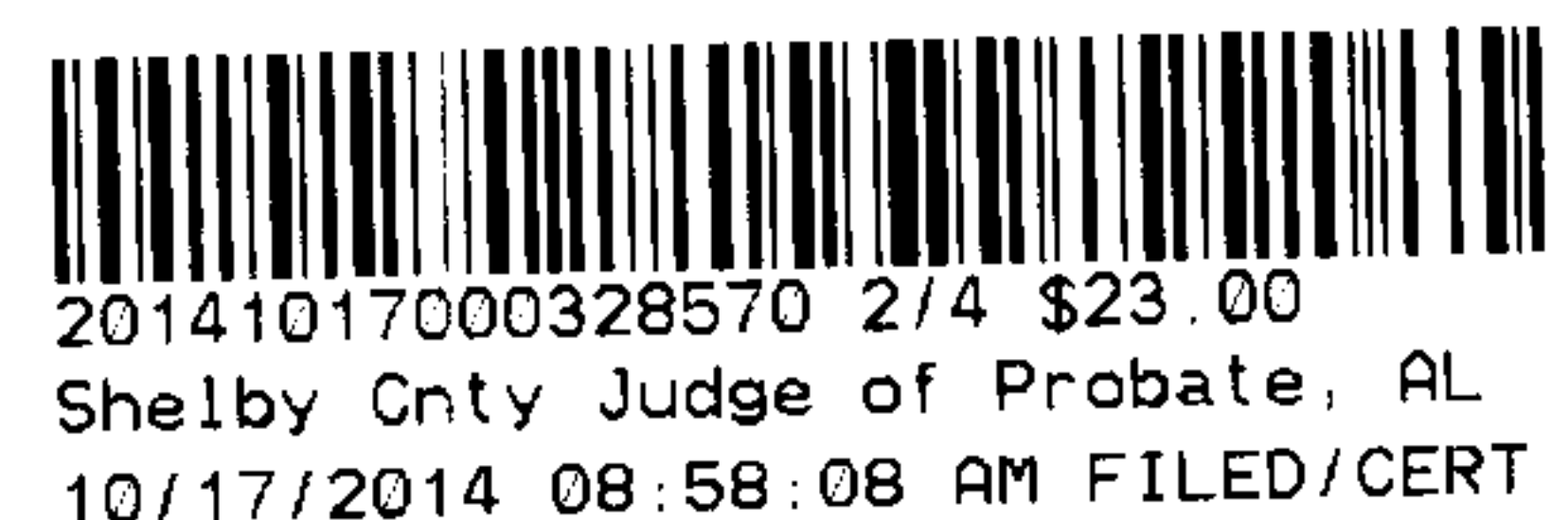
The Court having been advised at the hearing that the conditions of the Settlement Agreement have been met with the exception of paragraph 3 which requires James Carroll to turnover the bank account at Alabama One ending in #1894.

Attorneys representing the Trustee and the Carrolls have advised that Alabama One has refused to turnover the account and has claimed an offset as regards that account.

Accordingly, it is impossible for James Carroll to fulfill this term of the Settlement Agreement and by agreement of both parties, James Carroll is relieved of this part of the Settlement Agreement subject to the further conditions as set out in this order.

Based upon the file, representations of counsel, it is ORDERED, ADJUDGED and DECREED as follows:

1. The motion and the Settlement Agreement are approved with the following modifications:




- a. That any and all rights of James or Betty Carroll have as regards account #1894 at Alabama One Credit Union are assigned to Robert L. Shields, III, Trustee of this estate.
- b. Further, pursuant to the motion and the Settlement Agreement, a judgment in the amount of \$500,000.00 is awarded in favor of the Trustee/Plaintiff, Robert L. Shields, III, and against Betty L. Carroll and James N. Carroll, jointly and severally.

This resolves all matters in the above adversary proceeding. The clerk is directed to close this adversary proceeding. Each party shall bear its own costs.
